उम्मीदवारों के आपराधिक, वित्तीय, शैक्षिक पृष्ठभूमि और अन्य जानकारी का विश्लेषण (लोकसभा चुनाव 2014, उत्तरप्रदेश, छठा चरण)

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और उत्तर प्रदेश इलेक्शन वॉच ने लोकसभा चुनाव 2014, उत्तरप्रदेश के छठे चरण में चुनाव लड़ रहे 328 में से 325 उम्मीदवारों के शपथ पत्रों का विश्लेषण किया। उत्तरप्रदेश के छठे चरण की मतदान तिथि 12 मई है।

नीचे की तालिका में दिये गये उम्मीदवारों के नाम इनके शपथपत्र अधूरे और खराब होने के कारण इस विश्लेषण का भाग नहीं हैं।

आपराधिक पृष्ठभूमि

☞ आपराधिक मामलों वाले उम्मीदवार: 325 में से 63 (19 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामलों घोषित किये हैं।

☞ गंभीर आपराधिक मामलों वाले उम्मीदवार: 54 (17 प्रतिशत) उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामलों घोषित किये हैं। जिनमें हत्या, हत्या का प्रयास, अपहरण इत्यादि शामिल है।

☞ उम्मीदवारों द्वारा घोषित आपराधिक मामले-दलवार: कांग्रेस के 18 में से 8 (44 प्रतिशत), सपा के 17 में से 7 (41 प्रतिशत), बसपा के 18 में से 7 (39 प्रतिशत), भाजपा के 17 में से 4 (24 प्रतिशत) और आम आदमी पार्टी के 18 में से 4 (22 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामलों घोषित किये हैं।

8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध

- ☞ हत्या से सम्बन्धित मामले घोषित करने वाले उम्मीदवार: आईपीसी 302 के तहत (हत्या) का मामला घोषित करने वाले 4 उम्मीदवार हैं— मुख्तार अंसारी (घौसी लोकसभा सीट/कौमी एकता दल), धनंजय सिंह (जौनपुर लोकसभा सीट/निर्दलीय), रवि शंकर सिंह पप्पू (सलेमपुर लोकसभा सीट/बसपा) और अफ़ज़ाल अंसारी (बलिया लोकसभा सीट/कौमी एकता दल)।
- ☞ हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले उम्मीदवार: 13 उम्मीदवारों ने अपने ऊपर आईपीसी 307 के तहत (हत्या का प्रयास) से सम्बन्धित मामला घोषित किया है।
- ☞ अपहरण से सम्बन्धित मामले घोषित करने वाले उम्मीदवार: मनोज कुमार (डोमियारगंज लोकसभा सीट/सुहेलदेव भारतीय समाज पार्टी) ने अपने ऊपर 1 मामला आईपीसी धारा 363 के तहत “अपहरण” और 1 मामला आईपीसी धारा 366 के तहत “विवाह आदि के करने को विवश करने के लिए किसी स्त्री को व्यपहत करना, अपहत करना या उत्प्रेरित करना” से सम्बन्धित घोषित किया है।
- ☞ बलात्कार एवं महिलाओं के ऊपर अत्याचार से सम्बन्धित मामलें घोषित करने वाले उम्मीदवार: 2 उम्मीदवार , धनंजय सिंह (जौनपुर लोकसभा सीट/निर्दलीय) और मनोज कुमार (डोमियारगंज लोकसभा सीट/सुहेलदेव भारतीय समाज पार्टी) ने अपने ऊपर 1 मामला आईपीसी धारा 376 के तहत “बलात्कार” से सम्बन्धित और गौरख प्रसाद (बांसगांव लोकसभा सीट/सपा) ने अपने ऊपर 1 मामला आईपीसी धारा 498‘क’ के तहत “पति या पति के नातेदारों द्वारा क्रूरता” से सम्बन्धित घोषित किया है।
- ☞ सांप्रदायिक सदभाव में बाधा पहुंचाने से सम्बन्धित मामले घोषित करने वाले उम्मीदवार: 2 उम्मीदवारों ने अपने ऊपर सांप्रदायिक सदभाव में बाधा पहुंचाने से सम्बन्धित मामले घोषित किये हैं। आदित्यनाथ (गोरखपुर लोकसभा सीट/भाजपा) और एम. आमिर रशिद (आज़मगढ़ लोकसभा सीट/राष्ट्रीय उलेमा कांउंसिल) का विवरण नीचे दिया गया है।
- ☞ *दागी निर्वाचन क्षेत्र: 18 में से 13 निर्वाचन क्षेत्र ऐसे हैं जहाँ राजनीतिक दलों के कम से कम 3 उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।

वित्तीय पृष्ठभूमि

- करोड़पति उम्मीदवार: लोकसभा चुनाव 2014, उत्तरप्रदेश छठे चरण में 325 में से 93 (29 प्रतिशत) उम्मीदवार करोड़पति हैं।
- करोड़पति उम्मीदवार-दलवार: प्रमुख दलों में कांग्रेस के 18 में से 12 (67 प्रतिशत), भाजपा के 17 में से 13 (77 प्रतिशत), बसपा के 18 में से 17 (94 प्रतिशत), सपा के 17 में से 14 (82 प्रतिशत) और आम आदमी पार्टी के 18 में से 7 (39 प्रतिशत) उम्मीदवार करोड़पति हैं। (घोषित संपत्ति ₹ 1 करोड़ से ज़्यादा)।
- औसतन संपत्ति: लोकसभा चुनाव 2014, उत्तर प्रदेश छठे चरण में उम्मीदवारों की औसतन संपत्ति ₹ 2.12 करोड़ है।
- औसतन संपत्ति-दलवार: मुख्य दलों में कांग्रेस के 18 उम्मीदवारों की औसतन संपत्ति ₹ 3.93 करोड़ है, भाजपा के 17 उम्मीदवारों की औसतन संपत्ति ₹ 4.22 करोड़, बसपा के 18 उम्मीदवारों की औसतन संपत्ति ₹ 15.60 करोड़, सपा के 17 उम्मीदवारों की औसतन संपत्ति ₹ 4.08 करोड़ और आम आदमी पार्टी के 18 उम्मीदवारों की औसतन संपत्ति ₹ 1.28 करोड़ है।

- ☞ उम्मीदवारों की आयु: 325 में से 208 (64 प्रतिशत) उम्मीदवारों ने अपनी आयु 25 से 50 वर्ष के बीच घोषित की है। 325 में से 113 (35 प्रतिशत) उम्मीदवारों ने अपनी आयु 51 से 80 वर्ष के बीच घोषित की है।

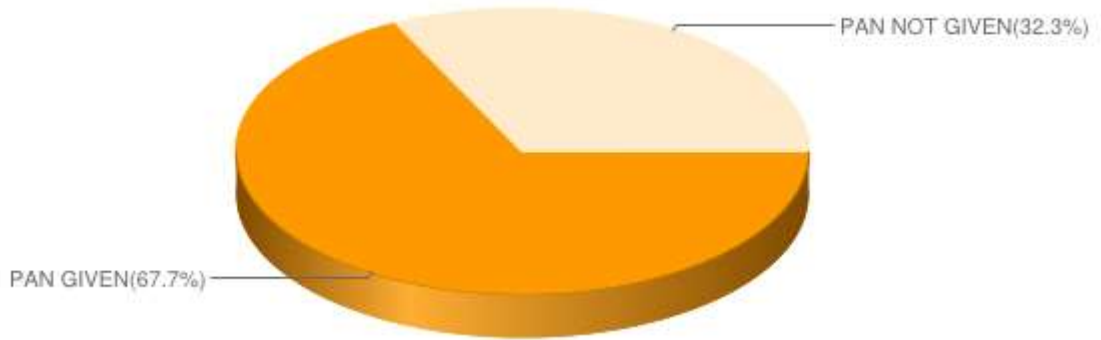

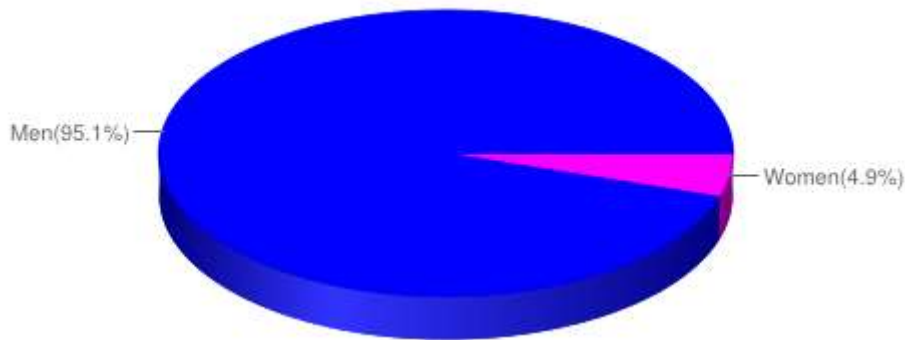
