Criminal Background

- **Winners with Criminal Cases:** Out of the 851 Winners, **104 winners (12%)** have declared criminal cases against them.
- **Winners with Serious Criminal Cases:** Out of the 104 winners who have declared criminal cases, **85 have declared serious criminal cases.** These include **murder, attempt to murder, dacoity, rape etc.**
- **Party wise Winners with Criminal Cases:** **71(11%) out of 654** winners fielded by **BJD** have declared criminal cases against them while **18 (15%) out of 122** winners from **INC** and **8 (22%) out of 36** winners from **BJP** have declared criminal cases in their affidavits.
- **Party wise Winners with serious Criminal Cases:** **57(9%) out of 654** winners fielded by **BJD** have declared serious criminal cases against them while **14 (11%) out of 122** winners from **INC** and **8 (22%) out of 36** Winners from **BJP** have declared serious criminal cases in their affidavits.
- **Murder Related Cases:** **5** Winners have declared cases of murder in their affidavits.
- **Winners with attempt to murder cases:** **11** Winners have declared cases of attempt to murder.
- **Winner with cases of rape:** **Umash Chandra Pradhan** of **INC** from **Chhendipada** constituency had declared a case of rape in his affidavit.
- **Winners with cases of crimes against women:** **10 winners** have declared cases of crimes against women.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepatis Winners:** Out of the **851** winners, **21 (2%)** winners are crorepatis.
- **Average Assets:** The average assets per winner in the 2012 Odisha ZP Elections was **Rs.15.45 lakhs.**
- **Party-wise Average Assets:** The average assets for 654 BJD winners is **Rs.15.98 lakhs**, for 122 INC winners the average is **Rs.11.86 lakhs** and for 36 BJP winners it is **Rs.26.62 lakhs.**
