## Summary and Highlights

Maharashtra Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **329 candidates out of 371** candidates who are contesting in the Vasai Virar City Municipal Corporation Elections of 2015. The rest of the affidavits were not analysed due to incomplete or unclear affidavits uploaded at time of making this report.

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 329 candidates analysed, **54 (16%) candidates** have declared criminal cases against themselves.

- **Candidates with Serious Criminal Cases:** **38 (12%)** candidates have declared serious criminal cases including cases related to **attempt to murder, communal disharmony** etc.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Candidates with Criminal Cases:** **14 (14%)** out of 100 candidates analysed from **Bahujan Vikas Aghadi**, **9 (26%)** out of 34 candidates analysed from **INC**, **11 (16%)** out of 70 candidates analysed from **Shiv Sena** and **5 (18%)** out of **28** candidates analysed from **BJP** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **10 (10%)** out of 100 candidates analysed from **Bahujan Vikas Aghadi**, **5 (15%)** out of 34 candidates analysed from **INC**, **9 (13%)** out of 70 candidates analysed from **Shiv Sena** and **2 (7%)** out of **28** candidates analysed from **BJP** have declared serious criminal cases against themselves in their affidavits.

## Financial Background

- **Crorepati Candidates:** Out of the 329 candidates analysed, **99 (30%)** are crorepatis.
- **High Asset Candidates:** Out of 329 candidates analysed, **9** candidates declared assets worth more than Rs. 10 crores. **2 candidates have declared assets worth more than Rs 100 crores.** The details of the top five candidates with high assets are;

- **Party-wise Crorepati Candidates:** **54 (54%)** out of **100** candidates analysed from **Bahujan Vikas Aghadi**, **14 (20%)** out of **70** candidates analysed from **Shiv Sena**, **7 (21%)** out of **34** candidates analysed from **INC** and **9 (32%)** out of **28** candidates analysed from **BJP** are crorepatis.

- **Average Assets:** The average assets per candidate analysed for the Vasai Virar City Municipal Corporation 2015 elections is **Rs.2.30 crores.**
- **Party-wise Average Assets:** Among major parties, the average assets per candidate for **100** analysed **Bahujan Vikas Aghadi** candidates is **Rs 5.45 crores**, **34** analysed **INC** candidates have average assets of

**Rs.1.06 crores, 70 analysed Shiv Sena candidates have average assets of Rs. 0.88 crores and 28 analysed BJP candidates have average assets of Rs. 1.87 crores.**

- **Candidate with Zero Assets:** Only 1 candidate has declared to have zero total assets. He is **Anselm Alex Crasto**, an independent candidate contesting from Ward no. 35.
- **Low Asset Candidates:** A total of 5 candidates have declared assets less than Rs. 10,000 (excluding the 1 candidate who has declared zero assets). The three candidates with lowest assets are as follows:

- **Candidates who have not declared Income Tax Details\*:** 252 (77%) candidates out of 329 analyzed have not declared income tax details. \*Some candidates may be exempted from filing Income Tax Returns
- **Party wise candidates who have not declared their Income Tax Details:** 42 (42%) out of 101 analysed candidates from Bahujan Vikas Aghadi, 49 (58%) out of 85 analysed candidates from INC, 26 (43%) out of 61 analysed candidates from Shiv Sena and 14 (33%) out of 42 analysed candidates from BJP have not declared their income tax details.

- **Candidates with High Assets who have not declared Income Tax Details:** 59 candidates with assets worth more than Rs. 1 crore, have not declared Income Tax Details.

- **Education Details of Candidates:** 7 candidates have declared that they are illiterate. 234 (71%) candidates (not including candidates who are illiterate) have declared that have an education qualification of 12<sup>th</sup> pass or below while 77 (23%) candidates have declared having an educational qualification of graduate or above.
