Analysis of Election Expenditure Statements of MLAs West Bengal Assembly Elections, 2016

According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. West Bengal Election Watch and Association for Democratic Reforms (ADR) have analyzed all the election expenditure statements submitted after the West Bengal 2016 Assembly for 294 MLAs. The expenditure limit for the candidates during the West Bengal Assembly elections was Rs. 28 lakhs. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

Recommendations:

1. Each candidate is required to file his election expenditure statement within 30 days of the results of the elections, the deadline in case of the West Bengal Assembly Elections being the 18th of June, 2016. However, it was observed that the election expenditure statements of the candidates were not uploaded on the CEO website till significantly after the deadline. **It is therefore recommended that the Abstract Expenditure Statement (Annexure 15) of the candidates is uploaded on the website of the CEO within 72 hours of the receipt of the statement.**
2. The deadline for filing an election petition against any candidate is 45 days after the declaration of the results. Generally, candidates submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any candidate. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the candidates and gather the relevant documents/proof etc for the election petition.
3. As has been instated in the filing of affidavits during the elections, the candidates should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

Summary and Highlights of Election Expenses of MLAs from the West Bengal Assembly 2016 Elections

- Less than 50% of the Limit:** Candidates have constantly claimed that the election expenditure limit set is very low. However, based on the election expense declarations of all 294 MLAs analysed from the 2016 West Bengal Assembly elections to the CEO, **162 MLAs (55%) have declared election expenses of less than 50% of the expense limit** in their constituency.
- Average Election Expenses:** Based on the election expense declarations of 294 MLAs from West Bengal Assembly to the CEO, the **average amount of money spent** by them in the elections is only about **Rs 13.39 lakhs, which is 48% of the expense limit**.
- Party-wise Average Election Expenses:** The party wise average election expenses shows that the average spending for **211 MLAs from AITC** is **Rs 13.57 lakhs** (49% of the expense limit), for **44 MLAs from INC** is **Rs 17.57 lakhs** (63% of the expense limit), for **26 MLAs from CPI(M)** is **Rs 7.19 Lakhs** (26% of the expense limit), and for **3 MLAs from BJP** is **Rs 17.10 Lakhs** (61% of the expense limit).




Figure 1: Party-wise Average Election Expenses (Rs. in lakhs)

4. **Top 3 MLAs with highest Election Expenses:** The maximum expense of about Rs 25.52 lakhs (91% of the expense limit) has been declared by **Apurba Sarkar** of INC from Kandi constituency followed by **Rajib Banerjee** of AITC from Domjur constituency with an expense of Rs 25.33 lakhs (or 90% of the expense limit) and **Firdousi Begum** of AITC from Sonarpur Uttar constituency with an expense of Rs 24.91 lakhs (or 89% of the expense limit).
5. **MLAs with lowest Election Expenses:** **Jahanara Khan** of CPI(M) from Jamuria constituency has declared election expenditure of **Rs. 3.25 lakhs** followed by **Rafikul Islam** of CPI(M) from Harirampur Constituency with election expenses of **Rs. 4.08 lakhs** and **Dhirendra Nath Layek** of Revolutionary Socialist Party from Chhatna Constituency with election expenses of **Rs. 4.29 lakhs**.
6. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the 294 MLAs analyzed, **77 (26%)** MLAs have declared that **they have not spent ANY amount** on public meetings, processions etc with Star Campaigners.
7. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** Out of the all 294 MLAs analyzed, **2 (0.68%)** MLAs have declared that **they have not spent ANY amount** on public meetings, processions etc other than the ones with star campaigners.
8. **Expense on Campaigning through electronic/print media:** **208 (71%)** MLAs have declared that they have **not spent ANY amount** on campaigning through electronic/print media.




Figure 2: Break-down of Election Expenses Incurred by MLAs

9. **Expense on Campaign Workers:** 87 (30%) MLAs have declared that they have not spent ANY amount on campaign workers.
10. **Expense on Vehicles used:** 13 (4%) MLAs have declared that they have not spent ANY amount on Vehicles Used.
11. **Expense on Campaign Materials.:** 57 (19%) MLAs have declared that they have not spent ANY amount on Campaign Materials.




Figure 3: Party-wise Average Expenses on Public Meetings, Processions etc with Star Campaigners (Rs. in lakhs)




Figure 4: Party-wise Average Expenses on Public Meetings, Processions etc without Star Campaigners (Rs. in lakhs)




Figure 5: Party-wise Average Expenses on Campaign Materials (Rs. in lakhs)




Figure 6: Party-wise Average Expenses on Electronic Media (Rs. in lakhs)




Figure 7: Party-wise Average Expenses on Campaign Vehicles (Rs. in lakhs)




Figure 8: Party-wise Average Expenses on Campaign Workers (Rs. in lakhs)

Summary and Highlights of Funds Raised by MLAs in the West Bengal Assembly 2016 Elections

1. Percentage break-down of funds received by MLAs:

Out of the total funds received by MLAs, 51% funds were raised from political parties, 15% were raised by MLAs themselves and 34% funds were raised from other sources.

2. MLAs Who Raised Funds from Political Parties:

Out of the 294 MLAs analyzed, 12(4%) MLAs have declared that they have not received any funds from political parties.

3. MLAs Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:

Out of the 294 MLAs analyzed, 60(20%) MLAs have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.

4. Self funds used for election campaign:

Out of the 294 MLAs analyzed, 46 (16%) MLAs have declared that they have not used any of their own funds for their election campaign.

5. Average funds raised from Political Parties (Party-wise):

On an average an MLA from INC raised 90 % of his/her election expense funds from the political party. Similarly, an MLA from CPI(M) raised 89% of his/her election expense funds, an AITC MLA raised 36 % , an BJP MLA raised 99 % , an Revolutionary Socialist Party MLA raised 77 % and a AIFB MLA raised 83 % of their election expense funds from the political party.




Figure 9: Percentage Break-down of Funds Raised by MLAs

- 6. Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc (Party-wise):** On an average an MLA from AITC raised 45% of his/her election expense funds from any person/company/firm/associations/body of persons etc as loan, gift or donation. Similarly, an MLA from INC raised 5% of his/her election expense funds, an MLA from Revolutionary Socialist Party raised 19% of his/her election expense funds, an MLA from Gorkha Janmukti Morcha raised 52% of his/her election expense funds, an MLA from CPI(M) raised 11% of his/her election expense funds and an AIFB MLA raised on an average 12% of their expense funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation.

Summary and Highlights of Election Expenses of Ministers from the West Bengal Assembly Elections, 2016

1. **Less than 50% of the Limit:** Based on the election expense declarations of all 42 Ministers analysed from West Bengal Assembly, 2016 to the ECI, 22 Ministers (52%) have declared election expenses of less than 50% of the expense limit in their constituency.
2. **Average Election Expenses:** Based on the election expense declarations of all 42 Ministers from West Bengal Assembly 2016 to the ECI, the average amount of money spent by them in the elections is only about Rs 14.39 lakhs, which is 51% of the expense limit.
3. **Top 3 Ministers with highest Election Expenses:** The maximum expense of about Rs 25.33 Lakhs (90% of the expense limit) has been declared by Rajib Banerjee of AITC from Domjur constituency followed by Rabindra Nath Ghosh of AITC from Natabari constituency with an expense of Rs 22.69 lakhs (or 81% of the expense limit) and Partha Chatterjee of AITC from Behala Paschim constituency with an expense of Rs 22.05 Lakhs (or 79% of the expense limit)
4. **Ministers with lowest Election Expenses:** James Kujur of AITC from Kumargram (ST) Constituency has declared an election expenditure of Rs. 6.78 lakhs (24% of the expense limit). He is followed by Bachchu Hansda of AITC from Tapan (ST) constituency who has declared election expenditure of Rs. 8.61 lakhs (31% of the expense limit), and Firhad Hakim of AITC from Kolkata Port Constituency with election expenses of Rs. 8.97 lakhs (32% of the expense limit).

5. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the all 42 Ministers analyzed, **14 (33%) Ministers** have declared that **they have not spent ANY amount on public meetings, processions etc with Star Campaigners.**
6. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** **1 Minister** namely MD Gulam Rabbani of AITC from Goalpokhar constituency has declared that **he has not spent ANY amount on public meetings, processions etc other than the ones with star campaigners.**
7. **Expense on Campaigning through electronic/print media:** **28 (67%) Ministers** have declared that they **have not spent ANY amount on campaigning through electronic/print media.**
8. **Expense on Campaign Workers:** **13 (31%) Ministers** have declared that they **have not spent ANY amount on campaign workers.**
9. **Expense on Vehicles used:** All ministers have declared expenses on **Vehicles Used.** Churamani Mahata of AITC from **Gopiballavpur Constituency** declared the lowest amount of **Rs. 3,000 (0.23% of his total expense declared)** on vehicles.
10. **Expense on Campaign Materials:** **8 (19%) Ministers** have declared that they **have not spent ANY amount on Campaign Materials.**




Figure 10: Break-down of Election Expenses Incurred by Ministers

Summary and Highlights of Funds Raised by Ministers in the West Bengal Assembly 2016 Elections

1. Percentage break-down of funds received by Ministers:

Out of the total funds received by Ministers, 32% funds were raised from political parties, 21% were raised by Ministers themselves and 47% funds were raised from other sources.

2. Ministers Who Raised Funds from Political Party:

Out of the all 42 Ministers analyzed, 2 (5%) Ministers have declared that they have not received any funds from political parties.

3. Ministers Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:

Out of the 42 Ministers analyzed, 6 (14%) Ministers have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.

4. Self funds used for election campaign:

Out of the 42 Ministers analyzed, 2 (5%) Ministers have declared that they have not used any of their own funds for their election campaign




Figure 11: Percentage Break-down of Funds Raised by Ministers
