## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of 9 winners belonging to 3 major parties, who have won the **Municipal Corporation Bye Elections** held in **Thane, Aurangabad, Nashik, Parbhani, Amravati and Dhule districts**, on **28<sup>th</sup> August, 2016**.

**Smt. Dahake Praveena Digambar** who contested on **Shiv Sena** ticket from **Ward no 32 B (Navathe Plot)** seat in **Amravati** district, was earlier elected **unopposed** in this election. Due to unavailability of winners' affidavit from **Latur** district, ADR could not analyse same.

### Criminal Background

- **Winners with Criminal Cases:** None of the 9 winners have declared criminal cases against themselves.

### Financial Background

- **Crorepati Winners:** Out of the 9 winners analyzed, only 2 (22%) are crorepatis, of which 1 belongs to Shiv Sena and 1 is independent.
- **Party-wise Crorepati Winners:** 1 (33%) out of 3 winners analysed from **Shiv Sena** are crorepatis.

- **Average Assets:** The average assets per winner analyzed for the **Municipal Corporation Bye Elections August 2016**, is **Rs. 55 Lakhs +**.
- **Party-wise Average Assets:** Among major parties, the average assets per winner for 3 analyzed **Shiv Sena** winners is **Rs 89 Lakhs+**, 2 **NCP** winners have average assets of **Rs. 38 Lakhs+** and 2 **BJP** winners have average assets of **Rs. 24 lakhs+**.

- **Zero Assets:** Only 1 (11%) winner viz., **Smt. Mahmudi B.** of Ward no 16 constituency from Parbhani district, has declared zero asset.
- **Low Assets:** Only 1 (11%) winner (excluding the one having zero asset), viz., **Smt. More Sunanda Laxman** of Ward no 36 B constituency from Nasik district, has declared low assets (below Rs. 1 lakh).
- **Winners with declared Liabilities:** 5 (56%) out of 9 winners have declared their liabilities. The summary of their declared liabilities is given below -

It is also to be noted that 1 (11%) winner viz. Smt. **Parveen Khesar Khan** of **NCP**, from **ward no 21 (Aurangabad district)** has not given her educational qualifications, in her affidavit.
