EXECUTIVE SUMMARY OF MPs OF RAJYA SABHA

Summary of MPs

- National Election Watch (NEW) analyzed affidavits of 230 out of 237 MPs of Rajya Sabha.
- Out of these 230 MPs analyzed, 39 (17%) MPs have declared pending criminal cases against them. INC has 10 out of 69 (14 %), BJP has 9 out of 50 (18 %), BSP has 4 out of 15 (27 %), SS has 4 out of 4 (100 %), CPI has 1 out of 3 (33 %), JD(U) has 2 out of 9 (22 %), NCP has 2 out of 7 (29 %), AITC has 1 out of 9 (11%) MPs with pending criminal cases.
- Out of these 39 MPs with pending criminal cases analyzed by ADR/NEW, 14 MPs have serious criminal cases like attempt to murder, voluntarily causing hurt by dangerous weapons or means, obscene acts and songs etc. pending against them. These include 3 from INC, 5 from BJP and 1 each from CPI (M) and BSP.
- 7 out of 30 (23%) MPs analyzed from Uttar Pradesh have criminal cases pending against them while from Maharashtra, there are 10 out of 19 (53%) MPs, Bihar 4 out of 16 (25%) MPs and Andhra Pradesh has 3 out of 18 (17%) MPs with pending criminal cases.
- There are 19 IPC charges of heinous nature on MPs which include attempt to murder, voluntarily causing hurt by dangerous weapons or means, obscene acts and songs, etc.
- Out of 230 MPs analyzed by NEW, 146 (63%) of are crorepati.
- Among all the parties, INC has the maximum number of crorepati MPs. INC has 50 (72%) out of 69 MPs who are crorepati, followed by BJP with 34 (68%) crorepati MPs out of 50 MPs.
- Out of 230 MPs analyzed, the average asset per MP of Rajya Sabha is Rs 20.12 crore.
- Out of 230 MPs analyzed, the value of average assets of MPs of TDP is Rs. 85.95 crore, for INC it is Rs. 18.14 crore, for BJP it is Rs. 8.05 crore and for BSP it is Rs. 13.82 crore.

NOTE:

1) In the current Rajya Sabha, there are seven nominated MPs and they are not required to submit affidavits. Hence, their information on criminal, financial and other details is not available in public domain. The table below lists these nominated MPs in the current Rajya Sabha.

Analysis based on pending criminal cases

A total of 230 out of 237 affidavits of MPs were analyzed by the National Election Watch (NEW). Out of these 230 MPs analyzed, 39 (17%) MPs declared criminal cases pending against them. Out of these 39 MPs with pending criminal cases, 14 have serious criminal cases like attempt to murder, voluntarily causing hurt by dangerous weapons or means, obscene acts and songs etc. pending against them.

Party-wise break-up of MPs with pending criminal cases

- A total of 39 MPs in Rajya Sabha have pending criminal cases against them. INC has 10 out of 69 (14%), BJP has 9 out of 50 (18%), BSP has 4 out of 15 (27%), SS has 4 out of 4 (100%), JD(U) has 2 out of 9 (22%), CPI has 1 out of 3 (33%), NCP has 2 out of 7 (29%), AITC has 1 out of 9 (11%) MPs with pending criminal cases. Crorepati MPs of Rajya Sabha- Party wise break-up

Among all the parties, INC has the maximum number of crorepati MPs. Out of 69 MPs analyzed, 50 (72%) MPs of INC are crorepati, followed by BJP with 34 (68%) crorepati MPs out of 50 MPs analyzed. Surprisingly, out of 230 MPs analyzed, 63% of them are crorepati.


