Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **73** out of **78** winners who had contested in the **20 wards** for the **Ulhasnagar Municipal Corporation Elections**, held on **21st February, 2017**. The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.



Criminal background

- **Winners with criminal cases:** Out of the **73** winners analysed, **17(23%)** winners have declared criminal cases against themselves.
- **Winners with serious criminal cases:** **11(15%)** winners have declared **serious criminal cases**.
- **Winners with cases related to attempt to murder:** **2** winners have declared cases related to **attempt to murder (IPC Section- 307)**.
- **Winners with cases related to crime against women:** **3** winners have declared cases related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**.
- **Winners with cases related to kidnapping:** **1** winner namely **Rajender Singh Veer Singh Bhuler** from **Shiv Sena** contesting from **Ward No. 3D** has declared case related to **Kidnapping or abducting with intent secretly and wrongfully to confine person (IPC Section-365)**.
- **Party wise Winners with criminal cases:** **9(38%)** out of 24 winners from **Shiv Sena(SHS)**, **6(21%)** out of 28 winners from **Bhartiya Janta Party(BJP)**, **1(25%)** out of 4 winners from **Nationalist Congress Party (NCP)**, **1 (9%)** out of 11 winners from **Secular Alliance of India** have declared criminal cases against themselves in their affidavits.
- **Party wise Winners with serious criminal** **6(25%)** out of 24 winners from **Shiv Sena(SHS)** and **5(18%)** out of 28 winners from **Bhartiya Janta Party(BJP)** have declared serious criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
