Analysis of New MLAs of Bihar 2010 Assembly Elections

(83 pages)

- A total of 241 affidavits of MLAs (out of 243) of Bihar Assembly Elections 2010 are analyzed by National Election Watch (NEW)
- 141 newly elected MLAs (i.e. 59%) in Bihar Assembly Elections 2010 have pending criminal cases against them according to their self sworn affidavits. In 2005 Bihar Assembly, 117 (i.e.35%) MLAs had pending criminal cases.
- 85 MLAs out of these 141 analyzed have declared pending serious IPC charges like murder and attempt to murder charges against them. In 2005, 68 MLAs had serious pending criminal cases.
- 76 MLAs analyzed (32%) have not declared their PAN card details.
- A total of 47 MLAs (i.e. 20%) analyzed are crorepatris in Bihar Assembly Elections 2010. In 2005, 8 MLAs were crorepatris.

Patna, November 25th, 2010: Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, have been working on electoral reforms, improving democracy and governance in India. NEW has analyzed affidavits of 241 MLAs. Affidavits of 2 MLAs were either not available or were illegible.

MLAs with Pending Criminal Cases

A total of 141 MLAs out of 241 analyzed by NEW had declared pending criminal cases in their affidavits. Out of these 141, 85 MLAs have declared that they have serious criminal cases pending of them. They include such heinous criminal cases as such as murder, attempt to murder, kidnapping or abducting in order to murder, theft, illegal payments in connection with elections etc. against them. The table below gives the party wise break up of MLAs with pending criminal case against them.

Comparison with Bihar Assembly Elections 2005

The Bihar Assembly Elections 2005 had only 117 MLAs or 35% with pending criminal cases. The number of MLAs with pending criminal cases in Bihar Assembly Election 2010 is 141, which is 59% of Assembly Elections. Thus the MLAs with pending criminal cases have increased from 2005 assembly to 2009 assembly.

As can be seen from above table, there is significant increase in the number of MLAs with not only pending criminal cases but also with serious pending criminal cases. It shows an increase in criminalization of MLAs in Bihar Assembly Elections 2010 as compared to Bihar Assembly Elections 2005.

Financial background of MLAs

Of 241 MLAs analyzed, 47 MLAs have declared that their assets are more than a crore, i.e. about 20% of the contesting MLAs analyzed are crorepatis. The highest assets declared are 15.83 crores by Dr. Faiyaj Ahmad of RJD from Bisfi Constituency followed by Suresh Kumar Sharma from BJP with 8.27 crores.

In **Bihar Assembly Elections 2005** there were 8 crorepati MLAs while in Bihar Assembly elections 2010 tis has increased to 47 crorepati MLAs candidates, i.e. 20%
