

## Analysis of IT returns filed by political parties for Financial Year (FY) 2007-08 and Financial Year (FY) 2008-09

### Executive Summary

- Association for Democratic Reforms (ADR) obtained copies of the Income Tax Returns and Assessment Orders of various political parties through the filing of RTI applications.
- This analysis has been done for Financial Year 2007-08 and Financial Year 2008-09 for 8 major political parties.
- Among the parties analyzed for FY2007-08 & FY 2008-09, INC has declared the maximum aggregate income (718 crores) followed by BJP (344 crores) and BSP (252 crores).
- The lowest aggregate income has been declared by CPI of 2 crores followed by RJD (6 crores), NCP (57 crores), SP (71 crores) and CPM of 123 crores.
- As on 31<sup>st</sup> March 2009, INC has shown the maximum total assets (612 crores), followed by BSP (286 crores) and BJP (261 crores).
- Among the parties analyzed, Maximum contributions/donations for FYs 2007-08 and 2008-09 have been reported by BJP (₹ 297 crores) followed by BSP (₹ 202 crores) and INC (₹ 72 crores), as part of their income.
- BSP declared that it did not receive a single voluntary contribution in excess of ₹20,000 although the total contributions received by BSP exceed ₹ 202 crores for both the FYs.

Association for Democratic Reforms (ADR) obtained copies of the Income Tax Returns and Assessment Orders of various political parties through the filing of RTI applications. This was made possible as per the Central Information Commission's order number CIC/AT/A/2007/01029 & 1263-1270, according to which public authorities (Income Tax Departments) holding Income Tax returns of political parties are directed to make these returns available to an appellant.

The data was obtained for the following parties: Bhartiya Janta Party (BJP), Bahujan Samaj Party (BSP), Communist Party of India (CPI), Communist Party of India Marxist (CPM), Indian National Congress (INC), Samajwadi Party (SP), Nationalist Congress Party (NCP) and Rashtriya Janta Dal (RJD). This analysis has been done for Financial Year 2007-08 and Financial Year 2008-09.

A Contribution Report, which has contributions received by political parties in amounts greater than ₹ 20,000, is attached by Political Parties along with their Income Tax Returns. Copies of these Contribution Reports are also submitted by Political Parties to the Election Commission of India (ECI) and are available on ECI's website. Despite this, ADR was unable to obtain copies of Contribution Reports for some parties. The following table gives a status of Contribution Reports available to ADR for this analysis.

## 1. Total Income and Sources of Income of Political Parties for Financial Years(FY) 2007-08 and 2008-09

### Summary

- Among the parties analyzed for FY 2007-08 and FY 2008-09, INC has declared the maximum aggregate income (718 crores) followed by BJP (344 crores) and BSP (252 crores).
- BSP has shown the maximum percentage increase in total income (161%) between FY 2007-08 and FY 2008-09 followed by NCP (130%) and INC (125%).
- CPI is the only party which showed a decrease in income in FY 2008-09 as compared to FY 2007-08 i.e. (-6.45%)
- The maximum single source of income for the parties analyzed for FY 2007-08 and FY 2008-09 was Sale of Coupons for INC (598 crores).
- Voluntary Contributions/Donations were a major source of income for most parties for FY 2007-08 and FY 2008-09. The maximum were received by BJP (298 crores) followed by BSP (203 crores) and INC (72 crores).
- Other major sources of income for the parties analyzed for 2007-08 and FY 2008-09 were Membership for BSP (43 crores), Levy for CPM (46 crores) and receipt from Sale of Coupons for NCP (50 crores).

## 2. Total Assets of Political Parties in Financial Year(FY) 2008-09

### Summary

- 1) As on 31<sup>st</sup> March 2009, INC has shown the maximum total assets (approx 612 crores), followed by BSP (286 crores) and BJP (261 crores).
- 2) Amongst the other parties, RJD has shown total assets of 3 crores, CPI (7 crores), NCP (32 crores), SP (178 crores) and CPM (185 crores).

## 3. Total voluntary contributions received by political parties for the financial years 2007-08 and 2008-09

- Political parties, under section 13A of Income Tax Act, get tax exemption on all voluntary contributions above ₹ 20,000.
- Association for Democratic Reforms (ADR) has analyzed the contribution reports, containing amounts greater than ₹ 20,000, attached by political parties along with their Income Tax Returns.

- Among the parties analyzed, Maximum contributions/donations have been reported by BJP (₹ 297 crores) followed by BSP (₹ 202 crores) and INC (₹ 72 crores), as part of their income.
- BSP declared that it did not receive a single voluntary contribution in excess of ₹20,000 although the total contributions received by BSP exceed ₹ 202 crores for both the FYs.
- NCP has reported that 100% of its donations/contributions in both the FYs are in sums greater than ₹ 20,000.
- CPI and INC have reported 56% and 50% respectively of their donations/contributions in sums greater than ₹ 20,000.
- CPM and SP declared that it received only 2% and 1% each of the total contributions/donations in sums greater than ₹20,000 i.e. around ₹ 1 crore out of ₹ 55 crores and ₹ 51 lakhs out of ₹ 46 crores.

#### 4. Top 10 Donors for all the political parties analyzed in Financial Years 2007-08 and 2008-09

- Bharti Electoral Trust has contributed the highest amount i.e. ₹ 18 crores. The highest contribution has been made to INC of 11 crores in both Financial Years 2007-08 and 2008-09
- Torrent Power Ltd on the other hand has made contributions of ₹ 4.5 crores each to INC and BJP and 1 to NCP of ₹ 1 Crore.
- General Electoral Trust has made contributions of approx. ₹ 6 crores to BJP only.
