# Analysis of 2<sup>nd</sup> and 3<sup>rd</sup> list of Candidates declared by Political Parties for Bihar 2010 Assembly Seats (total pages 63)

- 116 candidates with pending criminal cases given tickets so far by political parties for bihar Assembly elections (includes analysis of 2<sup>nd</sup> and 3<sup>rd</sup> lists candidates)
- Includes 48 candidates with charges related to murder. Many have multiple charges.
- JD(U), INC, RJD, LJP every party gives tickets to candidates with criminal background even in their 2<sup>nd</sup> and 3<sup>rd</sup> lists. BJP's 2<sup>nd</sup> list not available yet
- Till now, BJP has 62% candidates, LJP 46 %, JD(U) 36%, RJD 39 % and INC 29% candidates with pending criminal cases
- Mr T S Kirshnamurthy (Former CEC), Mr R K Khatri (former IAS), Prof Trilochan Sastry (Dean, IIM Bangalore), others again urge parties to not give tickets to criminals

**New Delhi/Patna**: Association for Democratic Reforms (ADR) & National Election Watch (NEW) have been monitoring candidates declared by political parties for the forthcoming assembly elections in Bihar. NEW has looked at candidates declared by JD(U), BJP, INC, RJD and LJP and checked the records of these candidates with records that NEW has accumulating since 2003.

When it was found that parties had given tickets to many candidates with criminal background in 1<sup>st</sup> list, several civil society groups including ADR and NEW had demanded that political parties do not give any more tickets to such candidates. Political parties however have continued to turn a blind eye to civil society's demands of giving tickets to honest and capable candidates.

After looking at the recent candidate list declared by political parties (2<sup>nd</sup> and 3<sup>rd</sup> lists), NEW has found that more candidates with criminal background have been given tickets by political parties. The total for such candidates is now 116.

For BJP, out of the list of 87declared candidates, NEW was able to find affidavits for 66 candidates filed in previous elections, out of which it found 41 (62%) candidates have criminal backgrounds. For INC, out of the list of 122 declared candidates NEW was able to find records of 31 candidates and it found that 9 (29%) of them have criminal backgrounds. Similarly, LJP has





13 out of 28(46%), JD(U) has 31 out of 86 (36%) and RJD has 22 out of 57 (39%) candidates with pending criminal cases.

Information of candidates declared by political parties has been collected and their names have been matched in the existing database of names prepared by the NEW, based on affidavits filed by these candidates in earlier elections.

Several of these criminal charges are serious charges, like Murder, Criminal Intimidation, assault, wrongful restraint, etc.

Civil society groups have strongly disapproved this blatant giving of tickets to candidates with criminal background. They have called it a betrayal of people's trust by the political leaders.

In reaction to these findings, Mr T S Krishnamurthy said, "Democracy should represent the will of the people. Criminals and crorepatis cannot and should not represent the will of the people. The sanctity of democracy depends upon the sanity of the elected representatives."

Mr R K Khatri (former IAS) said, "People of Bihar want to move ahead, but political parties are betraying them by relying so heavily on bahubalis. Are there no honest and capable candidates in Bihar? There is still time, they should take the tickets back from these candidates and give them to genuine candidates who want to truly serve the people of Bihar".

Prof Trilochan Satry, Dean of IIM Bangalore and founder member of ADR said, "In the all party meeting with Election Commission yesterday, each party agreed that they will weed out criminal elements from





their parties. However, they continue to give tickets. This is betrayal of trust that people have put in their political leaders"


