National and Regional Recognised Parties are equal defaulters in submitting expenditure statements for Assembly Elections

- ADR requests the Election Commission of India to suspend recognition of those parties who have repeatedly defaulted in submitting election expenditure statements for Assembly Elections
- National and Regional recognised parties, if unrecogised, would not be able to enjoy free airtime and subsidized bungalows among other such facilities

New Delhi: Association for Democratic Reforms (ADR) lauds the Election Commission of India (ECI) for its <u>notice dated 16th June, 2015</u> suspending the recognition of National Peoples' Party (NPP) for failing to submit its election expenditure report for Lok Sabha elections held in 2014, even after multiple reminders were sent by the ECI. This was a much needed step in order to improve not only financial transparency in political parties during elections but also accountability towards the public.

The election expenditure statements of political parties are required to be submitted **75 days** after the completion of **Assembly elections** and **90 days** from the date of completion of **Lok Sabha elections**. It is to be noted that NPP failed to submit its election expenditure statements to the ECI after repeated reminders while not all National and Regional parties submitted their expenditure statements within the specified time limit of 90 days.

Based on the information on the website of the ECI, ADR analysed availability of statements of election expenditure incurred by political parties during <u>Assembly Elections held between 2011 and 2015</u>. For a complete list of recognised parties which contested in the Assembly elections and the status of their submission with the ECI, as on date, kindly refer to the Annexure.

Availability of election expenditure statements of political parties with the Election Commission of India

- Among the National Parties, election expenditure statements of BJP and INC are not available for 5 Assembly elections held between 2011 and 2015 followed by CPI defaulting with its submission for 4 Assembly elections and CPI(M) in 1 Assembly election.
- The availability of election expenditure statements of Regional Parties is equally worrisome where the statements of JD(U) is unavailable for **15** Assembly Elections while that of LJP is unavailable for **11** Assembly Elections and election expenditure statements of RSP and Shiv Sena are unavailable for **10** Assembly Elections held between 2011 and 2015.

Year-wise list of Assembly Elections held and details of defaulting parties

<u>Assembly elections held in 2015</u>: Election to the Delhi Assembly was held in February and a total of 16 National and Regional political parties contested in the elections. Out of the 16 recognised parties, election expenditure statements of 8 parties are unavailable. While INLD had requested for more time for auditing the accounts, BJP and INC are the only two National Parties whose expenditure statements are unavailable.

Assembly elections held in 2014: Apart from the Lok Sabha elections, elections to 8 Assemblies were held in 2014. Assembly elections in Andhra Pradesh, Arunachal Pradesh, Odisha and Sikkim were held along with the General Elections. While Maharashtra and Haryana assembly elections were held in October, Jammu & Kashmir and Jharkhand went for polls in November.

Out of 19 recognised parties which contested in **Andhra Pradesh Assembly elections**, election expenditure statements of **8 recognised parties are unavailable**. NCP is the only National Party whose expenditure statement for Andhra Pradesh Assembly is unavailable.

AAP and NPF are the only two parties out of 6 contesting recognised parties whose election expenditure statements are unavailable for the **Arunachal Pradesh Assembly elections**.

A total of 14 recognised parties contested in **Odisha Assembly elections** of which the election expenditure statements of **4 regional recognised parties are unavailable**. These include **AITC**, **AJSUP**, **RSP and SP**.

AITC is the only defaulting party whose election expenditure statement for **Sikkim Assembly elections** is unavailable. A total of 4 recognised parties contested in the Sikkim Assembly elections.

Out of 15 recognised political parties which contested in the **Maharashtra Assembly Elections** held in October, the election expenditure statements of **5 recognised parties are unavailable**. These include the National Parties, BJP, CPI and INC along with the Regional Parties, JD(S) and RLD.

National parties, **BJP, CPI and INC are the only parties** whose election expenditure statements are unavailable for **Haryana Assembly elections** in which 11 recognised parties contested.

Election expenditure of **9 recognised parties** out of 18 parties which contested in the **Jharkhand assembly elections** are unavailable. These include BJP, INC and the Jharkhand State parties, AJSUP and RJD

INC and BJP are the only 2 National Parties whose expenditure statements are **unavailable for Jammu & Kashmir Assembly elections** apart from **5 regional parties** whose statements of expenditure are not in the public domain. A total of 15 recognised parties contested in the Jammu and Kashmir Assembly Elections held in November.

<u>Assembly elections held in 2013:</u> A total of 9 states went for polls in 2013 which include Karnataka, Meghalaya, Nagaland, Tripura, Chhattisgarh, Madhya Pradesh, Mizoram, Rajasthan and Delhi.

13 recognised parties contested in the **Karnataka Assembly elections** held in May of which **6 recognised parties'** election expenditure reports are **unavailable**. **NCP** is the only **National Party** whose expenditure statements are unavailable.





Assembly elections in Meghalaya, Nagaland and Tripura were held in February. 9 recognised parties contested in the Meghalaya Assembly elections where the election expenditure statements of CPI and UDP are unavailable. Similarly, 6 recognised parties contested in the Nagaland Assembly elections where RJD is the only defaulting party. CPI is the only defaulting party out of 9 recognised parties which contested in the Tripura Assembly elections.

Chhattisgarh, Madhya Pradesh, Mizoram, Rajasthan and Delhi went for polls in November and December. Out of 11 recognised parties which contested in the **Chhattisgarh assembly elections**, **JD (U)**, **NPP and SP** are the only defaulting parties.

Out of 15 recognised parties which contested in the **Madhya Pradesh Assembly Elections**, the election expenditure statements of 7 recognised parties are not available. These include **AIFB**, **IUML**, **JD(S)**, **JD (U)**, **NPP**, **RSP and SP**.

MPC and **ZNP** are the only two recognised parties out of 6 which contested in **Mizoram Assembly elections** whose expenditure statements are not available.

A total of 16 recognised parties contested in the **Rajasthan Assembly Elections** but the election expenditure statements of **7 recognised parties** are unavailable. These include **AIFB, IUML, JD (S), JD (U), JKNPP, NPP and SP.**

Election expenditure statements of **7 recognised parties** out of 17 parties which contested in the **Delhi Assembly Elections** are unavailable. These include **AIFB, DMDK, INLD, IUML, JD (U), JKNPP and SP.**

<u>Assembly elections held in 2012</u>: Assembly elections were held in a total of 7 states in 2012 which were Manipur, Punjab, Uttarakhand, Uttar Pradesh, Goa, Himachal Pradesh and Gujarat.

Elections in Manipur, Punjab and Uttarakhand were held in January. A total of 13 recognised parties contested in the Manipur Assembly Elections of which the election expenditure statements of NPP, AITC, JD (S), JD (U) and LJP are unavailable. Similarly, out of 10 recognised parties which contested in the Punjab Assembly Elections, the expenditure statements of LJP, RJD and Shiv Sena are unavailable.

A total of 9 recognised parties' expenditure statements are not available for Uttarakhand Assembly Elections. A total of 16 recognised parties contested in the elections.

Assembly elections in Uttar Pradesh were held in February in which a total of 19 recognised parties contested. But the election expenditure statements of **11 recognised parties are unavailable.**

Out of the 10 recognised parties which contested in the Goa Assembly elections held in March, AITC, JD (U) and Shiv Sena are the only parties whose election expenditure statements are unavailable.

Himachal Pradesh Assembly elections were held in November in which 10 recognised parties contested but the expenditure statements of **AITC and SP** are unavailable.

<u>Assembly elections held in 2011:</u> A total of 5 assembly elections were held in 2011 which include Assam, Kerala, Tamil Nadu, Puducherry and West Bengal and we held in 5 phases between April and May.

Out of 16 recognised parties which contested in the **Assam Assembly Elections**, the election expenditure statements of 6 recognised parties are unavailable and these include **JD(U)**, **JKNPP**, **JMM**, **RSP**, **Shiv Sena and SP**.

Regional parties of **Kerala** whose expenditure statements are not yet available include **JPSS and KC(AMG)** apart from **JD(U)**, **LJP**, **RSP and Shiv Sena**. A total of 16 recognised parties contested in the Kerala Assembly Elections.

Out of 16 recognised parties which contested in the **Tamil Nadu Assembly Elections**, the expenditure statements of **7** recognised parties are unavailable. Similarly, **5** recognised parties have defaulted in submitting their expenditure statements for **Puducherry Assembly Elections** in which 11 recognised parties contested.

West Bengal Assembly elections were contested by 17 recognised parties but the election expenditure statements of 7 parties are not available.

Recommendations of ADR

While it is crucial for political parties to submit their expenditure statements for greater financial transparency, it is equally important to file the same within the time limit set by the ECI and endorsed by the Supreme Court of India. The National and Regional Parties should, ideally, lead by example by filing complete and correct statements of expenditure to the ECI well in time for public scrutiny so as to encourage financial transparency.

ADR requests the ECI to issue show-cause notices to those recognised parties which have defaulted in filing their election expenditure statements incurred during Assembly Elections held in the last 5 years.
