




Summary and Highlights

The Odisha Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **241 out of 244** candidates, who are contesting in the **Odisha Assembly Elections Phase II in the following constituencies:**



Criminal Background

- <u>Candidates with Criminal Cases</u>: Out of **241 candidates analyzed**, **84 (35%)** candidates have declared criminal cases against themselves.
- Candidates with Serious Criminal Cases:, 68(28%) have declared serious criminal cases against themselves .
- <u>Party wise Candidates with Criminal Cases:</u> Among the major parties, **21(60%)** out of 35 candidates analysed from BJP, **17(53%)** out of 32 candidates analysed from INC, **13 (37%)** out of 35 candidates analysed from BJD, and **4 (17%)** out of 23 candidates analysed from BSP have declared criminal cases against themselves in their affidavits.
- Party wise Candidates with Serious Criminal Cases: Among the major parties, 18(51%) out of 35 candidates analysed from BJP, 10(31%) out of 32 candidates analysed from INC, 11(31%) out of 35 candidates analysed from BJP, and 4(17%) out of 23 candidates analysed from BSP have declared serious criminal cases against themselves in their affidavits.



1. Offence for which maximum punishment is of 5 years or more.

Criteria for serious criminal cases

- 2. If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- Offences under Prevention of Corruption Act




Figure: Share of Wealth among the Contesting Candidates

- Crorepati Candidates: Out of the 241 candidates, 70(29%) are crorepatis.
- Party wise Crorepati Candidates: Among the major parties 21(60%) out of 35 candidates analysed from BJD, 20(57%) out of 35 candidates analysed from BJP, 13(41%) out of 32 candidates analysed from INC, and 1(14%) out of 7 candidates from AAP have declared assets worth more than Rs. 1 crore.




Figure: Party Wise Perecentage of Crorepati Candidates

- Average assets: The average of assets per candidate contesting in the Odisha Assembly Elections Phase II is Rs 1.93 Crores.
- <u>Party wise average assets:</u> Among major parties, the average assets per candidate for **35 BJD** candidates analysed is **Rs. 7.66 crores**, **35 BJP** candidates analysed is **Rs 3.14 crores**, **32 INC** candidates have average assets of **Rs 1.17 crores** and **,23 BSP** candidates have average assets worth **Rs. 10.53 lakhs**.

Other Background Details

- <u>Education details of candidates</u>: 111 (46%) candidates have declared their educational qualification to be between 5th and 12th, while 121 (50%) candidates have declared having an educational qualification of graduate or above. 4 candidates have declared to be just literate and 1 candidate has not given his educational qualification details.
- <u>Age details of candidates:</u> 57(24%) candidates have declared their age to be between 25 to 40 years while 147 (61%) candidates have declared their age to be between 41 to 60 years. There are 36 (15%) candidates who have declared their age to be between 61 to 80 years. 1 candidate has not declared his age.
- Gender details of candidates: 25(10%) female candidates are contesting in the Odisha assembly election Phase II.




