Criminal Background

- **Ministers with Criminal Cases:** 22 (76%) ministers have declared criminal cases against themselves. In the previous cabinet ministers of Bihar, 19 (68%) out of the 28 ministers analysed had declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** Out of the 22 ministers who have declared criminal cases, **9 have declared serious criminal cases** against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Cronepati Ministers:** Out of the **29** ministers, **21 (72%)** are cronepati. In the previous council of ministers, out of the 28 ministers analysed, 22(79%) were cronepati.
- **Average Assets:** The average assets of **29** ministers is **Rs 2.46 crores**.

Other Background details (Education, Gender, Age)

- **Ministers' Education:** A total of **9 (31%)** ministers have declared their educational qualification to be between 8th and 12th pass while **18(62%)** are graduates or have higher degrees.
- **Ministers' Age:** A total of **11 (38%)** ministers have declared their age to be between **31-50 years** while **18(62%)** ministers have declared their age to be between **51-70 years**.
- **Women Ministers:** Out of 29 Ministers, only **1(3%)** is a woman. In the previous cabinet of ministers, out of 28 Ministers, **2(7%)** were women.
