Analysis of Election Expenditure Statements of MLAs

Bihar Assembly Elections, 2020

According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories. Bihar Election Watch and Association for Democratic Reforms (ADR) have analyzed 240 out of 243 election expenditure statements submitted after the Bihar Assembly Election 2020 for newly elected MLAs.

List of MLAs whose expenditure statements were not analysed

These expenditure statements were not analysed due to the non-availability of the statements on the CEO Websites at the time of the making of the report.

The expenditure limit for the MLAs during the Bihar Assembly elections was **Rs. 30.80 lakhs**. These election expense documents include *details of expenses on public meetings and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

Recommendations:

1. Each Winner is required to file his election expenditure statement within 30 days of the results of the elections, the deadline in case of the Bihar Assembly Elections being the 11th December 2020. However, it was observed that the election expenditure statements of the Winners were not uploaded on the CEO/DEO's website till significantly after the deadline. **It is recommended that the Abstract Expenditure Statement (Annexure E2) of the MLAs is uploaded on the website of the CEO within 72 hours of the receipt of the statement.**
2. The deadline for filing an election petition against any Winner is 45 days after the declaration of the results. Generally, MLAs submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any Winner. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the MLAs and gather the relevant documents/proof etc. for the election petition.
3. As has been instated in the filing of affidavits during the elections, the MLAs should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure E2) and Schedule 1 to 10. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

Summary and Highlights of Election Expenses of MLAs from the Bihar Assembly 2020 Elections

1. **Less than 50% of the Limit:** Out of 240 MLAs analysed, 113 (**47%**) MLAs have declared election expenses less than 50% of the expense limit in their constituency.
2. **Average Election Expenses:** Based on the election expense declarations of 240 MLAs from Bihar Assembly, the average amount of money spent by them in the elections is **Rs 15.72 lakhs, which is 51% of the expense limit.**
3. **Party-wise Average Election Expenses:** The party wise average election expenses shows that the average spending for **74 MLAs from RJD is Rs14.53 lakhs** (47.2% of the expense limit). For **73 MLAs from BJP**, the average election expenditure is **Rs18.87 lakhs** (61.3% of the expense limit), the average election expenditure for **42 MLAs from JD(U)** is **Rs.14.27 lakhs** (46.4% of the expense limit), the average election expenditure for **19 MLAs from INC** is **Rs.18.05 lakhs** (58.6% of the expense limit), the average election expenditure for **12 MLAs from CPI(M)(L)** is **Rs.9.90 lakhs** (32.2% of the expense limit) and **4 Vikassheel Insaan Party MLAs** have spent **Rs. 15.74 lakhs** (51.1% of the expense limit).

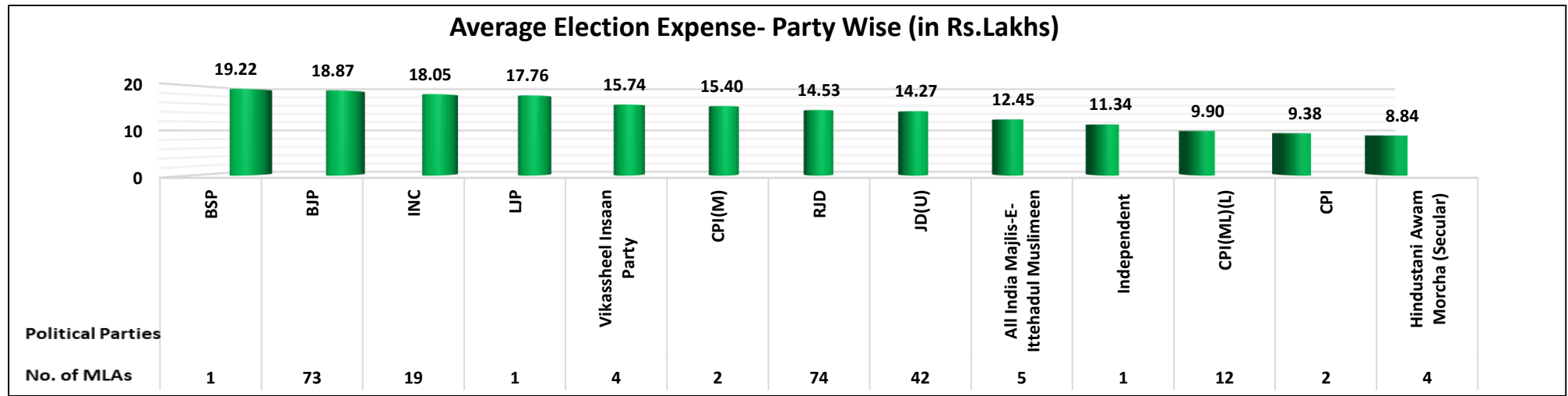


Figure 1: Party-wise Average Election Expenses (Rs.in lakhs)

- 6. Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the 240 MLAs analyzed, **198 (82.5%) MLAs** have declared that **they have spent funds on** public meetings, processions etc. With star campaigners and **42 (17.5%) MLAs** have declared that **they have not spent any funds on** public meetings, processions etc. with star campaigners.
- 7. Expense on Public Meeting, Rally, and Processions without Star Campaigners:** Out of the 240 MLAs analyzed, **191 (80%) MLAs** have declared that **they have spent funds on** public meetings, processions etc. Without star campaigners and **49 (20%) MLAs** have declared that **they have not spent any funds on** public meetings, processions etc. without star campaigners.
- 8. Expense on Campaigning through electronic/print media:** **180(75%) MLAs** have declared that **they have spent funds on** campaigning through electronic/print media and **60 (25%) MLAs** have declared that **they have not spent any funds on** campaigning through electronic/print media.
- 9. Expense on Campaign Workers:** **195(81%) MLAs** have declared that **they have spent funds on** campaign workers and **45 (19%) MLAs** have declared that **they have not spent any funds on** campaign workers.
- 10. Expense on Campaign Materials.:** **217(90%) MLAs** have declared that **they have spent funds on** campaign materials and **23(10%) MLAs** have declared that **they have not spent any funds on** campaign materials.
- 11. Expense on Campaign Vehicles.:** **239(99.58%) MLAs** have declared that **they have spent funds on** campaign vehicles and **Only 1(0.42%) MLA** has declared that **he has not spent funds on** campaign vehicles.

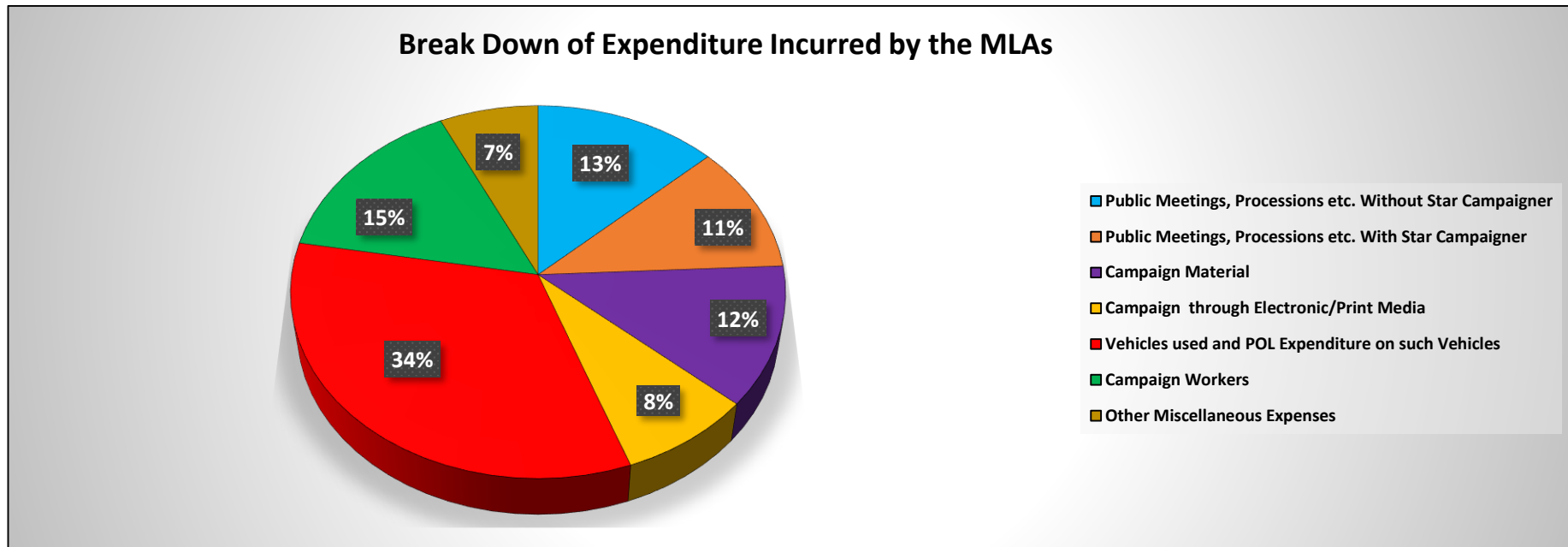


Figure 2: Break Down of Elections Expenses Incurred by MLAs

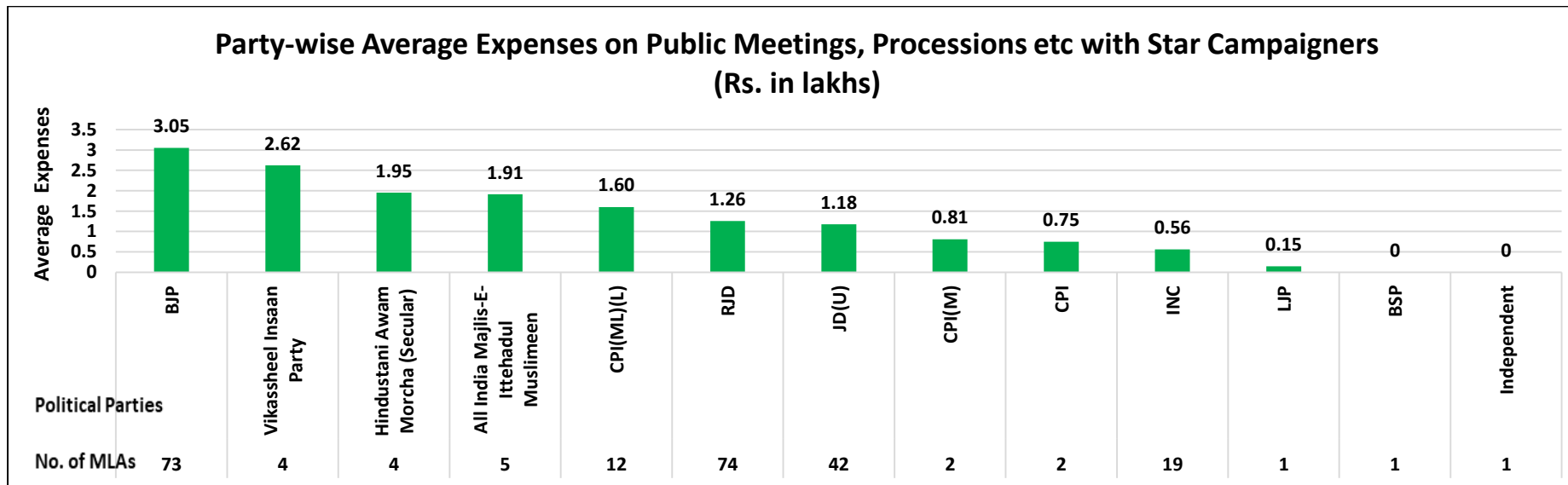


Figure 3: Party-wise Average Expenses on Public Meetings, Processions etc. with Star Campaigners (Rs. in lakhs)

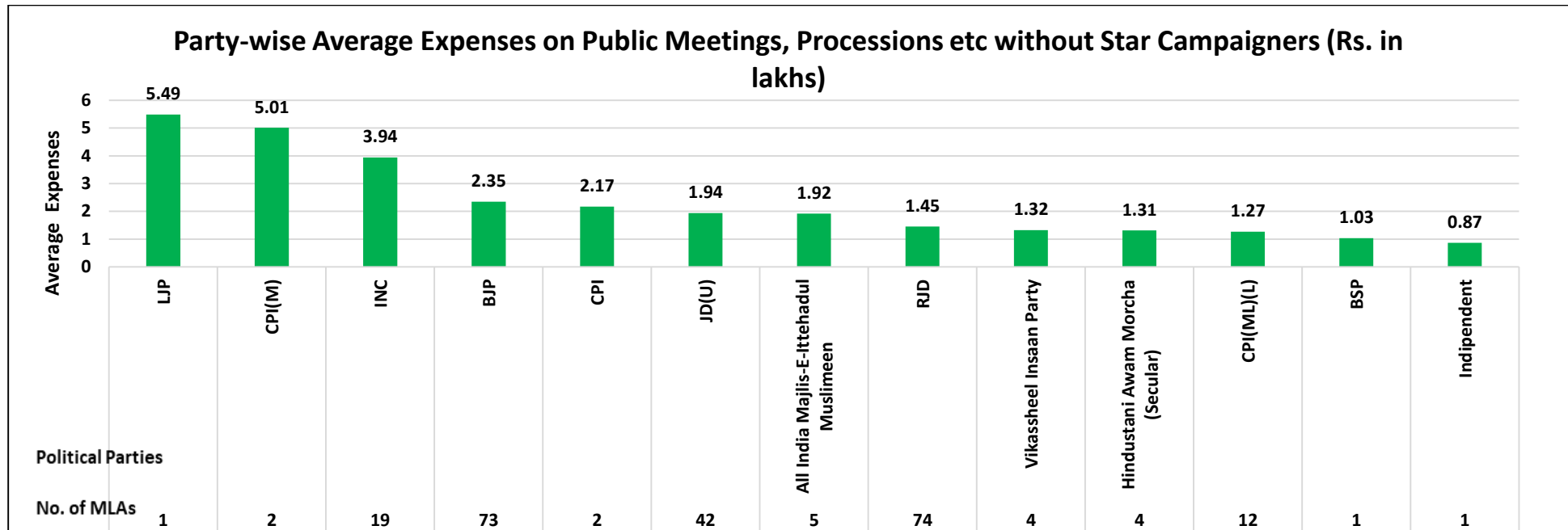


Figure 4: Party-wise Average Election Expenses on Public Meetings, Processions etc. without Star Campaigners (Rs.in lakhs)

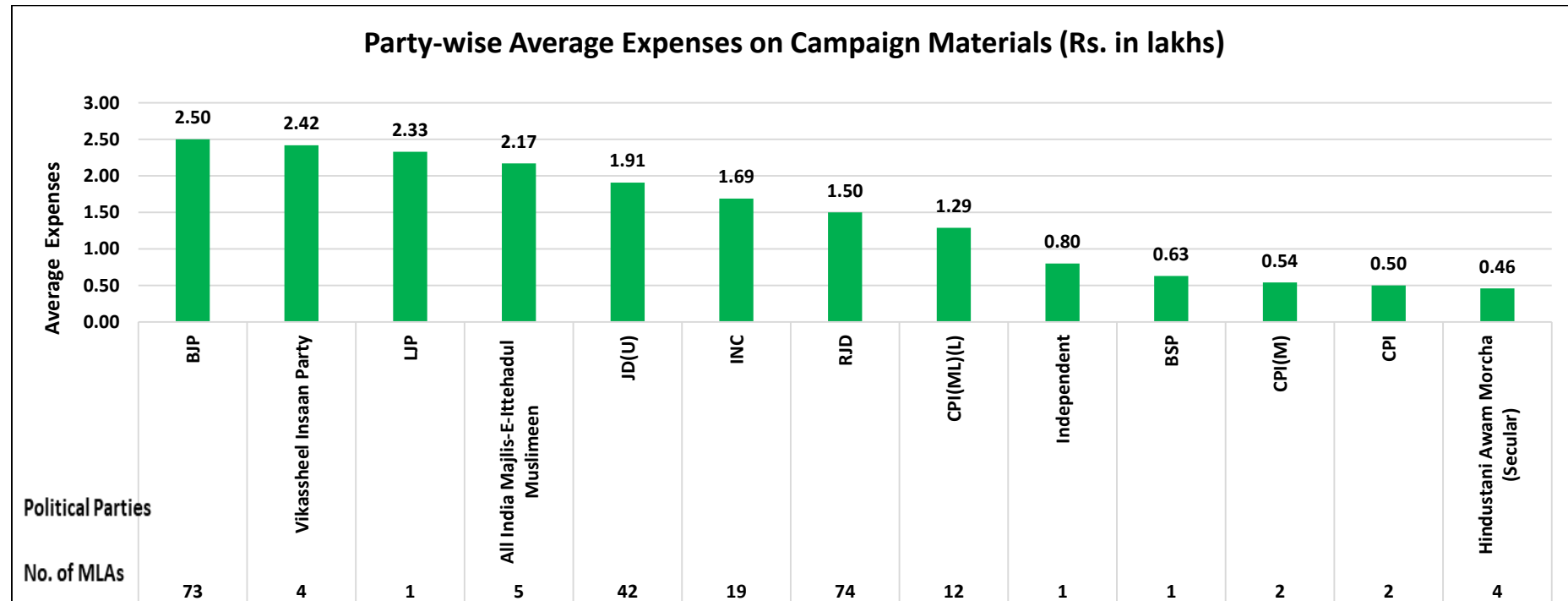


Figure 5: Party-wise Average Election Expenses on Campaign Materials (Rs.in lakhs)

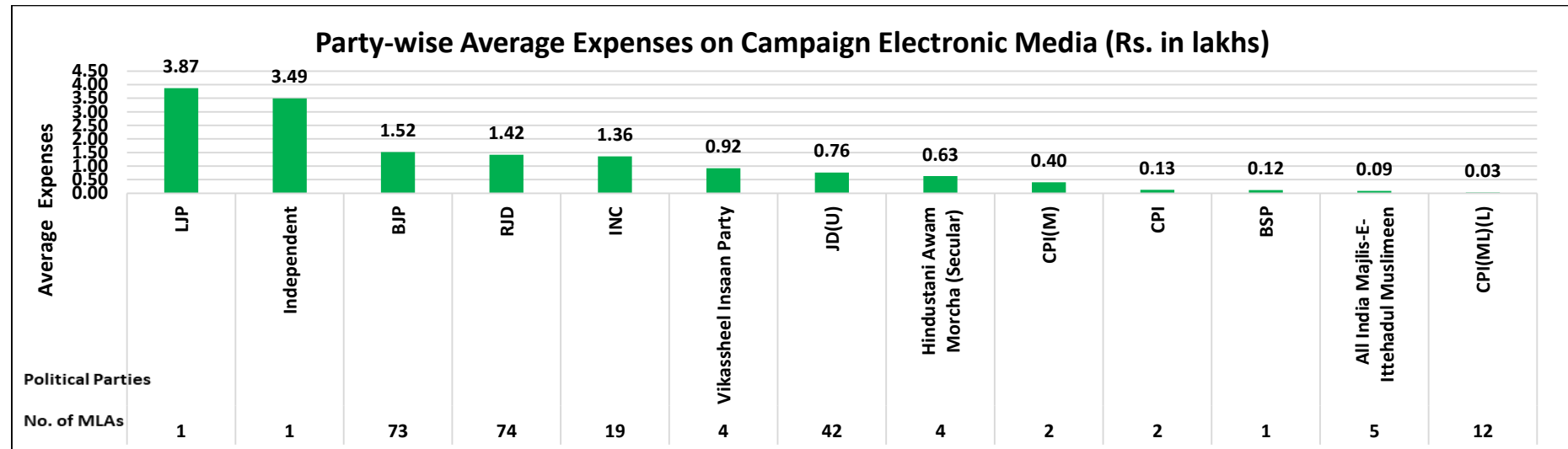


Figure 6: Party-wise Average Election Expenses on Campaign Electronic Media (Rs. in lakhs)

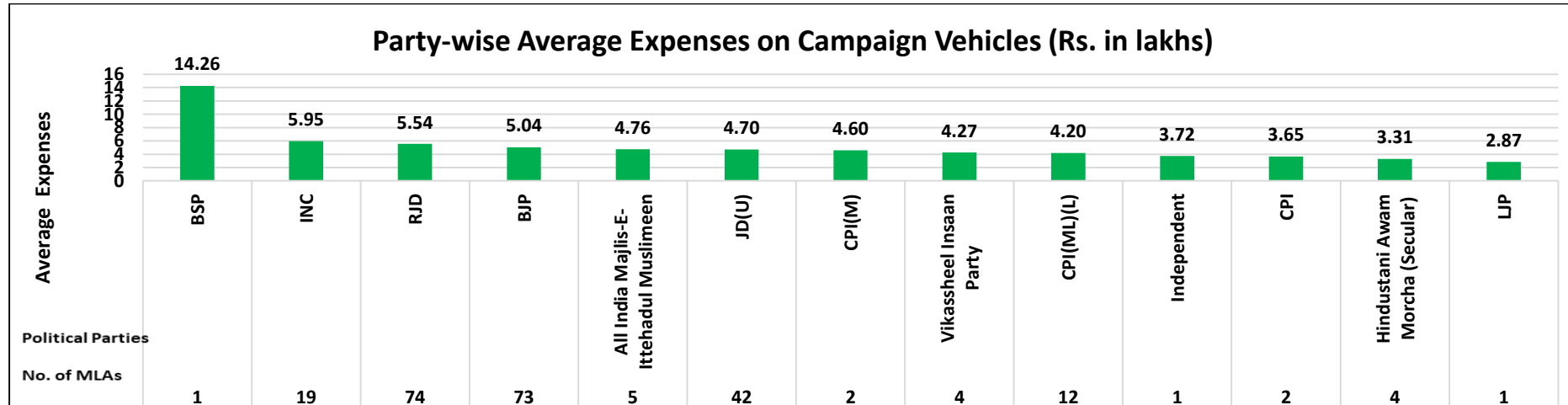


Figure 7: Party-wise Average Election Expenses on Campaign Vehicles (Rs. in lakhs)

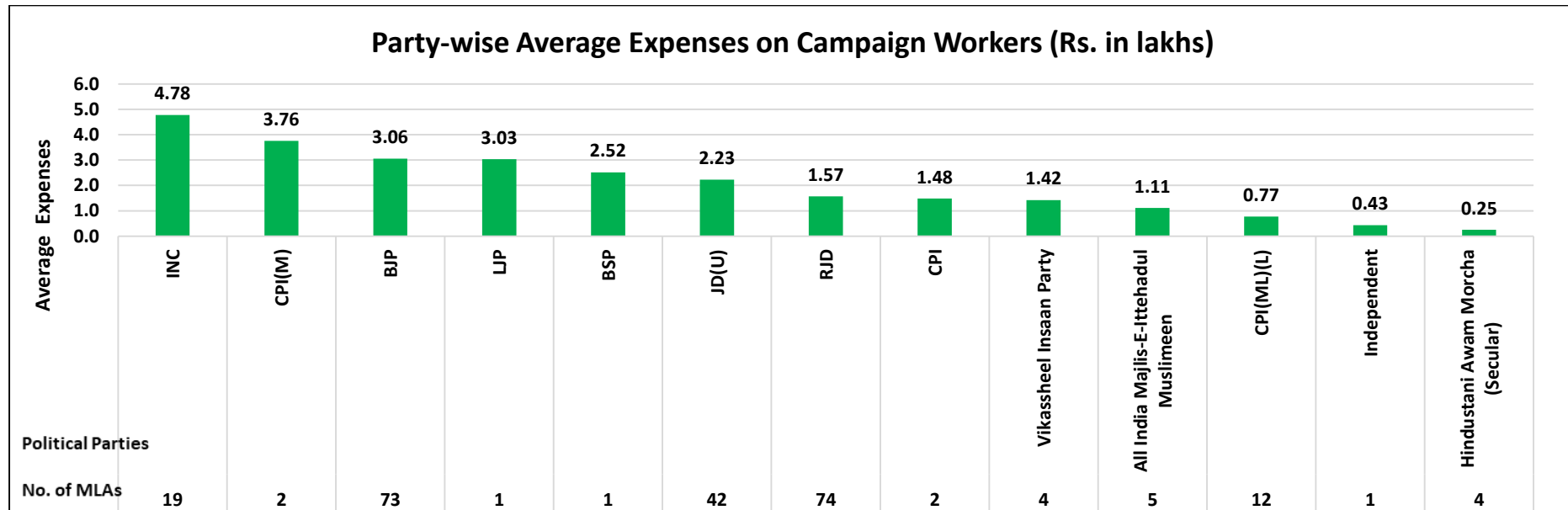


Figure 8: Party-wise Average Election Expenses on Campaign Workers (Rs. in lakhs)

Break-down of Sources of Funds Raised by MLAs

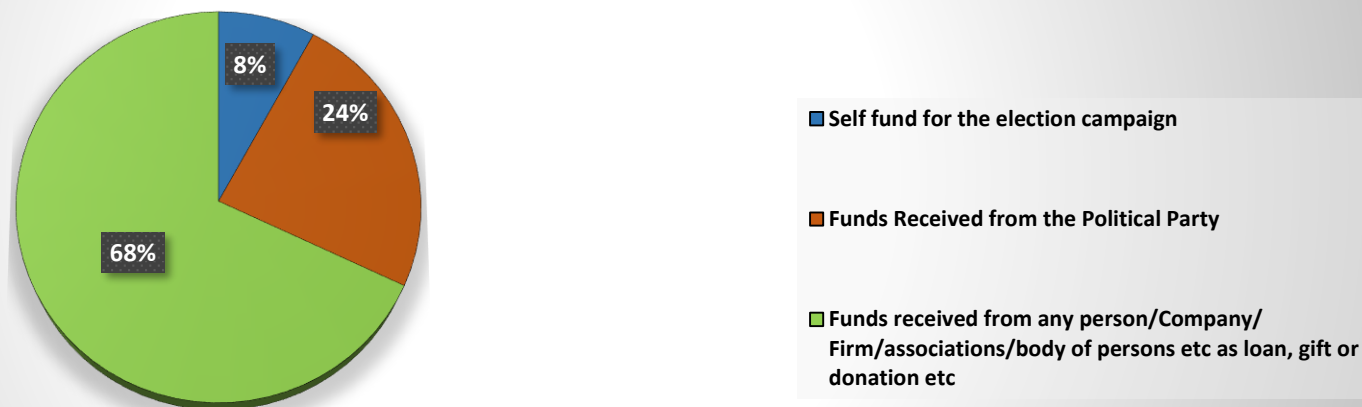


Figure 9: Percentage Break-down of Funds Raised by MLAs

1. **Percentage break-down of funds received by MLAs:** Out of the total funds received by MLAs, 24% funds were raised from political parties, 8% were raised by MLAs themselves and 68% funds were raised from other sources.
2. **MLAs Who Raised Funds from Political Parties:** Out of the 240 MLAs analyzed, 158 (66%) MLAs have declared that they have received funds from political parties and 82 (34%) MLAs have declared that they have not received any funds from political parties.
3. **MLAs Who Raised Funds through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:** Out of the 240 MLAs analyzed, 234(97.5%) MLAs have declared that they have received funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc. and 6(2.5%) MLAs have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.

4. **Self-funds used for election campaign:** Out of the 240 MLAs analyzed, **107(45%) MLAs** have declared that **they have used their own funds** for their election campaign and **133(55%) MLAs** have declared that **they have not used any of their own funds** for their election campaign
5. **Average funds raised from Political Parties (Party-wise):** On an average a MLA from **INC** raised **94.99%** and on an average a MLA from **BJP** raised **79.42%** of his/her election expense funds from the political party.
6. **Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc (Party-wise):** On an average a MLA from **RJD** raised **53.28%** of his/her election expense funds from any person/company/firm/associations/body of persons etc. as loan, gift or donation. Similarly, a MLA from **JD(U)** raised **20.20%** of his/her election expense funds, and a MLA from **BJP** MLAs raised on an average **9%** of their expense funds from any person/ company/ firm/ associations/ body of persons etc. as loan, gift or donation.
