## रिपोर्ट के मुख्य अंश

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और नेशनल इलेक्शन वॉच ने 6 राज्यों के उपचुनाव में 7 निर्वाचन क्षेत्रों के 43 में से 42 उम्मीदवारों के शपथपत्रों का विश्लेषण किया। उपचुनाव की मतदान तिथि 5 सितंबर 2023 है। केरल के निर्वाचन क्षेत्र पुथुपल्ली से 1 उम्मीदवार ल्यूक थॉमस का शपथपत्र स्पष्ट ना होने के कारण उनका विश्लेषण नहीं किया है।
