**Analysis of Candidates Contesting 2011 Assembly Elections in Tamil Nadu, Assam, Kerala, Puducherry and West Bengal
(13 pages in this report)**

- National Election Watch (NEW) groups in the four states of Tamil Nadu, Assam, Kerala, West Bengal and the Union Territory (UT) of Puducherry have analyzed the affidavits of 3547 candidates contesting in 2011 Assembly elections.
- 20% candidates i.e. (699 out of 3547 analyzed) have self declared pending criminal charges as per their affidavits in Assam, Kerala, Puducherry, Tamil Nadu and West Bengal 2011 Assembly Elections.
- 315 candidates out of these 699 analyzed have declared serious IPC charges like murder and attempt to murder charges against them.
- A total of 576 candidates (i.e. 16% of the total analyzed) are crorepatis.
- A total of 1785 candidates (50%) have declared that they have never filed Income Tax Returns (ITR).
- Out of the above 1785 candidates analyzed who have never filled IT returns, 1140 have not even given their PAN details.

Delhi, May 2nd, 2011: Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India. National Election Watch (NEW) groups in the four states of Tamil Nadu, Assam, Kerala, West Bengal and the Union Territory (UT) of Puducherry have analyzed the affidavits of 3547 candidates contesting in 2011 elections. This report is based on the analysis of these affidavits.

The following pages give party- wise and candidate-wise analysis of criminal, financial, PAN availability, IT, gender and other background information of the contesting candidates.

Analysis Based on Pending Criminal Cases

1. General Information

Assam Election Watch (AEW), Election Watch Kerala (EWK), Puducherry Election Watch (PEW), Tamil Nadu Election Watch (TNEW) and West Bengal Election Watch (WBEW) have analyzed a total of 3547 candidates contesting Assembly Elections in Assam, Kerala, Puducherry, Tamil Nadu and West Bengal. It will continue to analyze the remaining candidates and will update its reports accordingly.

2. Pending Criminal Cases against Candidates

- There are 699 candidates out of the 3547 analyzed, (i.e. about 20 %) who have criminal cases pending against them as per their self sworn affidavits given to the Election Commission.
- Out of the 699 candidates analyzed with pending criminal cases, 315 have declared pending **serious** criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. on them.

Analysis Based on Assets

A total of 576 candidates out of 3547 analyzed i.e 16% of the total number of candidates (analyzed) contesting in the 5 states are crorepatis. 38% of candidates analyzed of Tamil Nadu are crorepatis followed by 26% of candidates of Puducherry and 17% of candidates of Kerala.

Analysis of Income Tax and PAN details of Candidates in five Assembly Elections

- A total of 1785 candidates (50%) out of 3547 candidates analyzed have declared that they have never filed Income Tax Returns.
- Out of the above 1785 candidates who have never filed IT returns, 1140 have not even given PAN details.

State-wise candidates who have not filed Income Tax Returns (ITR)

Out of 3547 candidates analyzed, 1785 candidates (50%) have declared that they not filed Income Tax Returns. They include 67% of candidates from Kerala followed by 59% from Puducherry and 52% candidates from West Bengal.



- Financial details of 452 re-contesting MLAs out of 3547 candidates analyzed by NEW were matched with existing details from their 2006 affidavits.
- The maximum percentage growth is in the assets of the re-contesting MLAs of Tamil Nadu with 190% followed by Assam at 187%.
