Analysis of Financial and Other Background details of Candidates Contesting in Phase 1 and Phase 2 of the Gujarat Assembly Elections 2012

- Gujarat Election Watch (GEW) has analyzed affidavits of 952 candidates out of 1666 candidates who are contesting in the Gujarat 2012 Assembly Elections.
- A total of 302 candidates out of 952 analyzed i.e. 32% are crorepati. In 2007, there were 21% crorepati candidates.
- The top three candidates who have declared the highest assets are Balvantsinh Chandansinh Rajput of INC from Sidhpur constituency who has declared the highest assets worth Rs. 268 crores, followed by Indranil Sanjaybhai Rajguru, of INC from Rajkot East constituency with Rs. 122 crores worth of assets and Javaharbhai Pethalajibhai Chavada of INC from Manavadar constituency with assets worth Rs. 82 crores.
- A total of 70 candidates out of 952 analyzed have declared assets less than Rs. 1 Lakh.
- Balwantbhai Gopalbhai Solanki of SP from Kalol constituency, Viroolbhai V Dube (IND) from Bardoli (SC) constituency, Mineshbhai Maganbhai Patel (GPP) from Valsad constituency and Madarbhai Chandubhai Patel (IND) from Kaprada (ST) constituency have declared that they have zero assets.
- INC and BJP candidates with lowest assets: Pravinbhai Jinabhai Rathod from Palitana constituency is the INC candidate who has declared the lowest assets worth Rs 7.5 Lakhs. Rameshbhai Bhurabhai Katara from Fatepura (ST) constituency is the BJP candidate with lowest declared assets worth Rs 6 Lakhs.
- A total of 80 candidates out of 952 analyzed have declared liabilities of Rs. 50 lakhs or above.
- The top three candidates with highest liabilities are Balvantsinh Chandansinh Rajput, an INC candidate from Sidhpur who has declared the highest liabilities worth Rs. 52.33 Crores followed by Indranil Sanjaybhai Rajguru of INC from Rajkot East constituency with liabilities of Rs. 27.14 Crores and Jitendrabhai Kantilal Somani a BJP candidate from Wankaner constituency with liabilities of Rs. 17.69 Crores.
- Among major parties, the average asset per candidate for INC is Rs 6.98 Crores, for BJP is 5.45 Crores, for GPP is 1.13 Crores, for BSP is 46.24 Lakhs, for JD(U) is 17.87 Lakhs, for SP is 22.34 Lakhs, and for NCP is Rs 4.36 Crores.
- 216 out of 952 (23%) candidates analyzed in the Gujarat 2012 Assembly Elections, have not declared their PAN details
- 9 Crorepati Candidates have not declared their PAN details.
- 70 out of 150 candidates of BSP have not declared their PAN, 6 out of 180 of BJP have not declared their PAN, 7 out of 171 of INC have not declared their PAN, 29 out of 157 candidates of GPP have not declared their PAN, 17 out of 60 of JD(U), 2 out of 9 of NCP and 22 out of 59 of SP have not declared PAN details.

Number of parties and candidates contesting in Gujarat 2012 Elections

A total of 1666 candidates contested in the Gujarat 2012 Assembly Elections representing 27 political parties. In 2007, 1268 candidates contested, representing 39 parties for the Gujarat Assembly Elections.

Analysis based on assets

Out of 952 affidavits analyzed for candidates contesting in the Gujarat 2012 Assembly Elections, 302 (32%) are crorepati. 71% of candidates from BJP are crorepati, 64 % of INC candidates are Crorepati, 28% of GPP are crorepati, 2% of SP, 3% of BSP, and 56% of NCP candidates contesting in the Gujarat Assembly Elections are crorepati.


