

गुजरात में राजनीतिक दलों द्वारा प्राप्त दान (Donation) का विश्लेषण

राजनीतिक दल चुनाव लड़ने एवं अपने दैनिक कार्य चलाने के लिए दान पर पूर्णतया आश्रित होते हैं। उन्हें कॉर्पोरेट जगत, ट्रस्टों एवं व्यक्तियों से दान के रूप में भारी रकम मिलती है।

जन प्रतिनिधि अधिनियम 1951 (Representation of People Act) के अनुभाग 29सी के अनुसार राजनीतिक दलों को किसी व्यक्ति अथवा कंपनी से मिले 20,000 रु० से अधिक के दान का विवरण देना होता है। इस अनुभाग का अर्थ राजनीतिक दलों के अनुसार यह है कि इसमें वे सारे दान शामिल किए जाएं जो कि एक स्रोत द्वारा एक समय पर दिए गए हैं और जो 20,000 रु० से अधिक हैं। तथापि, इस अनुभाग में वे सभी विभिन्न दान भी शामिल किए जाने चाहिए जो किसी एक व्यक्ति, संस्था अथवा कंपनी ने पूरे वर्ष के दौरान दिए हैं, और जिनका औसत 20,000 रु० या उस से अधिक है।

इसके अलावा राजनीतिक दलों ने नकद दान के लिए दानकर्त्ता को प्राप्ति (Receipt) के बदले कूपन जारी करने की प्रणाली अपना ली है। इन नकद दानों से दानकर्त्ता की पहचान करना मुश्किल हो जाता है इसका तात्पर्य यह है कि बहुत से नकद में लिए गए दान बेहिसाब रह जाते हैं क्योंकि खातों में वही राशी दर्ज होती है जिसकी प्राप्ति (Receipt) जारी की गई हो।

इसलिए यह बहुत आवश्यक हो जाता है कि एक सख्त नियामक प्रणाली बनाई जाए जिसके तहत राजनीतिक दलों को अपने लिए गए दान के सूत्र तथा उनकी सही मात्रा का विवरण देना आवश्यक हो।

गुजरात के दो मुख्य दलों, कांग्रेस और भाजपा के दान, आय और व्यय के विवरण का विश्लेषण गुजरात इलेक्शन वॉच (जी.ई.डब्ल्यू) और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स (ए.डी.आर) द्वारा किया गया है।

कुल आय (Total Income)

- ☞ पूरे भारत में विभिन्न स्रोतों से राजनीतिक दलों की कुल आय की गणना उनके द्वारा प्रस्तुत आयकर रिटर्न से की गई है।
- ☞ वित्तीय वर्ष 2007-08 से 2010-11 तक, चार वर्षों में कांग्रेस ने भाजपा 769.81 करोड़ की तुलना में अपनी कुल आय 1492.35 करोड़ घोषित की है। (पूरे देश से)
- ☞ दोनों राष्ट्रीय दलों में से भाजपा ने घोषित किया है कि उसकी कुल आय का 82.43 प्रतिशत वित्तीय वर्ष 2004-2005 से 2010-2011 तक प्राप्त किए गया दान है। जबकि कांग्रेस को उसी अवधि के दौरान मिला हुआ दान उसकी कुल आय का केवल 12.31 प्रतिशत है।
- ☞ दोनों राष्ट्रीय दलों के बीच कुल आय में से दान का अधिकतम भाग भाजपा के लिए 83.75 प्रतिशत है, जबकि कांग्रेस ने आय का मात्र 12.31 प्रतिशत भाग दान से प्राप्त घोषित किया है।

- ☞ कांग्रेस ने आय का 9 प्रतिशत और भाजपा ने आय का 21.71 प्रतिशत भाग ₹0 20,000 से ऊपर दान से प्राप्त किया है।

- ☞ राष्ट्रीय दलों के बीच भाजपा ने सर्वाधिक दान प्राप्ति की घोषणा की है, चार वित्तीय वर्षों के लिए भाजपा ने ₹0 644.77 करोड़ का दान प्राप्त किया है।
- ☞ हालांकि कांग्रेस केन्द्र में सत्ता में है, इसके बावजूद कांग्रेस ने चारों वित्तीय वर्षों में केवल ₹0 183.82 करोड़ का दान प्राप्त किया है जिसमें कांग्रेस ने ₹0 1171 करोड़ कूपनों की बिक्री से प्राप्त किये हैं।
