Gujarat 2007 Assembly Elections

Gujarat Assembly Elections 2007 were held during the month on December 2007. A total of 1268 candidates contested in the said elections and out of that Gujarat Election Watch (GEW) & Association for Democratic Reforms (ADR) have analyzed the data of 544 candidates. This report includes the analysis of criminal, financial, educational and other details of 544 candidates and 181 MLAs. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Executive summary of candidates and MLAs

Summary of Candidates

1. GEW analyzed the affidavits of 544 candidates, out of which 124 (23% of total analyzed) have pending criminal cases against them. INC had 50 out of 172 (29 % of total analyzed), BJP had 36 out of 180 (20% of total analyzed), IND had 20 out of 100 (20 % of total analyzed) and BSP had 9 out of 54 (17 % of total analyzed) candidates with pending criminal cases.
2. Out of these 124 candidates with pending criminal cases, 48 had pending serious criminal cases like murder, attempt to murder, rape, kidnapping, robbery, extortion etc. BJP had 19, INC had 15, and IND had 7 candidates with pending serious criminal cases.
3. There were 113 IPC charges of serious nature on the candidates which included murder, attempt to murder, kidnapping, theft etc.
4. Out of these 124 candidates with declared criminal cases, Jayantibhai R Rathva of BJP from JETPUR - Baroda constituency with 12 cases including 1 charge related to attempt to murder. He is followed by Maheshbhai C Vasava of JD(U) from DEDIAPADA constituency with 2 charges related to attempt to murder and :Bhagwanbhai D. Barad of INC from Junagadh with 6 cases including 2 charge related to attempt to murder
5. A total of 117 candidates out of 544 analyzed i.e. 22% were crorepatis.
6. The candidate who has declared maximum assets is Ashok Kumar B Shah of INC from Surat City West constituency with assets worth Rs 234.23 crores. He is followed by Chandubhai K. Patel of INC from Himatnagar constituency with assets worth Rs 220.89 crores and Saurabh Y patel of BJP from Botad constituency with assets worth Rs 65.29 crores.
7. A total of 6 candidates out of 544 analyzed declared zero assets.
8. A total of 10 candidates out of 544 analyzed declared liabilities of 1 Crore or above.
9. Among major parties, the average asset per candidate for INC was approximately 4.14 Crore each, for BJP it was 1.44 Crore and for BSP it was 22.96 Lakhs.

10. 44% of candidates (242 of 544 analyzed) did not furnish PAN card details.
11. Total number of women candidates who contested in the Gujarat Assembly Elections 2007 was a mere 88 compared to 1180 men candidates, i.e. only 7% of the candidates were women.
12. More than 36% candidates (195 of 544 analyzed) were graduates and above.

Summary of MLAs

- GEW analyzed the affidavits of 182 MLAs, out of which 44(24%) have pending criminal cases against them. BJP has 23 out of 121 (19 %), INC has 20 out of 55 (36 %) and IND has 1 out of 2 (50 %) MLAs with pending criminal cases.
- Out of these 44 MLAs with pending criminal cases, 14 have pending serious criminal cases like murder, attempt to murder, kidnapping, rape, robbery, extortion etc. BJP has 7 and INC has 7 MLAs with pending serious criminal cases.
- There were a total of 27 IPC charges of heinous nature on the MLAs. These include murder, attempt to murder, kidnapping, extortion, etc.
- Out of these 45 MLAs with declared criminal cases, Bhagwanbhai D. Barad of INC from TALALA constituency with 6 cases including 2 charges related to attempt to murder. He is followed by Ashok C Bhatt of BJP from Khadia constituency with 2 charges related to extortion and Jethabhai G Ahir of BJP from Shehra with 1 charge related to rape.
- A total of 57 MLAs out of 182 i.e. 31% were crorepatis.
- The candidate who has declared maximum assets is Saurabh Y patel of BJP from Botad constituency with assets worth Rs 65.29 crores. He is followed by Siddharth C. Patel of INC from Dhaboi constituency with assets worth Rs 19.71 crores and Javaharbhai P Chavda of INC from Manavadar constituency with assets worth Rs 18.32 crores
- Among major parties, the average asset per MLA for BJP is approximate 1.84 crore , for INC it is 1.31 crore and for NCP it is 71 Lakhs
- 31% of MLAs (56 of 182) had not furnished PAN card details.
- Total number of women MLAs in Gujarat Assembly Elections 2007 is mere 16 comparing to 165 men MLAs, i.e. only 9% of the MLAs in Gujarat Legislative Assembly are women.
- More than 42% MLAs (77 of 182) are graduates and above.
- A total of 55 MLAs out of 182 declared liabilities of 5 Lakhs or above.

Analysis based on pending criminal cases – Candidates

Party-wise break up of candidates with pending criminal cases

124 candidates out of 544 analyzed (23% of total analyzed) have pending criminal cases against them. BJP had 36 out of 180 (20 % of total analyzed), INC had 50 out of 172 (29% of total analyzed) and IND had 20 out of 100 (20 % of total analyzed) candidates with pending criminal cases. Out of these 124 candidates with pending criminal cases, 48 have pending serious criminal cases like murder, attempt to murder, kidnapping, robbery,
