

4. If no, whether any notice has been sent or any action taken against Indian National Lok Dal for filing of incomplete Income Tax Returns(i.e. without the Balance Sheet and Income and Expenditure account) for any assessment year, if any?

Please refer to your letter No. ADR04/RTI/PIO-INLD/02 dated 03.07.2012 on the captioned subject, received in this office on 09.07.2012.

2. As desired, para-wise reply to the information sought by you is as under:-

- (i) On going through the record available with this Ward, it is found that Indian National Lok Dal has filed its Income Tax Return for A.Y. 2010-11 only with this Ward. Further, Indian National Lok Dal was never an assessee of this Ward, though it had filed return for A.Y. 2010-11 manually with this Ward. Its PAN lies with W-31(1), Delhi.
- (ii) Out of the documents cited by you, Income Tax Return for A.Y. 2010-11 of Indian National Lok Dal contains the following:-
  - (a) Income & Expenditure A/c for the year ending 31.3.2010.
  - (b) Auditor's Report.
  - (c) Balance sheet as on 31.03.2010.

- (iii) As desired by you, kindly find enclosed herewith a copy of Income Tax Return of Indian National Lok Dal for A.Y. 2010-11 alongwith a copy of 'Auditor's Report', 'Balance sheet as on 31.03.2010' and 'Income & Expenditure A/c for the year ending 31.3.2010'.

3. It is pertinent to mention here that the photocopy of the above said documents is being provided to you keeping in view the judgement of Chief Information Commissioner delivered in Appeal No. CIC/AT/A/2007/01029 and CIC/AT/A/2007/01263 to 1270, as cited by you.

4. It is also to convey that the Indian National Lok Dal is being assessed with W-31(1), Delhi, hence, in future, information regarding Indian National Lok Dal may please be sought for from that office.
