Please refer to your application dated 21/8/2012 received in this office on 28.8.2012, requesting to furnish the information relating to Janata Dal (Secular). The pointwise reply is as follows:

1. No record is available for the Janata Dal (Secular) party for the AY 2002-03, 2003-04, 2004-05, 2005-06, 2006-07 & 2007-08 as per ITD computer system. However, the case for the AY 2007-08 and 2008-09 have been completed u/s 144 of the Income Tax Act, 1961. The returns for the AY 2009-10 and 2010-11 have been filed in the prescribed form. No return for the AY 2011-12 has been filed by the assessee till date.
2. Any document which had not been filed by any assessee alongwith ITR. can be asked by the Assessing Officer during the assessment proceedings. The cases for the AY 2007-08 and 2008-09 were completed u/s 144 of the Income Tax, 1961. The copy of the assessment orders cannot be provided as these are covered under the purview of section 8(1)(j) & 8(1)(e) of the Right to Information Act, 2005.
3. Not applicable in view of reply to 1 above.
4. Notices u/s were sent to the assessee for filing its income tax returns.

2. In case you are not satisfied with the above order passed by the undersigned, you may file appeal before the first appellate authority, who in your case is Joint Commissioner of Income-tax, Range-31, New Delhi.
