ORDER U/S 7(1) OF THE RIGHT TO INFORMATION ACT-2005.

The applicant filed an application under section 6(1) of the Right to Information Act-2005 seeking information in respect of political party Janta Party. Q1. Whether the political party, Janta Party, has filed their complete Income Tax Returns for the assessment years 2002-03 to 2012-13.

Answer: The records available and traceable in this office, as on date shows that Janta Party has filed income Tax Returns for the assessment year 2002-03, 2003-04, 2004-05, 2005-06, 2006-07, 2008-09, 2009-10, 2010-11 and 2011-12.
