



#### Analysis of Donations received by Political Parties in Karnataka

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals.

Section 29C of the Representation of People Act, 1951 states that political parties are required to submit contribution details received in excess of Rs 20,000 from any person or a company. This section has been interpreted by political parties to include every single donation made above Rs 20,000 by any person at one time. This section however, would also include in it multiple donations made by the same person, entity or company aggregating at Rs 20,000 or above during the year.

In addition to this, the coupon system has been adopted by political parties for collecting funds by issuing coupons in lieu of receipts to donors for cash contributions. Moreover, since these are cash donations it becomes difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued.

Thus, it is vital to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

#### **Total Income**

- Among the top 3 parties analyzed, the INC had highest total income of Rs.1492.35 crores for the period 2007-2011, followed by the BJP with Rs.769.81 crores and the JD(S) with only Rs.4.63 crores.
- The share of donations in the total income is 83.75% for the BJP, while INC has shown that
  their share of donations received from the total income is a mere 12.31%. The remaining is
  largely from the sale of coupons. For instance, the INC has received close to ₹ 1171 crore
  from 'sale of coupons'.
- The regional party, Janata Dal (Secular), has shown that they derived 99% of their total income from donations for the four financial years 2008, 2009, 2010 and 2011. They have not shown any significant sale of coupons.
- The JD(S) has also not filed their Income Tax Returns (ITR) for 2008-09 and 2010-11. As per Income Tax Act, Political Parties are liable to pay tax on their income of they do not file their IT returns.

#### Share of Donations received in excess of Rs 20,000 from Total Income

- INC has shown that its share of donations received in excess of Rs 20,000 from total income is a mere 9% and for BJP it is 21.71%.
- Janata Dal (Secular) has shown that 24% of its income comes from donations in excess of Rs 20,000 in all the four financial years considered out of a total income of Rs 4.63 crore

#### **Analysis of Total Donations of Parties**

The following table shows only the donations received by the parties. It does not show the income obtained through sale of coupons or from other sources like rent or interest income.

- BJP has declared that it has received the maximum donations amongst the national parties.
   Total Donations received for the four financial years is ₹ 644.77 crore.
- Even though INC is in power at the center, its total donations for the four financial years is ₹ 183.82 crore only. INC has received close to ₹ 1171 crore from 'sale of coupons'.
- Janata Dal (Secular) has not filed ITR for the FY 2008-09 and FY 2010-11. From the data available for the FY 2007-08 and FY 2009-10, total donations received are Rs 4.58 crores.
