
**Income Tax Returns of Lok Janshakti Party (FOR Assessment Years 2002-2003, 2003-2004, 2004-2005,

Please refer to your application dated 9/8/2012 received in this office on 6.7.2012, requesting to furnish the information relating to Lok Jan Shakti Party. The pointwise reply is as follows:

1. As per computer record (ITD), the Lok Jan Shakti Party has filed their income tax return for the AY 2003-04, 2004-05 and 2008-09 at Ward 31(2), for AY 2005-06 at Circle 31(1). For the AY 2002-03 and 2006-07, no record is available at ITD. The return filed for the AY 2005-06 being an old one, is not readily traceable.
2. Any document which had not been filed by any assessee alongwith ITR, can be asked by the Assessing Officer during the assessment proceedings.
3. Not applicable in view of reply to 1 above.
4. No notice has been sent to the assessee in view of the reply above.

2. In case you are not satisfied with the above order passed by the undersigned, you may file appeal before the first appellate authority, who in your case is Joint Commissioner of Income-tax, Range-31, New Delhi.
