Summary and Highlights

The National Election Watch and Association of Democratic Reforms (ADR) have analysed the self-sworn affidavits of 261 out of 265 Candidates from 3 Lok Sabha Constituencies of 3 states and 30 State Assembly Constituencies of 14 states Bye-elections to be held on 30th October, 2021. 4 Candidates were not analysed due to unclear affidavit available on the ECI website at the time of making this report.

Lok Sabha bye-elections

Criminal Background, Financial, Education, Gender and other details of Candidates

- Affidavits of all **26 candidates** who are contesting in Lok Sabha Bye-elections 2021 have been analyzed.
- There are **4(15%)** candidates who have declared criminal cases against themselves. Out of these, **1(4%)** has declared serious criminal cases against himself.
- > 7(27%) candidates are crorepati.
- > The average assets per candidate contesting in the Lok sabha bye election is **Rs. 4.97 crore.**
- > There are 11 candidates who have declared liabilities.
- > Out of 26 candidates, 4 are women.

- > Affidavits of 235 out of 239 candidates who are contesting in Assembly Bye-elections 2021 have been analyzed.
- There are **44(19%)** candidates who have declared criminal cases against themselves. Out of these, **36(15%)** have declared serious criminal cases against themselves.
- > 77(33%) candidates are crorepati.
- > The average assets per candidate contesting in the Assembly bye election is Rs. 2.99 crore.
- > There are 93 candidates who have declared liabilities.
- Out of 235 candidates, 18 are women.
