# Analysis of Election Expenses of MLAs from the Mizoram, 2013 Assembly Elections

**According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories.** Election Expense limit for the Mizoram 2013 Assembly Elections is 8 Lakh Rupees.

Mizoram Election Watch (MEW) and Association for Democratic Reforms (ADR) have analyzed the election expenditure affidavits of 39 out of the 40 newly elected MLAs in the Mizoram 2013 Assembly Elections. The election expenditure affidavit of 1 MLA C. Ngunlanchunga of INC from Lawngtlai West Constituency was not analysed due to an unclear scan of the statement on the CEO Mizoram Website. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

## Summary and Highlights of Election Expenses of MLAs from the Mizoram 2013 Assembly Elections

1. **Less than 50% of the Limit:** Candidates have constantly claimed that the election expenditure limit set is very low. However, based on the election expense declarations of 39 out of 40 newly elected MLAs of Mizoram to the ECI, **16 MLAs (41%) have declared election expenses of less than 50% of the expense limit** i.e. Rs 8 Lakhs.
2. **Average Election Expenses:** Based on the election expense declarations of 39 out of the 40 newly elected MLAs of Mizoram to the ECI, the **average amount of money spent by them in the elections is only about Rs 4.39 Lakhs, which is 55% of the expense limit** (8 Lakhs).
3. **Party wise Average Election Expenses:** The Party wise average election expenses shows that the average spending for **33 MLAs of INC is Rs 4.19 lakhs** (52% of the expense limit), for **MNF's 5 MLAs is Rs 5.70 lakhs** (71% of the expense limit) and for **1 MLA of MPC is Rs 4.45 Lakhs** (56% of expense limit).
4. **Election expense of Chief Minister:** Lal Thanhawla has declared election expense of **Rs 4.60 Lakhs** (58% of expense limit) and **Rs 3.50 Lakhs** (44% of expense limit) from Hrangturzo and Serchhip constituencies respectively.
5. **Election expense of Ministers:** The average election expense declared by 11 Ministers including Chief Minister is **Rs. 3,81,147.** **8 out of 11 Ministers** have declared election **expenses of less than 4 Lakhs**, i.e. 50% of the expense limit. **Lal Thanzara** has declared highest election expense of **Rs 4.52 Lakhs** (57 % of expense limit) among ministers while **Lalsawta** has declared lowest election expense of **Rs 3.18 Lakhs** (40% of expense limit).

6. **Lowest Election Expenses:** A total of **2 MLAs (5%)** have declared election expenses **less than Rs 2 lakhs** (that is about 25% of Expense Limit set by ECI).
7. **Top 3 MLAs with highest Election Expenses:** The maximum expense of about **Rs 7.94 Lakhs** (99% of the expense limit) has been declared by **P.C. Zoram Sangliana of INC** from Kolasib constituency followed by **Lalruatkima of MNF** from Aizawl West - 2 constituency with an expense of **Rs 6.61 lakhs** (or 83% of the expense limit) and **K. Lalrinthanga of INC** from Serlui constituency with an expense of **Rs 6.50 Lakhs** (or 81% of the expense limit)
8. **MLAs with lowest Election Expenses:** The minimum expense of about **Rs 1.24 Lakhs** (or 16% of the expense limit) has been declared by **Chalrosanga Ralte of INC** from Lunglei West constituency. He is followed by **Dr.Ngurdilingiana of INC** from Chalfilh constituency with election expenses of about **Rs. 1.45 lakhs** (or 18% of the expense limit) and **R. L. Pianmawia of INC** from Tuivawl constituency with expenses of **Rs. 2.40 lakhs** (or 30% of the expense limit).
9. **Expense on Public Meetings and Processions:** Out of the 39 MLAs analyzed, **23 (59%)** have declared that they have **not spent ANY amount** on public meetings, processions etc.
10. **Expense on Campaigning through electronic/print media:** **26 MLAs (67%)** have declared that they have **not spent ANY amount** on campaigning through electronic/print media.
11. **Expense on Campaign Workers:** **11 MLAs (28%)** have declared that they **have not spent ANY amount on campaign workers**.
12. **Expense on Vehicles Used:** **3 MLAs** have declared that they have **spent less than Rs 20,000** on use of vehicles. **Zodintluanga of INC** from Thorang constituency has declared that he has spent only **Rs. 12,460** on vehicle use. **Dr.R. K. Beichhua of MNF** from Saiha constituency has declared highest expenditure of **Rs 2.99 Lakhs** on usage of vehicles.
13. **Expense on Campaign Materials and Erection of gates, arches, banners etc.:** All 39 MLAs analysed have declared that they have incurred some expense on campaign materials and erection of gates, arches, banners etc. **Dr.Ngurdilingiana of INC** from Chalfilh constituency has declared **lowest amount of Rs 14,790** spent on **campaign Materials, banners, gates, etc.**

## Analysis of the Election Expenses – MLAs

### Election expenses declared by Ministers

The average election expense declared by 11 Ministers analysed including Chief Minister is **Rs.3,81,147**. **8 out of 11 Ministers** analysed have declared election **expenses of less than 4 Lakhs**, i.e. 50% of the expense limit. **Lal Thanzara** has declared highest election expense of **Rs 4.52 Lakhs** (57 % of expense limit) among ministers while **Lalsawta** has declared lowest election expense of **Rs 3.18 Lakhs** (40% of expense limit).

The minimum expense of about **Rs 1.24 Lakhs** (or 16% of the expense limit) has been declared by **Chalrosanga Ralte of INC** from Lunglei West constituency. He is followed by **Dr.Ngurdingliana of INC** from Chalfilh constituency with election expenses of about **Rs. 1.45 lakhs** (or 18% of the expense limit) and **R. L. Pianmawia of INC** from Tuivawl constituency with expenses of **Rs. 2.40 lakhs** (or 30% of the expense limit).

The Party wise average election expenses shows that the average spending for **33 MLAs of INC is Rs 4.19 lakhs** (52% of the expense limit), for **MNF's 5 MLAs is Rs 5.70 lakhs** (71% of the expense limit) and for **1 MLA of MPC is Rs 4.45 Lakhs** (56% of expense limit).The table below gives party wise average election expenses declared for MLAs of Mizoram 2013 Assembly.

## MLAs who declared NO expenses on Public Meetings, Processions etc.

According to the ECI's document of Election Expenditure Monitoring 2011, (5.5.1) *Any candidate or his representative, who applies for permission for a public meeting or a rally shall also submit an expenditure plan in a prescribed format along with the application for permission.* (5.6.2) *In the event of public rally or meeting by the star campaigner, if the candidate or his election agent shares the dias with the star campaigner/another dignitary or banners and posters with his name or photograph are displayed at the site of the rally or his name is mentioned by the Star Campaigner, then the entire expenditure on that rally other than the travel expenses on that star campaigner shuld be added to the candidate's expenses.*

Out of the 39 MLAs analyzed, **23 declared that they have not spent ANY amount on public meetings, processions etc.** as per their election expenses. The names of these MLAs are listed below:

### MLAs who declared NO expense on campaigning through electronic/print media

This category for monitoring election expenses is mainly to combat instances of “paid news” and surrogate advertising that many candidates resort to. According to 4.10.4 of ECI’s document of Election Expenditure Monitoring 2011, “*The candidate will have to submit the details of expenditure on the telecast/ broadcast in electronic media and advertisement/ paid news in print media. If the Media monitoring cell finds that any advertisement has been published in favour of any candidate without proper permission, they shall inform the RO immediately, and the RO will issue a notice to the candidate u/s 127 of the R.P.Act, 1951*”.

**26 MLAs have declared that they have not spent ANY amount on campaigning through electronic/print media.** The table below provides a list of the names of these MLAs.

## MLAs who declared lowest election expense on vehicle used

According to 5.9.1 of ECI's document of Election Expenditure Monitoring 2011, "*Each candidate shall submit before the R.O., details of all vehicles proposed to be used by him for his election campaign. The R.O. will issue permits for use on the same day. The vehicle permit obtained from the concerned RO is to be displayed on the front screen of the vehicle...*"

**3 MLAs have declared that they have spent less than Rs 20,000 on use of vehicles.** **Zodintluanga** of INC from Thorang constituency has declared that he has spent only **Rs. 12,460** on vehicle use. **Dr.R. K. Beichhua** of MNF from Saiha constituency has declared highest expenditure of **Rs 2.99 Lakhs** on usage of vehicles.
