Nagaland 2008 Assembly Elections

Nagaland Assembly Elections 2008 were held during the month of March in 2008. A total of 218 candidates contested in the said elections and out of that Nagaland Election Watch & Association for Democratic Reforms (ADR) have analyzed the data of 210 candidates. This report includes the analysis of criminal, financial, educational and other details of 210 candidates and 60 MLAs. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Growth of political parties

A total of 218 candidates contested in Nagaland 2008 Assembly Elections representing 10 parties. In 2003, 225 candidates contested representing 10 parties for the Nagaland Assembly Elections. The number of political parties has been constant and there is a decline of 3% in the number of candidates contesting elections. Out of the 10 parties contesting in 2008 Assembly Elections only 4 parties managed to win seats, rest 6 parties failed to secure even a single seat.

Executive summary of candidates and MLAs

Summary of Candidates

- Nagaland Election Watch has analyzed affidavits of 210 candidates out of 218 candidates who contested in 2008 Assembly Elections.
- Out of these 210 candidates analyzed, 4 candidates (2%) have declared criminal cases against them. RJD has 2 candidates with declared criminal cases followed by INC and IND with one candidate each with declared criminal cases against them.
- Among these 4 candidates who have declared criminal cases against themselves, B. P. Hangu of INC from Aboi constituency with 1 charge related to attempt to murder. He is followed by Dezoto Rhakho of RJD from Phek constituency with 1 charge related to cheating by personation and 1 charge related to punishment of criminal conspiracy, etc., Nkha Lotha of RJD from Sanis constituency with charges related to defamation and Y. Ekyimo Kikon of IND from Sanis constituency with 1 charge related to forgery for purpose of cheating, 1 charge related to criminal intimidation, etc.
- A total of 54 candidates out of 210 analyzed i.e. 26% are crorepatis.

- The candidate who has declared maximum assets is K.L. Chishi of INC from Dimapur-I with assets worth Rs 46.78 crore. He is followed by Nuklutoshi of NPF from Arkakong with assets worth Rs 40.97 crore and S. I. Jamir of INC from Dimapur-II with assets worth RS 35.33 crore.
- A total of 2 candidates out of 210 analyzed declared zero assets.
- A total of 7 candidates out of 210 analyzed have declared their liabilities. S. I. Jamir of INC from Dimapur-II constituency has declared highest liability of Rs 2.49 crores.
- Among major parties, the average asset per candidate for INC was 2.22 Crores, for NPF it was 2.80 Crores, BJP it was 1.65 crores and for RJD was 72.95 lakhs.
- 208 out of 210 candidates analyzed i.e. 99% did not furnish their PAN card details.
- 121 out of 210 candidates analyzed i.e. 58% are graduates or with higher educational qualifications.
- Out of 218 contesting candidates for Nagaland Assembly Elections 2008, only 4 (2%) candidates are women.

Summary of MLAs

- Nagaland Election Watch has analyzed affidavits of all 60 MLAs of Nagaland 2008 Assembly Elections.
- Out of these 60 MLAs analyzed for Nagaland 2008 Assembly Elections, no MLA has declared criminal cases against them.
- Out of all 60 MLAs analyzed from Nagaland 2008 Assembly Elections, 23 (38%) are crorepati.
- The MLAs with maximum assets in Nagaland is of K.L. Chishi of INC from Dimapur-I constituency with assets worth Rs. 46.73 Crores followed by Nuklutoshi of NPF from Arkakong constituency with assets worth Rs. 40.15 Crores and S.I. Jamir of INC from Dimapur-II constituency with assets worth Rs. 35.29 crores.
- 6 MLAs have declared assets of less than 5 lakhs.
- A total of 3 MLAs out of 60 analyzed declared their liabilities. S.I. Jamir of INC from Dimapur-II constituency has declared highest liability of Rs. 2.49 crores.
- Among major parties, the average asset per MLA for NPF is Rs 3.29 Crores, for INC is Rs 6.27 Crores, for IND is Rs 1.58 Crores.
- Out of 60 MLAs analyzed, 58 (97%) have not declared their PAN details.
- A total of 42 (70%) MLAs (out of 60 analyzed) are graduate or with higher educational qualification in Nagaland 2008 Assembly.
- Only 14 (23%) MLAs (out of 60 analyzed) are 10th pass and below.
- Out of 60 MLAs of Nagaland Assembly Elections 2008, there is not even a single woman MLA.

Analysis based on declared criminal cases – Candidates

Party-wise break up of candidates with declared criminal cases

A total of 210 affidavits were analyzed by Nagaland Election Watch for 2008 Assembly Elections. Out of these 210 candidates, 4 (2%) declared that they have declared criminal cases against them. RJD has 2 candidate, one candidate of INC and one independent candidate have declared criminal cases against them. The party wise break up is given below:

Affidavits of all the 60 MLAs have been analyzed by Nagaland Watch for 2008 Assembly Elections. Out of these 60 analyzed MLAs, no one has declared that they have criminal cases against them.

Analysis based on assets – candidates

Crorepati Candidates- Party wise break up

Out of 210 analyzed candidates in Nagaland 2008 Assembly Elections, 54 (26%) are crorepati. 45% of candidates from NPF are crorepati, INC with 20% and BJP with 24% crorepati candidates.
