Association for Democratic Reforms (ADR) and Haryana Election Watch (HREW) have analyzed the self-sworn affidavits of 229 out of the 230 candidates (as given by the ECI) who are contesting the 3rd Phase of the Lok Sabha 2014 elections from Haryana.

Executive Summary – Phase 3

Criminal Background

- Candidates with Criminal Cases:** Out of 229 candidates analysed, **15 candidates (7%)** have declared criminal cases against themselves.
 - Candidates with Serious Criminal Cases:** Out of 229 candidates analyzed, **10 candidates (4%)** have declared serious criminal cases including cases related to murder, attempt to murder, kidnapping, theft etc.
 - Candidates with multiple serious IPC counts:** A total of **7** candidates have declared multiple counts of serious IPC sections out of which **Ved Pal of BSP from Bhiwani-Mahendragarh** Constituency has declared the highest count of serious IPC charges i.e. **11**. He is followed by **Naveen Jindal** of INC from **Kurukshetra** Constituency with **6 serious IPC Counts** and **Davinder Kumar** an Independent candidate from **Kurukshetra** Constituency, with **6 serious IPC Counts**.
- Criteria for serious criminal cases**

 1. Offence for which maximum punishment is of 5 years or more.
 2. If an offence is non-bailable
 3. If it is an electoral offence (IPC 171E or bribery)
 4. Offence related to loss to exchequer
 5. Offences that are assault, murder, kidnap, rape related
 6. Offences that are mentioned in Representation of the People Act (Section 8)
 7. Offences under Prevention of Corruption Act
 8. Crimes against women.
- Party wise Candidates with Criminal Cases:** **2 (25%)** of 8 candidates fielded by **BJP**, **3 (30%)** of 10 candidates from **INC**, **1 (10%)** of 10 candidates of **BSP**, **1(10%)** of 10 candidates of **AAP**, **1 (33%)** of 3 candidates of **SP**, **1 (50%)** 2 candidates of **Haryana Janhit Congress(BL)**, and **4 (3%)** of **120 Independent** candidates have declared criminal cases against themselves in their affidavits.
 - Party wise Candidates with Serious Criminal Cases:** **3 (30%)** of 10 candidates of **INC**, **1 candidate** each from **BSP**, **SP**, **Indian Bahujan Sandesh Party (Kanshiram)**, **Haryana Janhit Congress(BL)** and **3(3%)** out of **120 Independent** candidates have declared serious criminal cases against themselves in their affidavits.
 - Candidates with cases related to Murder and Attempt to Murder:** **Ved Pal** of **BSP** from **Bhiwani-Mahendragarh** constituency has declared 1 charge related to **Murder (IPC Section-302)**, and 1 charge related to **Attempt to murder (IPC Section-307)**. **Kheme Thakur** of **SP** from **Faridabad** constituency has declared 1 charge related to **Attempt to murder(IPC Section-307)**.
 - Candidates with cases related to Kidnapping:** **Ved Pal** of **BSP** from **Bhiwani-Mahendragarh** constituency has declared 1 charge related to **Kidnapping or maiming a minor for purposes of begging (IPC Section-363A)**.

- **Red Alert Constituencies:** 2 out of 10 constituencies in Haryana have atleast 3 or more candidates with criminal cases.

Financial Background

- **Crorepati Candidates:** Out of the 229 candidates analysed, **92 (40%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **10 (100%)** out of 10 candidates in **INC**, **8 (100%)** out of 8 candidates in **BJP**, **6 (60%)** out of 10 candidates in **AAP**, **9 (90%)** out of 10 candidates in **INLD**, **2(67%)** out of 3 candidates in **CPI(M)** and **9 (90%)** out of 10 candidates in **BSP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average asset per candidate contesting in the 3rd phase of 2014 Lok Sabha Elections from Haryana is **Rs.4.84 Crores**.
- **Party-wise Average Assets:** Among major parties, the average asset for 10 **INC** candidates is **Rs 49.91 crores**, 8 **BJP** candidates have an average assets of **Rs.20.30 crores**, 10 **AAP** candidates have average assets of **Rs. 3.76 crores** , 10 **INLD** candidates have average assets of **Rs. 11.65 crores** while 10 **BSP** candidates have average assets of **Rs. 3.62 crores**.
- **High Asset Candidates:** **30** candidates have more than **Rs. 5 crores worth of assets**. Total Assets includes Self Assets and Others Assets. The top three candidates with highest assets are given below:

- **Candidates who have not given value for Immovable Assets:** 24 candidates have not given value for atleast one immovable asset in their affidavits.

- **Candidates who have dues to Government Departments:** 4 candidates have declared that they have dues to Government Departments.
- **Candidates with Liabilities:** A total of **111** candidates out of the 229 contesting candidates analyzed have declared liabilities. **Ashwini Kumar** of BJP from Karnal constituency has declared liabilities worth **Rs. 15.39 crores** followed by **Shruti Choudhry** of INC from Bhiwani-Mahendragarh constituency with liabilities worth **Rs. 10.68 crores** and **Kuldeep Bishnoi** of **Haryana Janhit Congress(BL)** from Hisar constituency with liabilities worth **Rs. 10.44 crores**
- **Candidates with High Income:** A total of **102** out of 229 candidates analysed have declared their total income out of which **34** candidates have declared total annual Income of **over 10 Lakhs**.
- **Candidates who have not declared Income Tax Details*:** **127 (55%)** Candidates out of the 229 contesting candidates analyzed have not declared income tax details. * *Some candidates may be exempted from filing Income Tax Returns*
- **Candidates with High Assets who have not declared Income Tax Details:** **29** candidates with assets worth more than Rs. 1 crore, have not declared Income Tax Details.
- **Undeclared PAN:** **65(28%)** out of the 229 contesting candidates analyzed have not declared their PAN details.

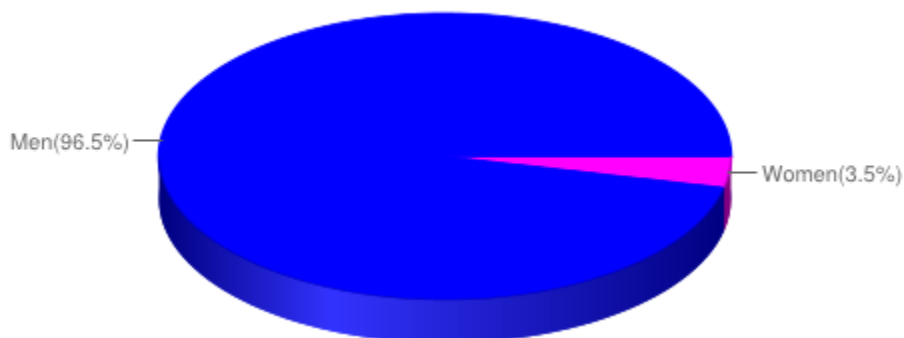
