Analysis of Criminal, Financial and Other Background details of Candidates from Madhya Pradesh (Phase-2) for Lok Sabha 2014

Association for Democratic Reforms (ADR) and Madhya Pradesh Election Watch have analyzed the self-sworn affidavits of 140 out of the 142 candidates contesting from Madhya Pradesh (Phase – 2) for Lok Sabha Election 2014 as given by the ECI.

The following candidates have not been analysed due to unavailability of affidavits or incomplete affidavits at the time of making this report:

Executive Summary – Phase 2

Criminal Background

- **Candidates with Criminal Cases:** Out of the 140 candidates analysed, **26 candidates (19%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 140 candidates, **15 candidates (11%)** have declared serious criminal cases relating to attempt to murder, dacoity, criminal intimidation etc.
- **Party wise Candidates with Criminal Cases:** INC had **4(40%)** out of 10, BSP had **4(40%)** out of 10, AAP had **4(40%)** out of 10, BJP had **3(30%)** out of 10 candidates with declared serious criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** BSP had **3(30%)** out of 10, SP had **3(50%)** out of 6, AAP had **3(30%)** out of 10, BJP had **2(20%)** out of 10 candidates who declared serious criminal cases against themselves.
- **Candidates with cases related to Murder and Attempt to Murder:** Girraj Yadav, independent candidate from **Guna**, has declared a case of murder against himself. Brindawan Singh Sikarwar of **BSP**, from **Morena** constituency, has declared 1 charge of attempt to murder against himself.
- **Candidates with cases related to Dacoity:** Jaibhansingh Pawaiya of **BJP** candidate from **Guna**, has declared 1 charge of dacoity against himself. Sheeba Malik of **SP** candidate from **Bhopal**, declared 1 charge of related to Dishonestly receiving property stolen in the commission of a dacoity.
- **Red Alert Constituencies***: 5 constituencies in Madhya Pradesh (Phase – 2) have at least 3 candidates with declared criminal cases.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections (including independents)

Financial Background

- **Crorepati Candidates:** Out of the 140 candidates analysed, **30 (21%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All 10 candidates from **INC** are crorepatis (**100%**), **8 out of 10 (80%)** BJP candidates, **4 out of 10 (40%)** BSP candidates and **3 out of 10 (30%)** of AAP candidates are crorepatis.
- **Average Assets:** The average assets per candidate contesting from Madhya Pradesh – Phase 2 in Lok Sabha 2014 elections is **Rs. 1.38 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset per candidate for **BJP** was **Rs. 3.12 Crore**, for **INC** was **Rs. 11.84 Crores**, For **BSP** was **Rs. 1.11 Crore**, for **AAP** was **Rs. 67.70**
- **High Asset Candidates:** 6 candidates have declared more than **Rs. 5 crore worth of assets**. Total assets include Self Assets and Others' Assets. Top 3 candidates with highest assets are:
