## **Analysis of Criminal, Financial and Other Background details of Candidates from Maharashtra (Phase-2) for Lok Sabha 2014**

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analyzed the self-sworn affidavits of 346 out of 357 candidates from Maharashtra (Phase – 2) for Lok Sabha Election 2014 as given by the ECI.

The following candidates have not not been analysed due to unavailability of affidavits or incomplete/unclear affidavits at the time of making this report:

## Executive Summary – Phase 2

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 346 candidates analysed, **71 candidates (21%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 346 candidates, **44 candidates (13%)** have declared serious criminal cases relating to murder, attempt to murder, rape etc.
- **Party wise Candidates with Criminal Cases:** **2 (22%) of 9** candidates fielded by **INC**, **4 (57%) out of 7** candidates from **BJP**, **2 (11%) out of 19** candidates from **BSP**, **5 (29%)** out of 17 candidates of **AAP**, **7(88%)** out of 8 candidates from **Shiv Sena** and **7 (78%)** out of 9 **NCP** candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **2 (29%) out of 7** candidates from **BJP**, **2 (12%)** out of 17 candidates of **AAP**, **4(50%)** out of 8 candidates from **Shiv Sena** and **5(56%)** out of 9 **NCP** candidates have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder :** **3** candidates have declared cases related to murder. **Raju Shetty of Swabhimani Paksha** from Hatkanangle constituency and **Sandip Amrutrao Mozar** an Independent candidate from Satara constituency have each declared 1 charge **related to murder (IPC Section-302)** while **Patil Padmasinha Bajirao** of **NCP** from Osmanabad constituency has declared 2 charges related to murder (IPC Section-302).
- **Candidates with cases related to Attempt to Murder:** **2** candidates have declared cases related to attempt to murder. **Raju Shetty of Swabhimani Paksha** from Hatkanangle constituency and **Adhalrao Shivaji Dattatreya** of **Shiv Sena** from Shirur constituency have each declared **1 charge of attempt to murder (IPC Section – 307)**
- **Candidates with cases related to Rape:** **Dambale Rahul Dharma** an Independent candidate from Pune constituency has declared **1 charge related to rape (IPC Section 376)**.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

**Red Alert Constituencies\*:** 11 out of 19 constituencies in Maharashtra (Phase – 2) have at least 3 candidates with declared criminal cases.

\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases standing up for elections. This analysis excludes independent candidates with criminal cases.

## Financial Background

- **Crorepati Candidates:** Out of the 346 candidates, **83 (24%)** are crorepati.
- **Party-wise Crorepati Candidates:** **8 (89%)** out of 9 candidates of **INC**, **all 7** candidates of **BJP**, **9 (53%)** out of 17 candidates of **AAP**, **all 8** candidates of **SHS** and **4 (21%)** out of 19 candidates of **BSP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average asset per candidate contesting from Maharashtra – Phase 2 in Lok Sabha 2014 elections is **Rs. 2.73 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset of **19 BSP** candidates is **Rs 97.73 lakhs**, **17 AAP** candidates have an average assets of **Rs 1.92 crores**, **9 INC** candidates have **Rs 21.91 crores**, **7 BJP** candidates have **Rs. 12.89 crores**, **9 NCP** candidates have average assets of **Rs. 23.89 crores** and **8 SHS** candidates have average asset of **Rs. 13.60 crores**.
- **High Asset Candidates:** **20** candidates have more than **Rs. 10 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Zero Asset Candidates:** 8 candidates have declared zero assets.
- **Low Asset Candidates:** Out of 346 candidates analysed, a total of **25** candidates have declared assets **less than Rs 50 thousand** (excluding the candidates with zero assets). The three candidates with lowest assets are as follows:

- **Candidates with Liabilities:** A total of 183 candidates out of 346 have declared liabilities **out of which 19** candidates have declared liabilities **above Rs 1 crores**. **Munde Gopinathrao Pandurang** of **BJP** from Beed constituency has declared liabilities of **Rs. 33.57 crores** followed by **Dr.Vishwajeet Patangrao Kadam** of **INC** from Pune constituency with liabilities of **Rs 20.49 crores** and **Dhananjay Bhimrao Mahadik** of **NCP** from Kolhapur constituency declaring total liabilities of **Rs 7.13 crores**
- **Candidates with High Income:** A total of 142 candidates have declared their income tax details **out of which 9** candidates have declared a total income of more than **Rs 50 lakhs**. **Dr.Vishwajeet Patangrao Kadam** of **INC** from Pune constituency has declared the highest total income of **Rs 22.84 crores** followed by **Khirid Simkumar Bhagwan** an Independent candidate also from Pune constituency with a total income of **Rs 2.43 crores** and **Supriya Sule** of **NCP** from Baramati constituency with a total income of **Rs. 2.08 crores**.

- **Candidates who have not declared Income Tax Details\*:** 204 (59%) candidates out of 346 analyzed have not declared income tax details. \* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 12 candidates out of 346 candidates have declared asset value of more than Rs 1 crore but have not declared Income Tax Details.
- **Undeclared PAN:** 96 (28%) out of 346 candidates analysed have not declared their PAN details.


