आपराधिक पृष्ठभूमि

- ☞ **आपराधिक मामलों वाले उम्मीदवार:** 147 में से 24 (16 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामलों घोषित किये हैं।
- ☞ **गंभीर आपराधिक मामलों वाले उम्मीदवार:** 147 में से 18 (12 प्रतिशत) उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामलों घोषित किये हैं। जिनमें हत्या, हत्या का प्रयास, अपहरण इत्यादि शामिल हैं।
- ☞ **उम्मीदवारों द्वारा घोषित आपराधिक मामले—दलवार:** बसपा के 11 में से 5 (45 प्रतिशत), भाजपा के 11 में से 3 (27 प्रतिशत), आम आदमी पार्टी के 10 में से 2 (20 प्रतिशत), पीस पार्टी के 10 में से 2 (20 प्रतिशत), सपा के 10 में से 1 (10 प्रतिशत) और कांग्रेस के 8 में से 2 (25 प्रतिशत) उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- ☞ दागी निर्वाचन क्षेत्र: 4 निर्वाचन क्षेत्र ऐसे हैं जहाँ राजनीतिक दलों के कम से कम 3 उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। इनमें निर्दलीय उम्मीदवार शामिल नहीं

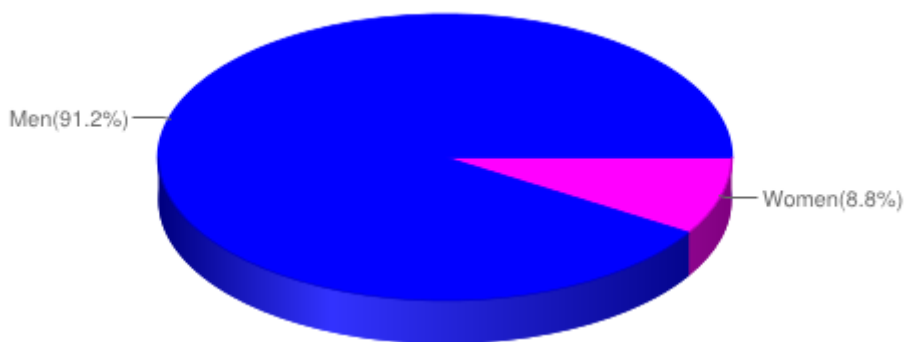
