Recommendations:

The current analysis of the candidates fielded by the major parties shows that **political parties continue to give tickets to candidates with serious criminal cases**. The Association for Democratic Reforms and National Election Watch recommend that

- Political parties should refrain from giving tickets to candidates with serious criminal cases.
- Political parties should take a stand against misuse of money power, bribing of voters and distribution of freebies.
- Political parties should move towards transparency and disclose the criteria for selection of candidates during elections.
