EXECUTIVE SUMMARY OF MPs OF RAJYA SABHA

Summary of MPs

- National Election Watch (NEW) analyzed affidavits of 227 out of 238 MPs of Rajya Sabha.
- Out of these 227 MPs analyzed, 41 (18%) MPs have declared pending criminal cases against them. INC had 8 out of 69 (12 %), BJP had 8 out of 49 (16 %), BSP had 5 out of 17 (29 %), SS had 4 out of 4 (100 %), CPI had 3 out of 5 (60 %), JD(U) had 3 out of 7 (43 %), NCP had 2 out of 7 (29 %), RJD had 1 out of 4 (25 %), SP had 1 out of 4 (25 %), DMK had 1 out of 7 (14 %) candidates with pending criminal cases.
- Out of these 41 MPs with pending criminal cases analyzed by NEW, 13 MPs have serious criminal cases like attempt to murder, voluntarily causing hurt by dangerous weapons or means, obscene acts and songs etc. pending against them. These include 3 from BJP, 2 from INC and 1 each from CPI (M), TDP, CPI, BJD, BSP and DMK.
- 8 out of 29 (28%) MPs analyzed from Uttar Pradesh have criminal cases pending against them while from Maharashtra, there are 9 out of 19 (47%) MPs, Bihar 4 out of 15 (27%) MPs and Andhra Pradesh has 3 out of 18 (17%) MPs with pending criminal cases.
- There are 20 IPC charges of heinous nature on MPs which include attempt to murder, voluntarily causing hurt by dangerous weapons or means, obscene acts and songs, etc.
- There are a total 86 criminal cases pending against MPs of Rajya Sabha.
- Out of 227 MPs analyzed by NEW, 131 (58%) of are crorepati.
- Among all the parties, INC has the maximum no. of crorepati MPs. INC has 48 (70%) out of 69 MPs who are crorepati, followed by BJP with 28 (57%) crorepati MPs out of 49 MPs.
- Out of 227 MPs analyzed, the average asset per MP of Rajya Sabha is Rs 12.14 crore.
- Out of 227 MPs analyzed, the value of average assets of MPs of INC is Rs. 12.45 crore, for BJP it is Rs. 5.65 crore and for BSP it is Rs. 5.98 crore.

1) Current Rajya Sabha consists of 238 Mps (231 elected MPs and 7 nominated MPs). Affidavits of 4 elected MPs are not available online. These MPs are:

Analysis based on pending criminal cases

A total of 227 out of 238 affidavits of MPs were analyzed by the National Election Watch (NEW). Out of these 227 MPs analyzed, 41 (18%) MPs declared criminal cases pending against them. Out of these 41 MPs with pending criminal cases, 13 have serious criminal cases like attempt to murder, voluntarily causing hurt by dangerous weapons or means, obscene acts and songs etc. pending against them.

Party-wise break-up of MPs with pending criminal cases

- A total of 41 MPs in Rajya Sabha have pending criminal cases against them. INC has 8 out of 69 (12%), BJP has 8 out of 49 (16%), BSP has 5 out of 17 (29%), SS has 4 out of 4 (100%), JD(U) has 3 out of 7 (43%), CPI has 3 out of 5 (60%), NCP has 2 out of 7 (29%), SP has 1 out of 4 (25%), AITC has 1 out of 6 (17%), BJD has 1 out of 6 (17%) MPs with pending criminal cases. Analysis based on the assets of MPs of Rajya Sabha

Affidavits of 227 out of 238 MPs were analyzed by the National Election Watch (NEW). Out of these 227 MPs analyzed 58% of them are crorepati. Dr. Vijaya Mallya, has highest total assets of Rs. 615 crore, followed by Dr. T. Subbarami Reddy with total assets of Rs 258 crore.

Crorepati MPs of Rajya Sabha- Party wise break-up

Among all the parties, INC has the maximum no. of crorepati MPs. Out of 69 MPs analyzed, 48 (70%) MPs of INC are crorepati, followed by BJP with 28 (57%) crorepati MPs out of 49 MPs analyzed. Surprisingly, out of 227 MPs analyzed, 58% of them are crorepati.
