



# **Sources of Funding of National Political Parties**

for FY 2004-05 to 2011-12

Where do the National Political parties get their funds from? An analysis of their Income Tax returns and statements filed with the Election Commission shows that the sources remain largely unknown. At present, political parties are not required to reveal the name of individuals or organizations giving less than Rs.20,000. As a result, over 75% of the funds cannot be traced and are from 'unknown' sources. This becomes very relevant in the light of recent events when the National Political Parties were brought under the RTI Act by a CIC ruling. There is an ongoing public debate on this issue. Unfortunately, full transparency is not possible under the current laws, and it is only the RTI that can keep citizens informed.

However, this is not the case in other leading democracies around the world. According to an analysis by the Stockholm-based International Institute of Democracy and Electoral Assistance (IDEA), 'India is ... among a mere 10% of countries in the world to allow either political parties or candidates to receive anonymous donations'. Another study of 40 countries shows that anonymity in the source of funding is not permitted in any of them. Some countries that have more transparency include our neighbours, Nepal and Bhutan.

### Highlights:

- National parties considered for this analysis are: INC, BJP, BSP, NCP, CPI and CPM
- Total income of political parties between FY 2004-05 and 2011-12: Rs 4,895.96 crores
- Total income of political parties as donations from Electoral trusts: Rs 105.86 crores, which is 2.16% of the total income of the parties
- Total income of political parties from known donors (details of donors as available from contribution report submitted by parties to Election Commission): Rs 435.85 crores, which is 8.90% of the total income of the parties
- Total income of political parties from other known sources (e.g., sale of assets, membership fees, bank interest, sale of publications, party levy etc.): Rs 785.60 crores, or 16.05% of total income
- **Total income of political parties from unknown sources** (income specified in the IT Returns whose sources are unknown): **Rs 3,674.50 crores**, which is **75.05**% of the total income of the parties
- The funds that can be classified as coming from 'unknown' sources are shown below:

- There are a total of 6 Electoral Trusts who have made contributions to political parties between 2004 and 2012, as per the statements provided by the political parties to the Election Commission of India.
- These trusts include the General Electoral Trust of the Aditya Birla Group, Electoral Trust of Tata Sons, Bharti Electoral Trust of Bharti Enterprises, Satya Electoral Trust, Harmony Electoral Trust and Corporate Electoral Trust
- It is to be noted that these trusts make contributions to the political parties more than once in a financial year

## • FY 2004-05: Rs 20.82 crores

 General Electoral Trust and Electoral Trust are the only two donors to INC and BJP donating a combined total of Rs 20.82 crores. Donations of General Electoral Trust to INC (Rs 11.21 crores) was more than 4 times the donations made by the trust to BJP (Rs 2.61 crores)

#### • FY 2005-06: Rs 35 lakhs

BJP is the only beneficiary to the donations made by General Electoral Trust amounting to Rs 35 lakhs. These donations were made in 7 installments of Rs 5 lakhs each over the FY 2005-06

#### • FY 2006-07: **Rs 10 crores**

 Only General Electoral Trust contributed to political parties and INC is the only beneficiary of the contribution. A total of Rs 10 crores was donated by the trust to the party in a single donation

### • FY 2007-08: Rs 5.76 crores

o INC and BJP were both beneficiaries to the donation by **General Electoral Trust**, receiving a total of **Rs 5.76 crores**. It is to be noted that BJP received Rs 5.51 crores which is

# 22 times more than the donation received by INC (Rs 25 lakhs)

#### • FY 2008-09: **Rs 19 crores**

General Electoral Trust and Bharti Electoral Trust contributed a total of Rs 19 crores to INC and BJP. It is to be noted than General Electoral Trust gave Rs 1 crore each to INC and BJP while Bharti Electoral Trust gave Rs 11 crores and 6 crores respectively to the two national parties

#### • FY 2009-10: Rs 47.93 crores

- As Lok Sabha Elections were held during the financial year 2009-10, a total of Rs 47.93 crores
  was donated by the major electoral trusts of India, General Electoral Trust, Electoral Trust,
  Satya Electoral Trust, Harmony Electoral Trust, Corporate Electoral Trust and Bharti Electoral
  Trust. These donations were made not only to INC and BJP but also to NCP
- <u>FY 2010-11:</u> No donations were made by any Electoral Trust to either national parties during the financial year 2010-11





#### • FY 2011-12: Rs 2 crores

- Satya Electoral Trust and General Electoral Trust made a total contribution of Rs 2 crores to INC and BJP. While General Electoral Trust did not contribute to INC, it donated Rs 1 crore to BJP while INC was the recipient of Rs 1 crore from Satya Electoral Trust
- Between FY 2004-05 and 2011-12, INC received a total of Rs 63,37,83,194 (63.37 crores), BJP- Rs 41,49,49,457 (Rs 41.49 crores), NCP Rs 1,00,00,000 (Rs 1 crore)

## **Recommendations of ADR**

- Since a very large percent of the income of political parties (75.1% for National parties) cannot be traced to the original donor, full details of all donors should be made available for public scrutiny under the RTI. Some countries where this is done include Bhutan, Nepal, Germany, France, Italy, Brazil, Bulgaria, the US and Japan. In none of these countries is it possible for 75% of the source of funds to be unknown, but at present it is so in India.
- Details of donors who make donations to the Electoral Trusts should be available in the public domain for increasing transparency in funding of political parties
- According to the Finance Bill introduced in 2009, 95% of the income of Electoral Trusts should be
  donated to political parties. Details of donations made by the electoral trusts to political parties has to
  be verified against the Income Tax Returns submitted by the electoral trusts so as to determine
  whether 95% of the Trusts' income has been donated
- The Law explicitly prohibits foreign funding to political parties. Electoral Trusts should also not be allowed to accept foreign funds. Subsidiaries of foreign companies, who get around the law by registering in India, but receive their funding from overseas, should also not be allowed to fund political parties.
- Any organization that receives foreign funding should not be allowed to support or campaign for any candidate or political party.
- The National and other political parties must therefore continue to provide all information under the Right to Information Act. This will only strengthen political parties, elections and democracy.





# Contributions received from various sources by political parties between FY 2004-05 and 2011-12

### Income of Political Parties from Known and Unknown sources

The contribution statements, submitted by the political parties declaring names and other details of donors who contribute above Rs 20,000, are the only **known source**. The **unknown sources** are income declared in the IT returns but **without giving source of income for donations below Rs.20,000**. Such unknown sources include 'sale of coupons', 'Aajiwan Sahayog Nidhi', 'relief fund', 'miscellaneous income', 'voluntary contributions', 'contribution from meetings/ morchas' etc. The details of donors of such voluntary contributions are not available in the public domain.

# Need for transparency in the funding of political parties by Electoral Trusts

Political parties have multiple sources of funding and thus accountability and transparency becomes all the more important. It is essential to have comprehensive and transparent accounting methods and systems, which would reveal the true financial position of the parties. The source of funding of Electoral Trusts is of utmost importance. Though the rules formed by the Central Bureau of Direct Taxes (CBDT) specify that electoral trusts are not permitted to receive foreign funding, these rules were formed only on 31<sup>st</sup> January, 2013. Hence, the details of all donors who made any contribution to the political parties through electoral trusts should be made public so as to ensure transparency in the financial aspect of functioning of political parties.
