Analysis of Donations Received by Political Parties in Meghalaya

Political parties rely heavily on donations for fighting elections and running their daily affairs. They receive huge sums of money in the form of donations and contributions from corporate, trusts and individuals.

Section 29C of the Representation of People Act, 1951 says that political parties are required to submit contribution details received in excess of Rs 20,000 from any person or a company. Named contributions seem to be very small i.e. single contributions above Rs 20,000 seem to be very few in number for all the parties.

In addition to this, the coupon system has been adopted by political parties for collecting funds by issuing of coupons in lieu of receipts to donors for cash contributions. Moreover, these are cash donations and it becomes all the more difficult to establish the identity of the donor. This implies that a lot of cash donations received remain unaccounted for in the books of accounts as only those amounts would be recorded for which a receipt has been issued.

Thus it becomes all the more important to have a strict regulatory mechanism wherein political parties have to report the correct quantum and the source of donations received.

Share of Donations from Total Income

- The total Income of political parties considered have been calculated from the income to the parties from various sources all over India as submitted in their Income Tax Returns. Political parties contesting in elections from the State of Meghalaya are INC, BJP, NCP, UDP and HPDP.
- INC (Rs 2,00,871.74 lakhs) tops the list followed by BJP (Rs 99,476.67 lakhs) and NCP (Rs 16,082.35 lakhs)
- Regional parties of the State of Meghalaya include United Democratic Party (UDP) and Hills State People's Democratic Party (HPDP). Donations details of these parties are not available with the ECI.
- The INC with Rs 27,250.48 lakhs collected from donations between FY 2004-05 and 2010-11 tops the list followed by BJP (Rs 82,000.50 lakhs) and NCP (Rs 1,303.11 lakhs) from all over India

- In spite of a total income of Rs 2,00,871.74 lakhs between FY 2004-05 and 2010-11, INC has declared that only 8.85% of its total income is covered by donations above Rs 20,000
- BJP, with a total income of Rs 99,476.67 lakhs, has only 19.46% coming from donations above Rs 20,000 collected during the same period

Top Donors of Parties for FY 2003-2004 to FY 2011-12

- General Electoral Trust is a major donor for INC (Rs 3641 lacs) for the Financial Years 2003-04 to 2010-11 while it must be noted that the trust has not made any contribution for the FY 2011-12
- Other major donors include Torrent Power donating Rs 1415 lacs followed by Bharti Electoral Trust donating Rs 1100 lacs to INC neither of which has made any contribution to INC in the FY 2011-12
- As donations reports was not available for BJP for the FY 2011-12, analysis has been done from FY 2003-04 to 2010-11.
- Top donor to BJP has been General Electoral Trust (Rs 2,607 lakhs) followed by Torrent Power Ltd (Rs 1,300 lakhs) and Asianet V Holding Pvt Ltd (Rs 1,000 lakhs)
- Torrent Power is one of the major donors to NCP too, donating Rs 100 lakhs between FY 2003-04 and 2011-12. Videocon Industries Ltd and Satya Electoral Trust are the other two top donors contributing a total of Rs 100 lakhs each between Fy 2003-04 and 2011-12
