Bihar Assembly elections 2005

Bihar Assembly elections were held in four phases in October 2005. This chapter includes the analysis of voting trends, criminalization of politics, use of money power, gender disparities etc in these elections. Information provided by the Election commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Number of candidates

A total of 2135 candidates contested from the 243 constituencies in the Bihar Assembly elections of October 2005. Out of 2135 candidates in 2005 elections, male and female candidates were 1999 (93%) and 136 (7%) respectively.

Executive summary for candidates and MLAs

Summary for candidates

- Bihar Election Watch (BEW) analyzed affidavits of 919 candidates out of 2135 who contested 2005 Assembly elections. This report is based on analysis of 919 affidavits of the candidates.
- Out of these 919 candidates, 358 candidates or 39% declared pending criminal cases against them. Out of 194 candidates of LJP, 85 (44%) had pending criminal cases, 72 out of 165(44%) from RJD, 58 out of 132 (44%) of JD(U), 53 candidates out of 100 (53%) of BJP and 20 out of 51(39%) candidates of INC had pending criminal cases against them.
- There were 846 candidates of six main parties (BSP, LJP, RJD, JD(U), BJP and INC) and out of these 846 candidates, 325 (38%) had pending criminal cases against them.
- There were 939 IPC charges of heinous nature on the candidates which included murder, attempt to murder, kidnapping, extortion, etc.
- There were a total of 39 red alert constituencies where 3 or more contesting candidates had pending criminal cases. Patna, East Champaran, Muzaffarpur, Rohtas and Banka had 4 candidates each with pending criminal cases.
- A total of 47 candidates out of 919 i.e. 5% were crorepatis.
- A total of 14 candidates declared zero assets.
- A total of 85 candidates declared liabilities above 5 lakhs.
- Among major parties, the average asset per candidate for INC was Rs. 72 lacs, for SP was Rs 40 lacs, for JD (U) and RJD was Rs. 34 lacs.
- 64% of candidates (587 of 919) had not furnished PAN card details.
- Number of women candidates was just 82 (9%) as compared to 837 of men (91%).
- More than 49% candidates (449 of 919) were graduates & above.

Summary for MLA's

• Out of 243 MLA's, affidavits were available for 233 MLAs. The MLA's report is based on the 233 available affidavits.

- Of the 233 MLA's, 117(50%) had pending criminal cases against them.
- Out of these 117 MLA's with pending criminal cases, 68(29%) had pending serious criminal cases.
- There were just 8 crorepati MLA's out of total 233 MLAs (3%). A total of 11% MLA's of RJD were crorepati whereas for JD(U) the corresponding figure was 6%.
- Among major parties, the average asset per winner for INC was Rs.21 lac, for BJP was Rs 22 lac, for RJD was Rs. 27 lac, for JD (U) was Rs 34 lac & for LJP was Rs 40 lacs.
- Average asset of an MLA from Bihar was Rs 27 lac.
- Out of 233 MLA's, 117 have not declared their PAN details.
- Of the 243 MLA's, there were 35 women MLA's. Hence only 14% of the MLA's in Bihar Assembly 2005 were women.

Party-wise break-up of Candidates and MLAs

There are 243 constituencies in Bihar. Maximum numbers of MLAs (88) are from JD (U) followed by 55 from BJP. The breakup of MLAs as compared to the total number of candidates from the party is:




Figure: Candidates vs. MLA's- Party wise

Analysis based on pending criminal cases

Total 919 affidavits were analyzed by Bihar Election Watch (BEW) for 2005 Assembly elections. Out of the 919 candidates, 358 or 39% declared pending criminal cases against them. Out of these 358 candidates with pending criminal cases, 213 had serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. pending against them.

Party wise break up for candidates with pending criminal cases

A total of 358 candidates contesting elections from Bihar had pending criminal cases against them. Out of 194 candidates of LJP, 85 (44%) had pending criminal cases, 72 out of 165 (44%) from RJD, 58 out of 132 (44%) of JD(U), 53 candidates out of 100 (53%) of BJP and 20 out of 51(40%) candidates of INC had pending criminal cases against them. 


Figure: Comparison of pending criminal cases and serious pending criminal cases for candidates of main parties from Bihar

Analysis based on the pending criminal cases -for MLAs

BEW has analysed affidavits of 233 MLAs out of 243 MLAs. Of 233 MLA's from Bihar Assembly in 2005, 117 MLA's had pending criminal cases against them. Of these 117 MLA's, there were serious criminal cases pending against 68 MLA's.

Party wise break up for MLAs with pending criminal cases

Out of total 117 MLAs with pending criminal cases, 39 are from JD (U), 32 are from BJP, 19 are from RJD, 6 are from LJP, 6 are from IND and 3 are from INC. The comparison between total candidates and MLA's is given below. The comparison between total candidates and MLAs is given below:




Figure: % MLAs with Pending criminal cases- Party wise

Party wise break up for MLAs with serious pending criminal cases

There are several cases of violent crimes like murder, attempt to murder, theft, extortion, robbery etc pending against MLAs of 2005 Bihar Assembly. The chart below gives summary of all serious violent offences related to murder, kidnapping, extortion, theft, robbery and dacoity. As can be seen MLAs of LJP had 260 pending serious IPC counts against them as compared to 132 of JD(U) and 129 of RJD, 102 of BJP, 70 of BSP, 62 of INC.




Figure: Crorepati candidates from major parties




Figure: Average assets for candidates

Analysis based on assets- for MLA's

Chances of winning based on assets

As can be seen from the table, the higher the assets the more are the chances of winning of a candidate. In the Bihar Assembly election 2005, 34% of the candidates who declared assets more than 50 Lakhs and above won. On the other hand less than 18% of candidates with assets less than 10 lakh won. The election results seemed to be highly influenced by the money power of the candidates.




Figure: Crorepati MLAs- Party wise break up




Figure: Comparison average assets for candidates & MLAs in Bihar assembly election 2005


