

Analysis of Criminal, Financial and other details of MLAs of the Manipur Assembly Elections 2012

Executive Summary

- Manipur Election Watch (MEW) has analyzed affidavits of all 60 MLAs of Manipur 2012 Assembly Elections.
- Out of these 60 MLAs analyzed for Manipur Assembly Elections, no MLAs has declared criminal cases against them. In 2007 assembly elections for the whole of Manipur, 2% MLAs had declared criminal cases against themselves.
- Out of all 60 MLAs analyzed from Manipur 2012 Assembly Elections, 16 are crorepatis. In 2007 Assembly Election for the whole of Manipur only 1 MLA was crorepati.
- The MLAs with maximum assets in Manipur is of T.N. Haokip of INC from Saikot(ST) constituency with assets worth Rs. 10.07 Crores followed by Ksh. Biren Singh of INC from Lamlai with assets worth Rs. 5.22 Crores and RK IMO Singh of MSCP from Sagoiband constituency with assets worth Rs. 2.72 crores.
- 6 MLAs have declared assets of less than 5 lakhs.
- A total of 5 (8%) MLAs out of 60 analyzed declared liabilities of Rs. 50 Lakhs or above.
- Among major parties, the average asset per candidate for INC is 1.05 Crores, for AITC is 69.8 Lakhs, For MSCP is 97.43 Lakhs, and NPF is 68.5 lakhs
- A total of 49 (82%) MLAs (out of 60 analyzed) are graduate or with higher educational qualification in the Manipur 2012 Assembly Election.
- Only 4 (7%) MLAs (out of 60 analyzed) are 10th pass and below
- Out of 60 MLAs of Manipur Assembly Elections 2012, only 3 (5%) MLAs are women.

Manipur Election Watch (MEW) has analyzed affidavits of all MLAs of Manipur 2012 Assembly Election. This report is

based on the analysis of these affidavits. There are a total of 60 constituencies that went to polls in Manipur 2012 Assembly Elections.

The following pages give party- wise and MLA-wise analysis of criminal, financial, education, PAN availability, IT, age, gender and other background information of the MLAs.

Growth of political parties

A total of 279 candidates contested in Manipur 2012 Assembly Elections representing 20 parties. In 2007, 308 candidates contested representing 19 parties for the Manipur Assembly Elections. There is a growth of 5% in the number of political parties and a decline of 10% in the number of candidates contesting elections. Out of the 20 parties contesting in 2012 Assembly Elections only 6 parties managed to win seats, rest 14 Parties failed to secure even a single seat.

Analysis based on pending criminal cases

Affidavits of all the 60 MLAs have been analyzed by Manipur Watch (MEW) for 2012 Assembly Elections. Out of these 60 analyzed MLAs, no one has declared that they have criminal cases against them.

Analysis based on assets

Crorepati MLAs Party Wise Break up

Out of 60 affidavits analyzed for MLAs of Manipur 2012 Assembly Elections, 16 (27%) are crorepati. 29% of MLAs from INC are crorepati while around 40 % of MSCP MLAs are Crorepati, 14% of AITC and 25% of NPF are crorepati.

Chances of winning based on assets

As can be seen from the table below, the higher the assets the more are the chances of winning for a candidate. In the Manipur 2012 Assembly Election, 47% of the candidates who declared assets more than 1 crore and above have won. On the other hand only 11% of candidates with assets less than 5 lakhs could win. The election results seemed to be highly influenced by the money power of candidates.
