Analysis of Candidates Contesting in Manipur 2012 Assembly Elections

(22 pages in this report)

- **3 candidates i.e. 1% (out of 258 analyzed) with self declared pending criminal charges contesting in the Manipur Assembly Elections.**
- **A total of 33 candidates out of 258 analyzed i.e. 13% are crorepati. In the Assembly elections of 2007, there were only 2 out of 304 (1%) candidates who were crorepati.**
- **A total of 170 candidates (66 %) have declared that they have never filed income tax returns.**
- **Out of the above 258 candidates analyzed, 89 (35%) have not given PAN details.**
- **Out of 258 candidates analyzed for Manipur 2012 Assembly Elections, the number of male candidates is 246 (95%) whereas the number of women candidates is only 12 (5%).**

Imphal/Delhi, January 18th, 2011: Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, has been working on electoral reforms, improving democracy and governance in India. Manipur Election Watch (MEW) has analyzed affidavits of candidates contesting in Manipur 2012 Assembly Election. This report is based on the analysis of these affidavits. There are a total of 60 constituencies going for polls in Manipur 2012 Assembly Elections.

The following pages give party- wise and candidate-wise analysis of criminal, financial, education, PAN availability, IT, age, gender and other background information of the contesting candidates.

Executive summary of Candidates

- Manipur Election Watch (MEW) has analyzed affidavits of 258 candidates out of 279 candidates who are contesting in 2012 Assembly Elections.
- Out of these 258 candidates analyzed, 3 candidates (1.2%) declared pending criminal cases against them. INC, AITC & MSCP have one candidate each with pending criminal cases against them.
- A total of 33 candidates out of 258 analyzed i.e. 13% are crorepati.
- A total of 2 candidates out of 258 analyzed declared zero assets.
- A total of 11 candidates out of 258 analyzed declared liabilities above 20 lakhs.
- Among major parties, the average asset per candidate for INC is 1.03 Crores, for NPP it is 1.07 Crores, for NPF was 72.2lakhs, for AITC it is 50.5 lakhs and for NCP it is 43.3lakhs.
- 89 out of 258 candidates analyzed i.e. 34.5% had not furnished their PAN card details.
- A total of 170 candidates (66%) out of 258 candidates analyzed have declared that they have never filed Income Tax returns (ITR).
- Out of the above 170 candidates analyzed who have never filed ITR, 88 have not even given their PAN details.
- 195 out of 258 candidates analyzed i.e. 76% are graduates or with higher educational qualifications.
- Out of 258 candidates analyzed for Manipur 2012 Assembly Elections, the number of men candidates is 246 (95%) whereas the number of women candidates was only 12(5%).

Representation of political parties

In Manipur 2007 Assembly Elections, 19 political parties contested which decreased to 17 in Manipur 2012 Assembly Elections. This reflects a decrease of 10% in the number of political parties contesting the election from Manipur 2007 Assembly Elections to Manipur 2012 Assembly Elections.

Number of candidates

In 2007 Manipur Assembly Elections, a total of 308 candidates contested. While only 279 candidates are contesting in 2012 Assembly Elections. This shows a 9% decrease in the number of candidates contesting the election from Manipur 2007 Assembly Elections to Manipur 2012 Assembly Elections.

Analysis based on pending criminal cases- candidates

A total of 258 affidavits were analyzed by Manipur Election Watch (MEW) for 2012 Assembly Elections. Out of these 258 candidates, 3 (1.2%) declared that they have pending criminal cases against them.

Party-wise break up of candidates with pending criminal cases

INC, AITC & MSCP have one candidate each with pending criminal cases against them. The party wise break up is given below:

Party-wise comparison of pending criminal cases on candidates in the Manipur Assembly Elections 2007 vs 2012

A comparison between candidates with pending criminal cases in Manipur Assembly Elections held in 2007 and 2012 shows that for parties INC, AITC and MSCP the number of candidates with pending criminal cases has increased in 2012 elections as compared to the 2007 Assembly Elections. None of the analyzed candidates contesting in 2012 have pending serious criminal cases.

Out of 258 analyzed candidates in Manipur 2012 Assembly Elections, 33 (13%) are crorepati. 24% of candidates from INC are crorepati while around 15% of MPP candidates are crorepati.

Candidates of INC have average assets in excess of 1.14 crores while those of NPP have assets in excess of 1.07 crores. Candidates of major parties have substantially more assets than those of other parties. Detailed list is given below-

Out of 258 candidates analyzed, 170 candidates (66%) have declared that they have never filed their ITR.

Top 10 high asset candidates who have never filed Income Tax Returns (ITR)

Among them, Alfred Kan-ngam Arthur of INC has the highest assets of approximately 7.9 crores followed by Sehpu Haokip of NPF with assets worth over 2.45 crores. Table below provides details of the top 10 candidates with high assets who have declared that they have never filed ITR:-
