Executive summary of MLAs

Chhattisgarh Election Watch (CEW) has analyzed affidavits of the 85 MLAs (out of the maximum 90) in the current assembly. Affidavits of 5 MLAs have not been analyzed since they are incomplete or poorly scanned.

Criminal

- **MLAs with Criminal Cases:** Out of these 85 MLAs analyzed for Chhattisgarh Assembly Elections, 11 MLAs or 13% have declared criminal cases against them.
- **Party wise MLAs with Criminal Cases:** Out of 48 MLAs of **BJP- 6(13%)** have declared criminal cases and out of 36 MLAs of **INC- 5 (14%)** have declared criminal cases against themselves.
- **MLAs with serious criminal cases:** Out of the 11 MLAs who have declared criminal cases against themselves, 8 (9%) MLAs declared serious criminal cases like murder.

Financial

- **Average Assets:** Average Asset per MLA (of 85 analyzed MLAs) in current Assembly is **Rs. 1.47 Crores**. Among major parties, the average asset per MLA for **BJP is Rs. 66.53Lakhs** (48 MLAs), and for **INC is Rs. 2.59 Crores** (36 MLAs).
- **Crorepati MLAs:** A total of 30 (35%) out of 85 MLAs analyzed are crorepatis.
- **Highest Asset MLAs:** **Nand Kumar Patel** of **INC** from Kharsia constituency has declared the highest assets worth **Rs 37.02 Crores**, followed by **Raj Kamal Singhaniya** of **INC** from Kasdol with declared assets worth **Rs 10.17 Crores** and **Gurumukh Singh Hora** of **INC** from Dhamtari constituency with assets worth **Rs 6.02Crores**.
- **Low Assets:** 20 MLAs have declared assets of less than Rs 25 lakhs.
- **MLAs with low assets:** **Dujram Bouddh** of **BSP** from Pamgarh constituency has declared the lowest assets of **zero rupees**. **Jageswar Ram Bhagat** of **BJP** from Jashpur constituency has declared assets of **Rs. 2 lakhs**. **Mahant Ramsunder Das** of **INC** from Jaijaipur constituency has declared assets of **Rs. 2.56 lakhs**.
- **Liabilities:** A total of 14 (16%) MLAs out of 85 analyzed have declared liabilities of Rs. 15 lakhs or above.
- **High Liability MLAs:** The top three MLAs with highest liabilities are **Paresh Agrawal, INC** MLA from Khallari with declared the highest liabilities worth **Rs. 59.51 Crores** followed by **Jai Singh Bhaiya** of **INC** from Korba constituency with liabilities of **Rs. 58.77 lakhs** and **Amarjeet Bhagatan, INC** MLA from Sitapur constituency with liabilities worth **Rs 29.47 lakhs**.
- **MLAs with no PAN:** 38 (45%) out of 85 MLAs have not declared their PAN details.

Analysis based on declared criminal cases – MLAs

Chhattisgarh Election Watch (CEW) has analyzed affidavits of 85 elected MLAs. Out of the 85 MLAs analyzed for Chhattisgarh Assembly election, 11 MLAs or 13% have declared criminal cases against them.

Party- wise break up of MLAs with declared criminal cases

Out of 48 MLAs of BJP- 6(13%) have declared criminal cases and out of 36 MLAs of INC- 5 (14%) have declared criminal cases against themselves.

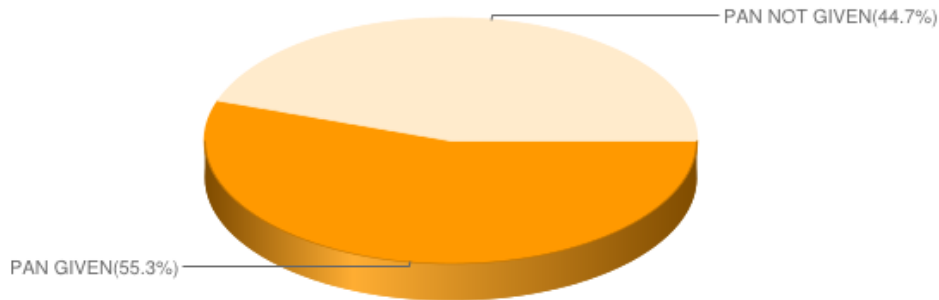
