Executive Summary

Criminal Background

- **Candidates with Criminal Cases:** Out of the 11 candidates analysed, **1 candidate (or 3%)** has declared a criminal case against himself.
- **Subu Kechu** an Independent candidate from **Arunachal West constituency** has declared one case related to **mischievous causing damage to the amount of fifty rupees.**

Financial Background

- **Crorepati Candidates:** Out of the 11 candidates analysed, **6 (55%)** are crorepatis.
- **Average Assets:** The average assets per candidate contesting in the 2nd phase of 2014 Lok Sabha Elections from Arunachal Pradesh is **Rs.3.36 crores.**
- **Party-wise Average Assets:** Among major parties, the average assets for 2 **INC** candidates is **Rs 9.69 crores**, 2 **BJP** candidates have an average assets of **Rs.4.74 crores** while the average assets of **PPA** candidates is **Rs. 2.54 crores** and the only **AAP** candidate has declared assets of **Rs. 1.45 crores.**
- **Candidates with Liabilities:** A total of **2** candidates out of 11 analyzed have declared liabilities. **Kiren Rijiju** of **BJP** has declared liabilities worth **Rs. 4.75 lakhs** and **Tapir Gao** of **BJP** has declared **Rs. 3 Lakhs** as liabilities.
- **Undeclared PAN:** **3(27%)** out of 11 candidates analysed have not declared their PAN details.
- **Candidates who have not declared ITR*:** None of the 11 candidates from Arunachal Pradesh contesting in the 2nd phase of Lok Sabha Elections have declared ITR.

**Candidates who have not declared ITR may be exempt from filing Income Tax Returns*
