Analysis of Criminal Background, Financial, Education, Gender and other details of Winners from Arunachal Pradesh 2014 Assembly Elections

Summary and Highlights

Arunachal Pradesh Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **58 winners** from Arunachal Pradesh State Assembly Elections 2014. The following winners were not analysed due to incomplete affidavit uploaded on the ECI website at the time of making of this report.

Criminal Background

- **Winners with Criminal Cases: 5(9%)** Out of the 58 winners analysed have declared criminal cases against themselves. All these 5 winners have declared serious criminal cases. In **2009 Assembly elections**, there were **2(3%)** winners with criminal cases out of 58 winners analysed.
- **Party wise Winners with Serious Criminal Cases: 4 (10%) out of 40** winners from **INC** have declared criminal cases against them while **1 (20%)** out of **5** winners from **PPA** have declared serious criminal cases in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Winners:** Out of the **58** winners analysed, **50 (86%)** winners are crorepatis. In 2009 Arunachal Pradesh Assembly elections, there were **34 (59%)** crorepatis out of 58 winners analysed.
- **Party wise Crorepati Winners: 37 (93%)** out of **40** winners from **INC** are crorepatis while **9 (82%)** out of **11** winners from **BJP**, **2 (40%)** out of **5** winners from **PPA** and **2 Independent winners** are crorepatis.
- **Average Assets:** The average assets of **58** winners analysed is **Rs 13.45 crores**. Average assets of 58 winners analysed from **2009 Arunachal Pradesh Assembly** elections was **Rs 6.70 crores**.
- **Party-wise Average Assets:** The average assets per winner for **40 INC** winners is **Rs 15.81 crores**, for **11 BJP** winners the average is **Rs 2.87 crores**, for **5 PPA** winners the average is **Rs 3.43 crores**. **2 Independents** have declared average assets of **Rs 49.32 crores**.
- **High Asset Winners: 4 winners** have declared assets worth more than **Rs 50 crores**. Their details are given below:

- **Undeclared PAN:** 6 (10%) winners out of 58 analysed have not declared their PAN details.
- **Crorepati winners with no PAN:** 5 winners who have declared assets worth more than **Rs 1 crore** had not disclosed their PAN details.
- **Winners who have not declared ITR*:** 56 (97%) out of 58 winners analysed have not declared their ITR details.

*Some Winners may be exempted from filing ITR

Other Background details (Education, Gender, Age)

- **Winners' Education:** A total of **38 (66%)** winners out of 58 analyzed are graduates or have higher degrees. **19 (33%)** winners have educational qualification of 12th pass and below.
- **Winners' Age:** A total of **36 (62%)** winners out of the 58 analyzed have declared their age to be between 25 and 50 years. **21 (36%)** winners declared their age to be between 51 and 70 years and 1 winner is aged above 70 years.
- **Women Winners:** Out of 58 Winners, only **2 (3%)** are women. In **2009 Assembly** elections, there were **2 (3%)** women winners.
