### Analysis of Election Expenses of MLAs from the 2014 Arunachal Pradesh Assembly Elections

***According to Section 78 of the Representation of the People Act, 1951, every contesting candidate has to lodge a true copy of his election expenses within 30 days from the date of declaration of result of election, with the District Election Officer in all States and Union Territories.*** Arunachal Pradesh Election Watch and Association for Democratic Reforms (ADR) have analyzed the election expense statements of all 60 MLAs submitted after the Arunachal Pradesh Assembly Elections of 2014. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.* ***Election expenditure limit for contesting candidates in Arunachal Pradesh assembly elections was Rs 20,00,000.***

#### **Recommendations:**

1. The candidate is required to file his election expenditure statement within 30 days of the results of the elections. The deadline for submitting the election expenditure statements for Arunachal Pradesh Assembly elections, 2014 was the 16<sup>th</sup> of June, 2014. The statements are then uploaded on the CEO websites within 72 hours of the receipt of the statement. It was observed that the election expenditure statements of the candidates were not uploaded on the CEO websites till significantly after the deadline. It is recommended that the Abstract Expenditure Statement (Annexure 15) of the candidates is uploaded on the CEO websites within 72 hours of the receipt of the statement.
2. The deadline for filing an election petition against any candidate is 45 days after the declaration of the results. Generally, candidates submit their election expenditure statements towards the end of the 30 days given for submission of the statements. This leaves 15 days for any common citizen to file an election petition against any candidate. The deadline for filing an election petition should be increased in order to give the citizens time to scrutinize the election expenditure statements of the candidates and gather the relevant documents/proof etc for the election petition.
3. As has been instated in the filing of affidavits during the elections, the candidates should not be allowed to keep any field blank on the Abstract Election Expenditure statement (Annexure 15) and Schedule 1 to 9. The statements must be filled in a legible format and overwriting of amounts in the statement should be discouraged.

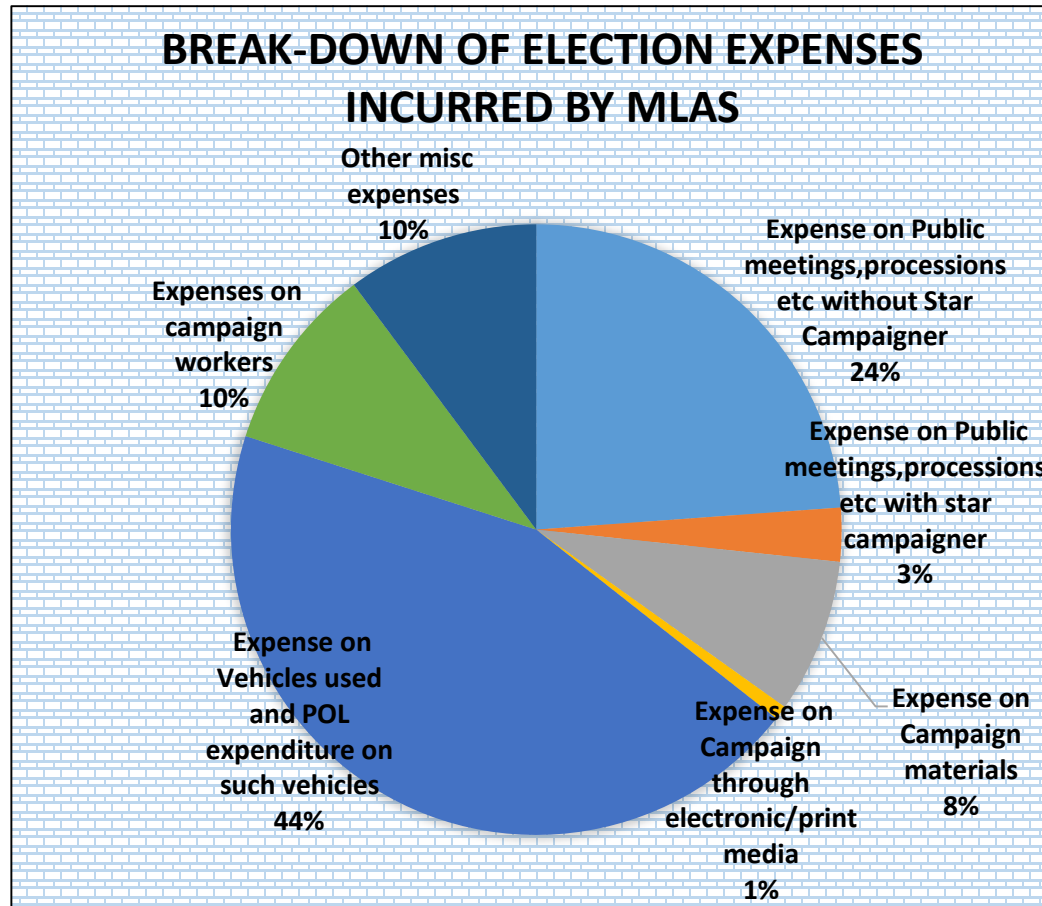

## **Summary and Highlights of Election Expenses of MLAs from the 2014 Assembly Elections**

1. **Less than 50% of the Limit:** Based on the election expense declarations of 60 MLAs, **39 MLAs (65%) have declared election expenses of less than 50% of the expense limit** in their constituency.
2. **Average Election Expenses:** The **average amount of money spent** by the 60 MLAs in the elections is only about **Rs 7.52 lakhs, which is 38% of the expense limit.**
3. **Party-wise Average Election Expenses:** The party wise average election expenses shows that the average spending for **42 MLAs from INC is Rs 7.15 lakhs (36% of the average expense limit), for 11 MLAs from BJP is Rs 7.71 lakhs (39% of the average expense limit) and for 5 MLAs from PPA is Rs 9.24 Lakhs (46% of the average expense limit).**
4. **Top 3 MLAs with highest Election Expenses:** The maximum expense of about **Rs 19.64 Lakhs (98% of the expense limit)** has been declared by **Gojen Gadi of INC** from Basar constituency followed by **Dikto Yekar of INC** from Daporijo constituency with an expense of **Rs 18.45 lakhs (or 92% of the expense limit)** and **Kumar Waii of INC** from Bameng constituency with an expense of **Rs 17.39 Lakhs (or 87% of the expense limit)**
5. **MLAs with lowest Election Expenses:** **Pema Khandu of INC** from Mukto constituency has declared election expenditure of **Rs. 12,574,** followed by **Lombo Tayeng of INC** from Mebo Constituency with election expenses of **Rs. 20,000** and **Mama Natung of INC** from Seppa West Constituency with election expenses of **Rs. 36,182.**
6. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** Out of the 60 MLAs analyzed, **51(85%) MLAs** have declared that **they have not spent ANY amount on public meetings, processions etc with Star Campaigners.**
7. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** Out of the 60 MLAs analyzed, **10 (17%) MLAs** have declared that **they have not spent ANY amount on public meetings, processions etc other than the ones with star campaigners.**
8. **Expense on Campaigning through electronic/print media:** **52 (87%) MLAs** have declared that they have **not spent ANY amount on campaigning through electronic/print media.**
9. **Expense on Campaign Workers:** **31 (52%) MLAs** have declared that they **have not spent ANY amount on campaign workers.**
10. **Expense on Vehicles used:** **2 (3%) MLAs** have declared that they **have not spent ANY amount on Vehicles Used.**
11. **Expense on Campaign Materials.:** **26 (43%) MLAs** have declared that they **have not spent ANY amount on Campaign Materials**

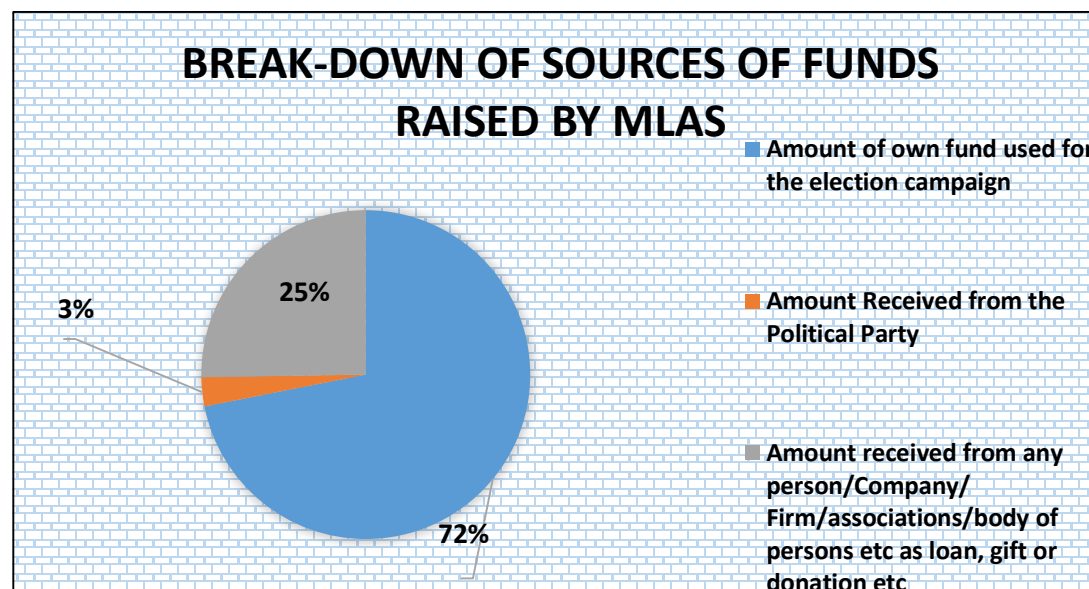

18. **Funds Raised from Political Party:** Out of the 60 MLAs analyzed, 57(95%) MLAs have declared that they have not received any funds from political parties.

19. **Funds Raised through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:** Out of the 60 MLAs analyzed, 40(67%) MLAs have declared that they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.

20. **Self funds used for election campaign:** Out of the 60 MLAs analyzed, 6 (10%) MLAs have declared that they have not used any of their own funds for their election campaign

21. **Average funds raised from Political Parties (Party-wise):** On an average a MLA from INC raised 1% of his/her election expense funds from the political party. Similarly, a MLA from BJP raised 12% of their election expense funds from the political party.

22. **Average funds raised through any person/company/firm/associations/body of persons etc as loan, gift or donation etc (Party-wise):** On an average a MLA from INC raised 26% of his/her election expense funds from any person/company/firm/associations/body of persons etc as loan, gift or donation. Similarly, a MLA from BJP and PPA raised 24% and 27% of his/her election expense funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation respectively.

Similarly, a MLA from BJP and PPA raised 62% AND 72% of his/her election expense funds from their own funds.

## Summary and Highlights of Election Expenses of Ministers from the 2014 Assembly Elections

- 1. Less than 50% of the Limit:** 6 Ministers (67%) have declared election expenses of less than 50% of the expense limit in their constituency.
- 2. Average Election Expenses:** The average amount of money spent by 9 ministers in the elections is only about Rs 7.18 lakhs, which is 36% of the expense limit.
- 3. Top 3 Ministers with highest Election Expenses:** The maximum expense of about Rs 19.64 Lakhs (98% of the expense limit) has been declared by Gojen Gadi from Basar constituency, followed by Kumar Waii from Bameng constituency with an expense of Rs 17.39 lakhs (or 87% of the expense limit) and Kamlung Mosang from Miao constituency with an expense of Rs 10.83 Lakhs (or 54% of the expense limit)
- 4. Ministers with lowest Election Expenses:** Pema Khandu from Mukto Constituency has declared an election expenditure of Rs. 12,574 (1% of the expense limit). He is followed by Takom Pario from Palin constituency who has declared election expenditure of Rs. 87,177 (4% of the expense limit) and Nabam Tuki from Sagalee Constituency, with election expenses of Rs. 2.08 lakhs (10% of the expense limit).

5. **Expense on Public Meeting, Rally, and Processions with Star Campaigners:** All 9 Ministers analyzed have declared that **they have not spent ANY amount on** public meetings, processions etc with Star Campaigners.
6. **Expense on Public Meetings, Rally, and Processions other than the ones with Star Campaigners:** 3 (33%) Ministers have declared that **they have not spent ANY amount on** public meetings, processions etc other than the ones with star campaigners.
7. **Expense on Campaigning through electronic/print media:** All 9 Ministers analysed have declared that they have **not spent ANY amount** on campaigning through electronic/print media.
8. **Expense on Campaign Workers:** 4 (44%) Ministers have declared that they **have not spent ANY amount on** campaign workers.
9. **Expense on Vehicles used:** One minister (Pema Khandu) has declared zero expenses on **Vehicles Used**.
10. **Expense on Campaign Materials:** 6 (67%) Ministers have declared that they **have not spent ANY amount on** Campaign Materials.
11. **Funds Raised from Political Party:** All 9 Ministers analyzed, have declared that **they have not received any funds from** political parties.
12. **Funds Raised through any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc:** Out of the 9 Ministers analyzed, 6 (67%) Ministers have declared that **they have not received any funds from any person/ company/ firm/ associations/ body of persons etc as loan, gift or donation etc.**
