Executive Summary – Phase 3

Criminal Background

- **Candidates with Criminal Cases:** Out of the 74 candidates analysed, **8 candidates (11%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 74 candidates, **7 candidates (9%)** have declared serious criminal cases relating to **murder, Kidnapping etc.**
- **Party-wise candidates with criminal cases:** AIUDF had **2 (40%)** out of 5, SP had **1 (25%)** out of 4, BJP had **1 (20%)** out of 5 and **4 (14%)** out of 29 Independent candidates have declared criminal cases against themselves.
- **Party-wise candidates with serious criminal cases:** AIUDF had **2 (40%)** out of 5 candidates, SP had **1 (25%)** out of 4 candidates and **4 (14%)** out of 29 candidates have declared serious criminal cases.
- **Candidates with charges of murder/dacoity/kidnapping:** Naba Kumar Sarania, Independent candidate from Kokrajhar, has 2 charges related to **murder (IPC Section-302)**, 2 charges of **kidnapping or abducting in order to murder (IPC Section-364)**, 1 charge related to **kidnapping for ransom, etc. (IPC Section-364A)**, and 1 charge related to **dacoity with murder (IPC Section-396)**. Benedict Alok Areng, independent candidate from Gauhati has declared a charge of **murder (IPC Section-302)** against himself.
- **Red Alert Constituencies:** There is one red alert constituency i.e. Guwahati where 3 independent candidates contesting have criminal cases pending against them.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

(A red alert constituency is one where there are 3 or more candidates with criminal cases pending against them)

Financial Background

- **Crorepati Candidates:** Out of the **74** candidates, **22 (30%)** are crorepatis.
- **Party-wise Crorepati Candidates:** All **5** candidates of **INC**, all **5** candidates of **BJP**, **3 (60%)** out of 5 from **AIUDF**, **3 (50%)** out of 6 from **AITC**, **1(20%)** out of 5 from **AGP** and **1 (33%)** out of 3 from **AAP** are crorepatis.
- **Average Assets:** The average assets per candidate contesting from Assam – Phase 3 in Lok Sabha 2014 elections is **Rs. 2.71 crores**.
- **Party-wise Average Assets:** Among major parties, the average asset of **5 INC** candidates is **Rs 3.08 crores**, **5 BJP** candidates have an average assets of **Rs 1.65 crores**, **5 AGP** candidates have **Rs 81.25 lakhs**, **6 AITC** candidates have **Rs. 6.27 crores**, **5 AIUDF** candidates have **Rs 22.42 crores** and **3 AAP** candidates have declared an average asset of **Rs. 78.60 lakhs**.
- **High Asset Candidates:** **7** candidates have declared total assets worth more than 3 crores. The top three candidates with highest assets are given below. Total assets include assets of self, spouse and dependents.

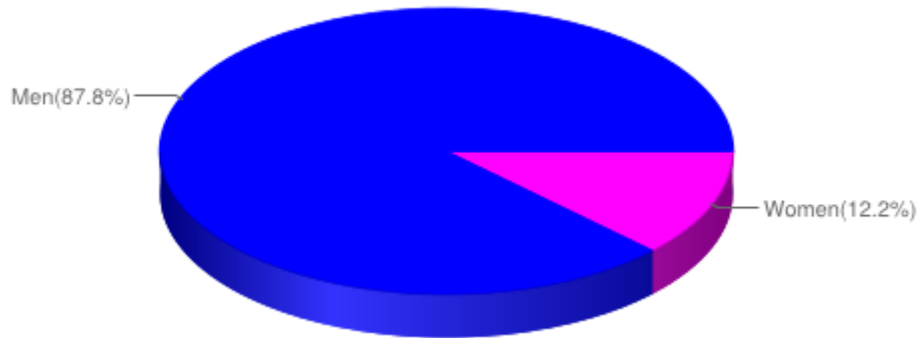

Executive Summary – Phase 1 to 3

In total, affidavits of all 162 candidates who contested the Lok Sabha elections from Assam (Phase 1 to 3) have been analyzed. The overall highlights are also below.

- **Total candidates analyzed:** 162 candidates
- **Candidates with declared Criminal Cases so far:** 14 (9%) candidates
- **Candidates with declared Serious Criminal Cases:** 11 (7%) candidates
