

Summary and Highlights

Jammu and Kashmir Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **138 candidates from 16 constituencies** who are contesting in the third phase of Jammu and Kashmir 2014 Elections.



Criminal Background

- **Candidates with Criminal Cases:** Out of the 138 candidates, **9 (7%) candidates** have declared criminal cases against themselves.
 - **Candidates with Serious Criminal Cases:** **6 (4%)** candidates have declared serious criminal cases including cases related to **robbery, attempt to murder etc.**
 - **Party wise Candidates with Criminal Cases:** **1** out of 15 candidates from **INC**, **2** out of 16 candidates from **JKNC**, **1** out of 8 candidates from **BJP** and **3** out of 54 **Independent** candidates have declared criminal cases against themselves in their affidavits.
 - **Party wise Candidates with Serious Criminal Cases:** **1** out of 15 candidates from **INC**, **2** out of 16 candidates from **JKNC**, **1** out of 8 candidates from **BJP** and **1** out of 54 **Independent** candidates have declared serious criminal cases against themselves in their affidavits.
 - **Candidate with case related to Attempt to Murder:** Basharat Hussain Najar of **Jammu & Kashmir Democratic Party Nationalist** from Pattan constituency has declared a case of **attempt to murder (IPC Section – 307)**
 - **Candidate with case related to robbery:** Zahid Hussain of **INC** from Chrar-I- Sharief constituency has declared a case of robbery (**IPC Section – 392**).
- Criteria for serious criminal cases**

 1. Offence for which maximum punishment is of 5 years or more.
 2. If an offence is non-bailable
 3. If it is an electoral offence (for eg. IPC 171E or bribery)
 4. Offence related to loss to exchequer
 5. Offences that are assault, murder, kidnap, rape related
 6. Offences that are mentioned in Representation of the People Act (Section 8)
 7. Offences under Prevention of Corruption Act
 8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the **138** candidates, **64 (46%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **12 (75%)** out of 16 candidates in **JKNC**, **14 (88%)** out of 16 candidates in **JKPDP**, **2 (25%)** out of 8 candidates in **BJP**, **9 (60%)** out of 15 candidates in **INC** and **22 (41%)** out of 54 Independent candidates have declared assets worth more than Rs. 1 crore.

- Average Assets:** The average assets per candidate contesting in the third phase of Jammu and Kashmir elections is **Rs.2.59 crores**.
- Party-wise Average Assets:** Among major parties, the average assets per candidate for **16 JKDPD candidates** is **Rs 5.27 crores**, **16 JKNC candidates** have average assets of **Rs.4.33 crores**, **15 INC candidates** have average assets worth of **Rs.3.48 crores** and **8 BJP candidates** have average assets of **Rs. 53.82 lakhs**.

- **Candidates who have not declared Income Tax Details*:** 109 (79%) candidates out of 138 have not declared income tax details.* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details*:** 41 candidates with assets worth more than Rs. 1 crore, have not declared Income Tax details. * Some candidates may be exempted from filing Income Tax Returns

Other Background Details

- **Education Details of Candidates:** 2 candidates have declared that they are illiterate. 68 (49%) candidates have declared that have an education qualification of **12th pass or below** (not including candidates who are illiterate) while 67 (49%) candidates have declared having an educational qualification of **graduate or above**.
- **Age Details of Candidates:** 62 (45%) candidates have declared their age to be between **25 to 50 years** while 65 (47%) candidates have declared their age to be between **51 to 70 years** and 7 candidates are in the age group of **71 to 80 years**.
- **Gender Details of Candidates:** There are no female candidates contesting in the third phase of Jammu and Kashmir 2014 Assembly elections.

- **Profession Details of Candidates:** 12 candidates have declared agriculture as their main profession. 39 candidates have declared their main profession to be business. 14 candidates have declared that they have retired. 33 candidates have declared their main occupation to be politics and 15 candidates have declared that their main profession is the practice of law.


