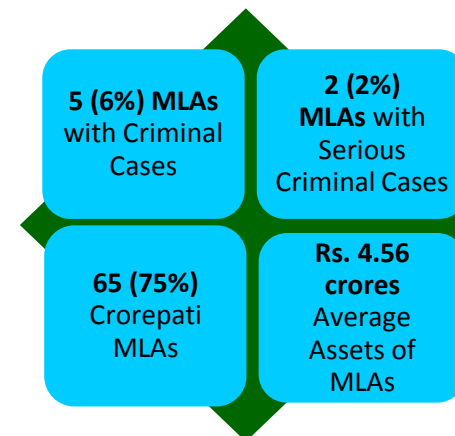

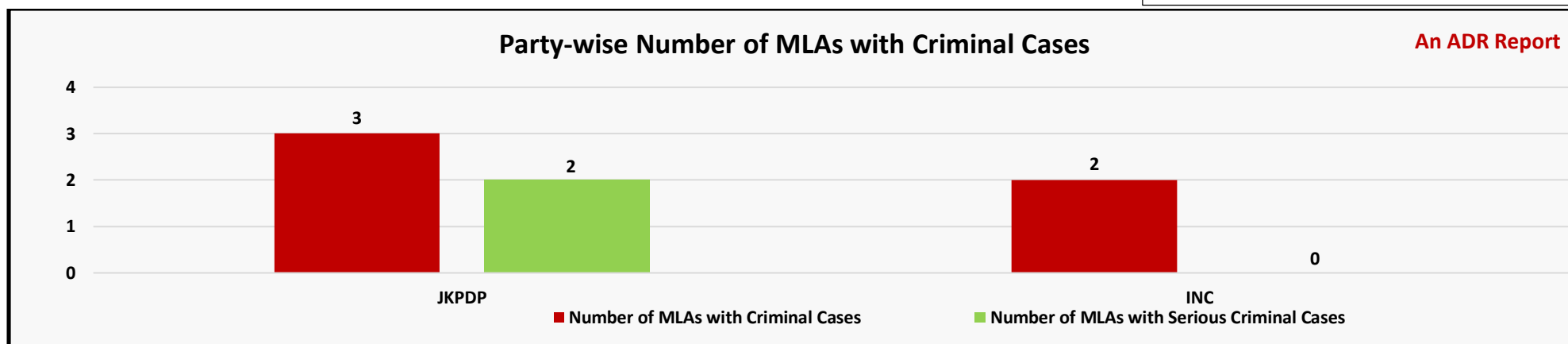

Criminal Background

- **MLAs with Criminal Cases:** Out of the **87** MLAs, **5 (6%)** MLAs have declared criminal cases against themselves.
- **MLAs with Serious Criminal Cases:** Mohammad Yousuf Bhat of JKPDP from Shopian constituency and Asiea of JKPDP from Hazratbal constituency have declared serious criminal cases in their affidavits.
- **Party wise MLAs with Criminal Cases:** **3 (11%)** out of 28 MLAs from JKPDP and **2 (17%)** out of 12 MLAs from INC have declared criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.



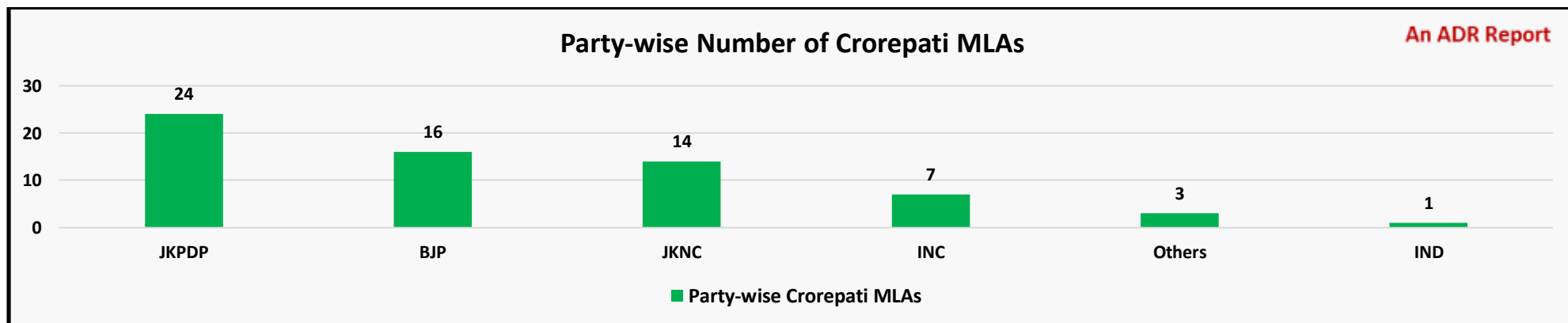

Financial Background

- **Crorepati MLAs**: Out of the **87** MLAs, **65 (75%)** are crorepatis.
- **Party-wise Crorepati MLAs**: **24 (86%)** out of 28 MLAs from JKPDP, **16 (64%)** out of 25 MLAs in BJP, **14 (93%)** out of 15 MLAs in JKNC and **7 (58%)** out of 12 INC MLAs have declared assets worth more than Rs. 1 crore.

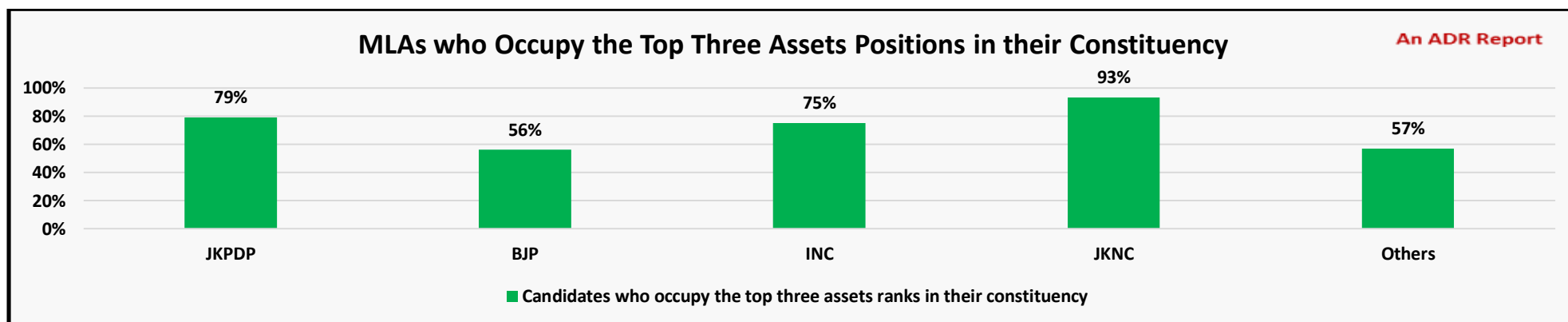
- **Chances of Winning for Crorepati Candidates:** The chances of winning for a crorepati candidate in the Jammu and Kashmir Assembly 2014 elections are 20% whereas for a candidate with low assets (<Rs. 1 crore) it is 4%.

Note:

$$\text{Chances of Winning for Crorepati Candidates} = \frac{\text{Crorepati Winners}}{\text{Crorepati Candidates}}$$

$$\text{Chances of Winning for Candidate with Low Assets} = \frac{\text{Winners with Low Assets}}{\text{Candidates with Low Assets}}$$

- **Candidates Asset Position and Chances of Winning:** 63 MLAs (72%) occupy top three highest asset positions in their respective constituency. 20 (23%) MLAs have the **highest declared assets** in their constituency. 21 (24%) MLAs have the **second highest declared assets** in their constituency and 22 (25%) MLAs have the third highest declared assets in their constituency.



- **Average Assets:** The average assets per MLA for Jammu and Kashmir 2014 Assembly Elections are **Rs. 4.56 crores**.

- **Party-wise Average Assets:** Among major parties, the average assets per winner for **28 JKPDP** MLAs is **Rs 7.78 crores**, **25 BJP** MLAs have average assets of **Rs.1.80 crores**, **15 JKNC** MLAs have average assets worth of **Rs.5.57 crores** and **12 INC** MLAs have average assets of **Rs. 1.78 crores**.

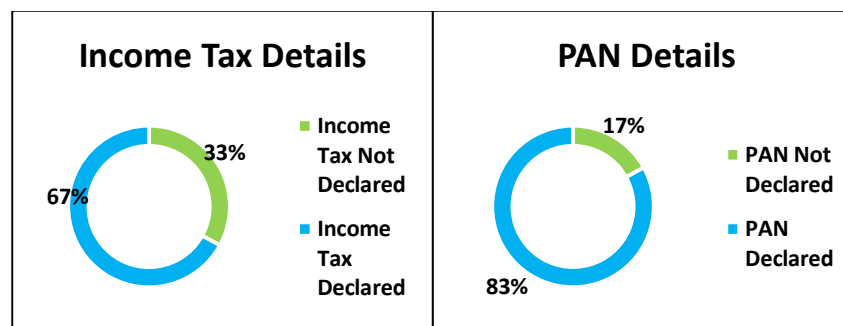

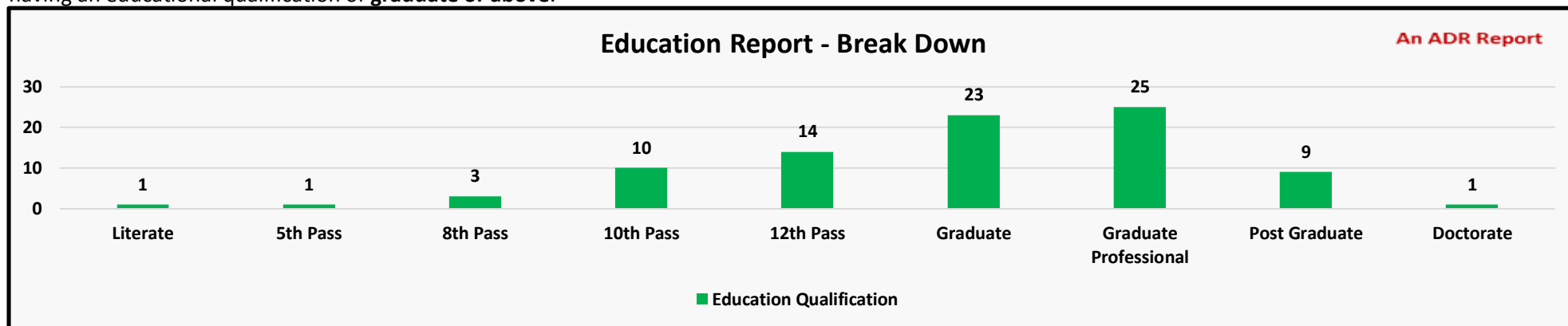

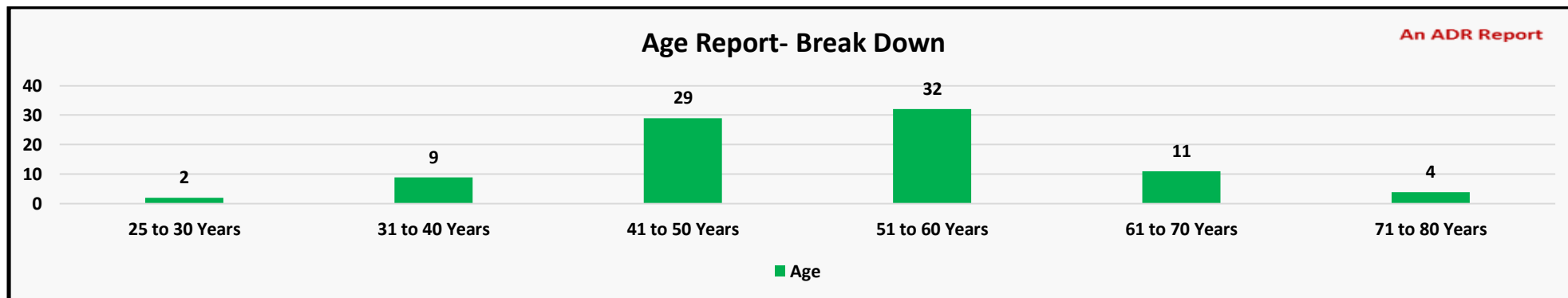


Other Background Details
