## Summary and Highlights

Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **15 out of 18 Ministers including Chief Minister** from Telangana State Assembly 2014.

### Criminal Background

- **Ministers with Criminal Cases:** 12 (80%) out of the 15 Ministers analysed have declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** Out of the 12 Ministers who have declared criminal cases, **9 have declared serious criminal cases**. These include attempt to murder, bribery, criminal intimidation etc.
- **Minister with cases related to attempt to murder:** **Thanneeru Harish Rao, Eatala Rajender and Guntakandla Jagadish Reddy** have declared cases of attempt to murder (IPC Section – 307) in their affidavits.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Crorepati Ministers:** Out of the 15 Ministers, **11 (73%)** are crorepatis.
- **Average Assets:** The average assets of 15 Ministers is **Rs 7.38 crores**.
