



## <u>Analysis of Criminal Background, Financial, Education, Gender and</u> otherdetails of newly elected winners in the Bihar MLC Elections 2015

## **Summary and Highlights**

Bihar Election Watch (BEW) and Association for Democratic Reforms (ADR)haveanalysedthe self-sworn affidavits of 24 winners from the Local Authority constituencies for the VidhanParishad Elections in Bihar in 2015.

One-third of the total MLCs are elected by members of local bodies such as Municipal Corporations, Municipalities, Gram Sabhas, Gram Panchayats, Panchayat Samitis and ZilaParishads. Among the rest of them, one-third of the total are elected by members of Legislative Assemblies of the State from among the persons who are not members of the Assembly.One-twelfth are elected by persons who are graduates of three years' standing residing in that state.Another one-twelfth are elected by persons engaged for at least three years in teaching in educational institutions within the state not lower than secondary schools, including colleges and universities and the remaining one-sixth are nominated by the Governor from persons having knowledge or practical experience in fields such as literature, science, arts, the co-operative movement and social service.

Criminal Background





- Winners with Criminal Cases: Out of the 24 winners, 16 winners (67%) have declared criminal cases against them.
- Winners with Serious Criminal Cases: Out of the 16winners who have declared criminal cases, 9 (38%) have declared serious criminal cases. These include murder, attempt to murder, robbery and dacoity etc.
- Party wise Winners with Criminal Cases: 7(64%) out of 11winners fielded by BJP have declared criminal cases against them while 4 (80%) out of 5winners from JD(U) and 3(75%) out of 4winners from RJD have declared criminal cases in their affidavits.
- Party wise Winners with serious Criminal
   <u>Cases:</u>2(18%)out of 11winners fielded by BJP have declared serious criminal cases against them while 4 (80%)out of 5winners from JD(U) and 1 (25%) out of 4winners from RJDhave declared serious criminal cases in their affidavits.

#### Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- If it is an electoral offence (IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- Offences under Prevention of Corruption Act
- 8. Crimes against women.

- <u>Party-wise Average Assets:</u> The average assets per winner for 11 BJPwinners is Rs.42.95 crores, for 5 JD(U)winnersthe average is Rs.9.79crores and for 4 RJDwinners it is Rs.4.65 crores.




