Summary and Highlights

Maharashtra Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **367 candidates** out of total **506** candidates who are contesting in the Kolhapur Municipal Corporation Elections of 2015 for 81 wards. The effort has been made to cover all affidavits of the candidates from major parties (**Congress, NCP, BJP, ShivSena, MNS, Tararani Agadhi, BSP, CPI**, etc). Due to time constraints, the rest of the candidate's affidavits were not analysed. The rest of the affidavits would be analysed subsequently and the report would be updated.

Criminal Background

- **Candidates with Criminal Cases:** Out of the **367** candidates analysed, **60 (16%)** candidates have declared criminal cases against them.
- **Candidates with Serious Criminal Cases:** Out of the 367 candidates, **32 (9%)** candidates have declared serious criminal cases including cases related to **murder, attempt to murder, kidnapping, robbery, extortion**, etc.
- **Party wise Candidates with Criminal Cases:** **15 (19%)** out of **80** candidates analysed from **INC**, **12 (16%)** out of **77** candidates analysed from **Shiv Sena**, **11 (14%)** out of **80** candidates analysed from **NCP**, **9 (24%)** out of 37 candidates analysed from **BJP**, **9 (24%)** out of 37 candidates analysed from **Tararani Agadhi**, **3 (25%)** out of **12** candidates analysed from **A Vikas Aghadi** and **1 (7%)** out of **14** candidates analysed from **RSP** have declared **criminal cases** against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **8 (10%)** out of 80 candidates analysed from **INC**, **8 (10%)** out of 77 candidates analysed from **Shiv Sena**, **6 (8%)** out of 80 candidates analysed from **NCP**, **5 (14%)** out of 37 candidates analysed from **BJP**, **3 (25%)** out of 12 candidates analysed from **A. Vikas Agadhi** and **2 (5%)** out of 37 candidates analysed analysed from **Tararani Agadhi** have declared **serious criminal cases** against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party-wise Average Assets:** Among major parties, the average assets per candidate for **80** analysed **NCP** candidates is **Rs 96 lacs**, **80** analysed **INC** candidates have average assets of **Rs. 66 lacs**, **77** analysed **Shiv Sena** candidates have average assets of **Rs. 46 lacs**, **37** analysed **BJP** candidates have average assets of **Rs. 2.51 crores**, **37** analysed **Tararani Agadhi** candidates have average assets of **Rs. 2.28 crores**, **14** analysed **RSP** candidates have average assets of **Rs.16 lacs**, **12** analysed **A. 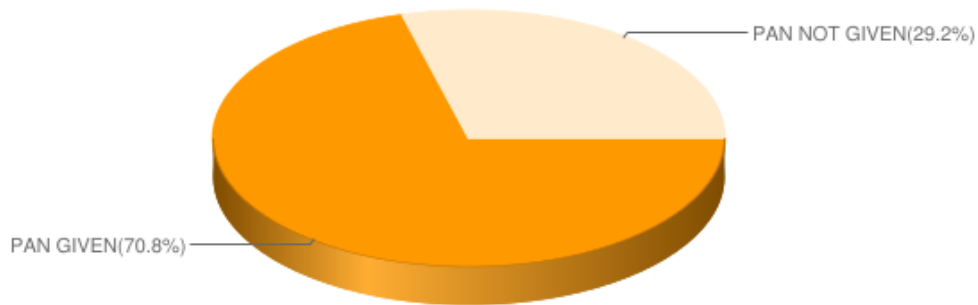

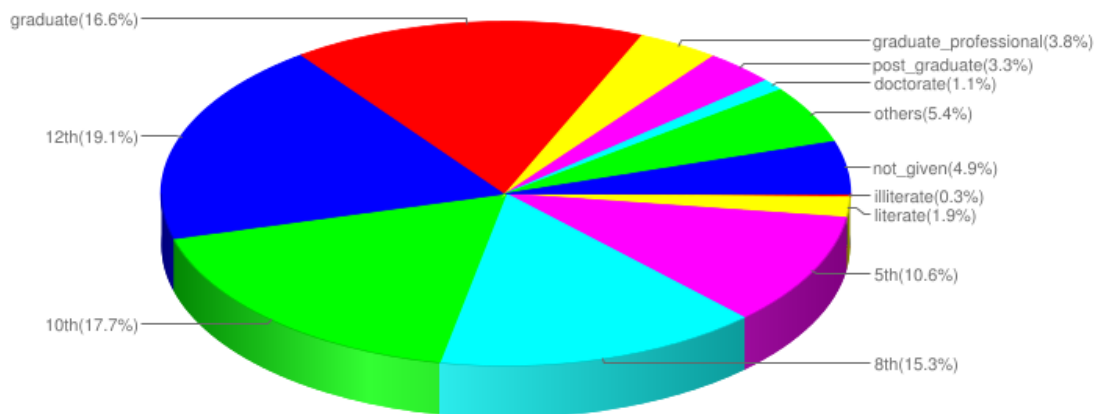

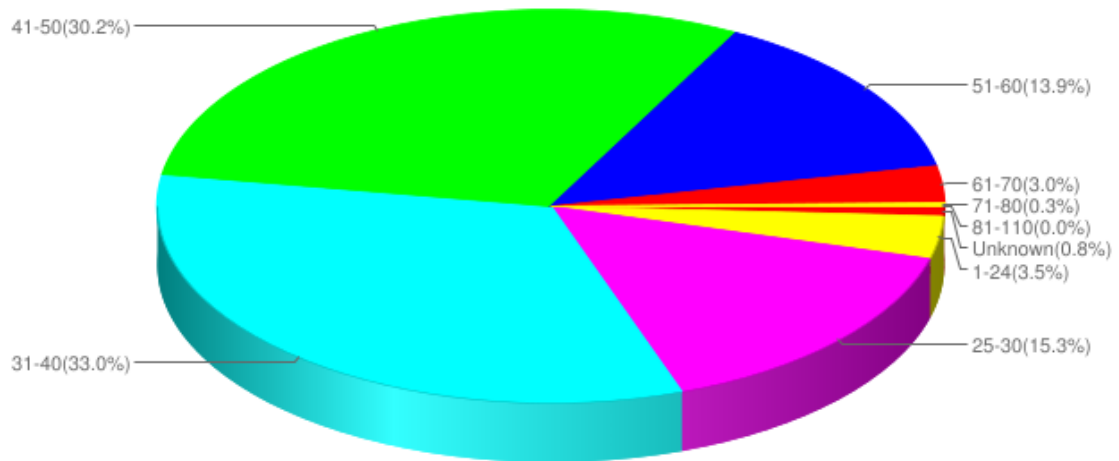

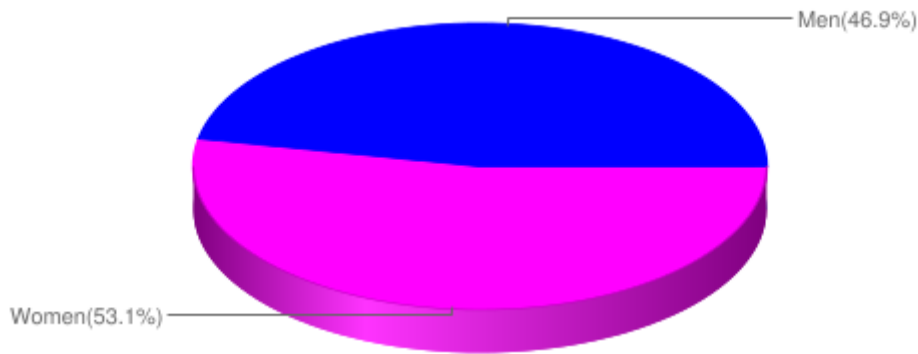
