An analysis of Sitting MPs & MLAs charged with Cases related to Communal Violence

By giving tickets to candidates who have been charged with promoting enmity between religious groups and for committing acts that are intended to outrage religious feelings, political parties have been in a way abetting circumstances that lead to events such as communal riots and violence between different groups of people.

ADR (Association for Democratic Reforms) and National Election Watch (NEW) have analysed the self-sworn affidavits of sitting MPs and MLAs. Analysis reveals that many of our current MPs and MLAs, who are designated lawmakers have actually declared cases of communal violence against themselves. For the purpose of our analysis we have considered the following sections of the Indian Penal Code:

- **Section 153A** (Promoting enmity between different groups on ground of religion, race, place of birth, residence, language, etc., and doing acts prejudicial to maintenance of harmony)
- **Section 295** (destruction, damage, or defilement of a place of worship or an object held sacred, with intent to insult the religion of a class of persons)
- Section 295A (Deliberate and malicious acts intended to outrage religious feelings)

Summary and Highlights:

A total of 51 Current MPs and MLAs have declared cases related to communal violence against themselves. The breakup of the same is given below:

- <u>Sitting MPs with Charges related to Communal Violence</u>: 19 Sitting MPs have declared Charges related to Communal Violence. Of these, 16 are Lok Sabha members and 3 are Members of the Rajya Sabha.
- Party wise distribution of MPs with Charges related to Communal Violence: 14 Sitting MPs with
 Charges related to Communal Violence are from the BJP, and 1 each is from the PMK, TDP, TRS,
 AIMIM and the AIUDF.
- <u>Sitting MLAs with Charges related to Communal Violence</u>: **32** of our current MLAs have declared Charges related to Communal Violence.
- <u>State wise distribution of MLAs with Charges related to Communal Violence</u>: **10** sitting MLAs with Charges related to Communal Violence are from **Telangana**, **4 MLAs** are from **Bihar**, **5 MLAs** are from **Uttar Pradesh**, **3** each from **Maharashtra and Karnataka**, **2** from **Tamil Nadu** and **1 MLA each** from **Punjab**, **Madhya Pradesh**, **Rajasthan and Jharkhand**.





<u>Party-wise distribution of MLAs with Charges related to Communal Violence</u>: 8 Sitting MLAs with Charges related to Communal Violence are from the BJP, 5 are from the AIMIM, 4 are from the TRS, 3 are from SP, 2 from JD(U), 2 from INC, 1 each from DMK, PMK, SHS, TDP and 3 are Independent MLAs.
