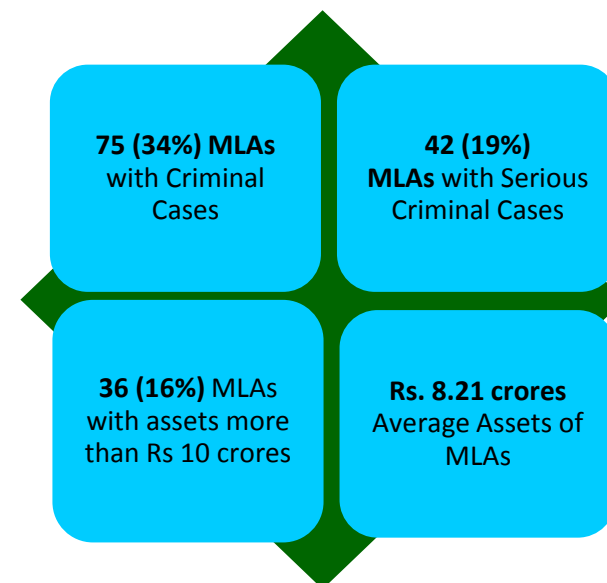

Summary and Highlights

Tamil Nadu Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of 223 out of 232 newly elected MLAs in the Tamil Nadu 2016 Assembly Elections.

It is to be noted that the results for Aravakurichi (Karur District) and Thanjavur (Thanjavur District) will be announced on 23rd May.

Criminal background

- **MLAs with criminal cases:** Out of the **223** MLAs analysed, **75 (34%)** MLAs have declared criminal cases against themselves. Out of 234 MLAs analysed during **Tamil Nadu Assembly elections in 2011**, **70 (30%)** MLAs had **declared criminal cases** against themselves.
- **MLAs with serious criminal cases:** **42 (19%)** MLAs have declared serious criminal cases including cases related to **murder, attempt to murder, kidnapping, crimes against women** etc. Out of **234** MLAs analysed during **Tamil Nadu Assembly elections in 2011**, **37 (16%)** MLAs had **declared serious criminal cases** against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

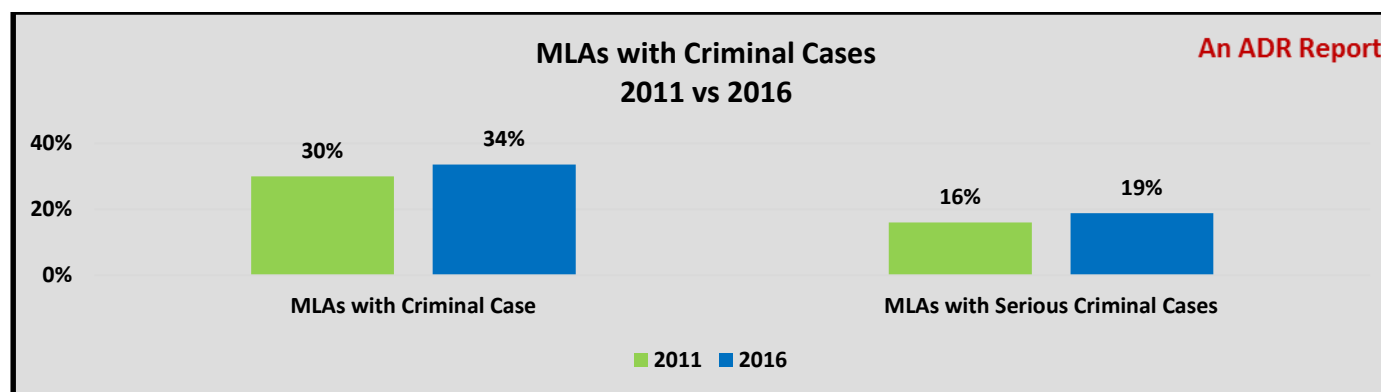


Figure: Comparison of MLAs with declared criminal cases in 2011 and 2016

- **MLAs with cases related to murder and attempt to murder:** **Samy K.P.P** of **DMK** from Thiruvottiyur Constituency of Thiruvallur district is the only MLA who has declared a case related to murder. **9** MLAs have declared cases of attempt to murder. **5** MLAs of **DMK**, **2** of **AIADMK** and **1** **MLA from INC** declared cases related to murder against themselves.
- **MLAs with cases related to crimes against women:** **Sekar Babu P.K.** of **DMK** from Harbour constituency of Chennai has declared a case related to crimes against women with **1** offence related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**.
- **Party wise MLAs with criminal cases:** **28 (22%)** out of 127 MLAs from **AIADMK**, **42 (48%)** out of 88 MLAs from **DMK**, **5 (71.4%)** out of 7 MLAs from **INC** have declared criminal cases against themselves in their affidavits.
- **Party wise MLAs with serious criminal cases:** **23 (26.14%)** out of 88 MLAs from **DMK**, **16 (12.6%)** out of 127 MLAs from **AIADMK**, **3 (42.86%)** out of 7 MLAs from **INC** have declared serious criminal cases against themselves in their affidavits.

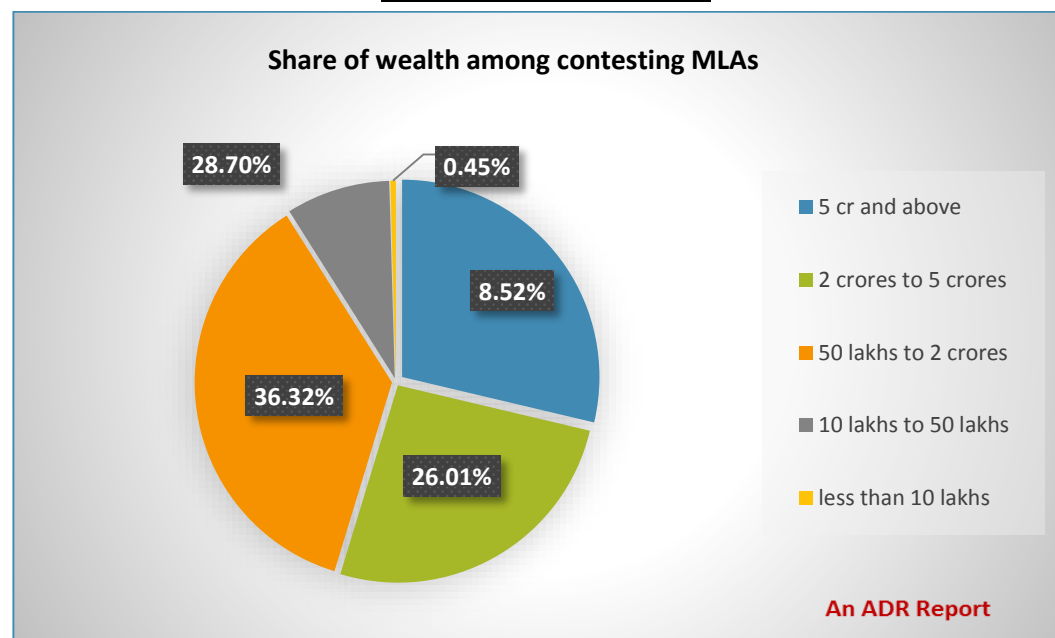


Figure: Share of wealth among MLAs

- **Corepati MLAs:** Out of the **223** newly elected MLAs, **170 (76.2%)** are corepatis. Out of **234** MLAs analysed during **Tamil Nadu 2011 assembly elections**, **120 (51%)** MLAs were corepatis.

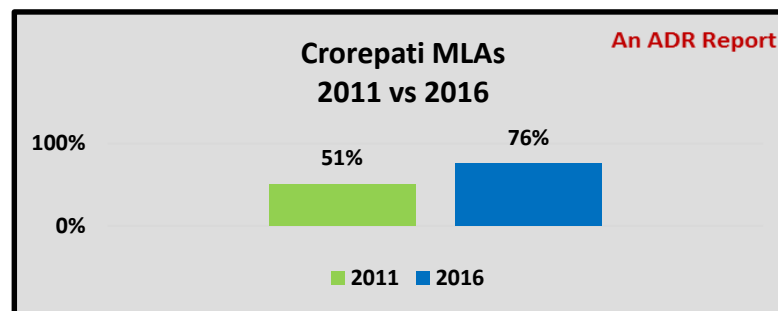


Figure: Comparison of corepati MLAs in 2011 & 2016

- **Party wise crorepati MLAs:** 90 (70.9%) out of 127 MLAs from **AIADMK**, 74 (84.1%) out of 88 MLAs from **DMK**, 5 (71.4%) out of 7 MLAs from **INC** and 1 (100%) MLA from **IUML** have declared assets valued more than **Rs 1 crore**.
- **Average assets:** The average assets per MLA who has won in the Tamil Nadu 2016 assembly elections is **Rs. 8.21 crores**. In 2011, the average assets per MLA out of 234 analyzed was **Rs 3.98 crores**.
- **Party wise average assets:** Among major parties, the average assets per MLA for **127 AIADMK** MLAs analysed is **Rs 4.54 crores**, **88 DMK** MLAs have average assets of **Rs 10.25 crores**, **7 INC** MLAs have average assets worth of **Rs. 50.18 crores** and **1** MLA has average assets of **Rs. 1.22 crores**.
- **Candidates asset position and chances of winning:** 198 (88.79%) MLAs occupy top three highest asset positions in their respective constituencies. 92 (41.3%) MLAs have the **highest declared assets** in their constituency. 58 (26%) MLAs have the **second highest declared assets** in their constituency and 48 (21.5%) MLAs have the third highest declared assets in their constituency.
- **MLAs with high liabilities:** 17 MLAs have declared liabilities of **Rs 5 crores** and above, and the details of the top 3 MLAs are as follows:

Other background details

- **Education Details of MLAs:** 90 (40.36%) MLAs have declared their education qualification to be between 5th pass and 12th pass while 127(56.95%) MLAs have declared having an educational qualification of **graduate or above**. 1 MLA has declared himself to be simple **literate** and 1 MLA has not declared the educational background information.
- **Age details of MLAs:** 82 (36.77%) MLAs have declared their age to be between 25 and 50 years while 140 (62.78%) MLAs have declared their age to be between 51 and 80 years. Only one MLA has declared his age to be in the age group between 81 and 110 years.
- **Gender details of MLAs:** Out of 223 MLAs, only 18 (8.07%) MLAs are women. Even in 2011, out of 234 MLAs, 17 (7.26%) MLAs were women.

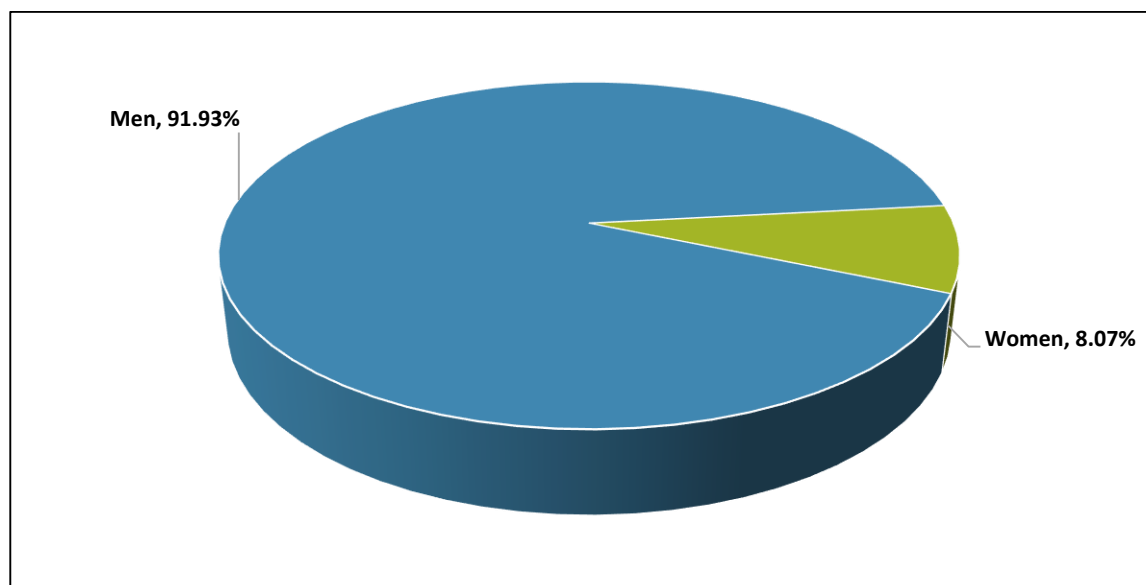
